On behalf of the citizens of Leona Valley and as a member of the Leona Valley Town Council we are requesting additional time for public comment on the above mentioned CPUC and US Forest Service Alternate Route 5 and all other alternate routes.

The Leona Valley Town Council did not receive any notification from the US Forest Service or the CPUC concerning this proposed alternate route 5 until the first week of August. It was with this notice that we also received notification that the last date for public input was September 18, 2006. I am sure that by now you have an indication of our concerns and displeasure about this Proposed Alternate Route 5. You also should know that Leona Valley does not stand alone. The communities of Acton and Agua Dulce are also very seriously impacted. It is mind boggling to imagine that the Forest Service and the CPUC would even put forth such a suggestion.
