Dear Commissioner Grueniech:

My name is Vern Denham. I am the chair of the Pine Valley Community Planning Group. On November 14, 2006 we had our monthly business meeting. We had a standing room crowd of approximately 120 residents. This is the largest number of residents at a public meeting that I have seen in the 36 years that I have lived in Pine Valley. San Diego Gas & Electric was represented by Mr. Nicolas Pince, Mr. Don Parent, and Mr. Tom Carr. Other speakers were Kelly Fuller, (Sierra Club) Bill Powers, (Border Power Plant Working Group) and Dennis Trapicante (Santa Ysabel Homeowners) The Pine Valley Community Planning Group was concerned with the environmental, financial, and historical destruction of the communities of Pine Valley and Guatay. The 200 foot wide tower footprint of the proposed alternate route "C" would totally destroy approximately 50 homes, and the community character of these rural-historic communities. After 2 hours of input the Pine Valley Community Planning Group voted 10-0-2 1 absent to oppose this project. I will enclose a draft copy of our November 14, 2006 minutes. I am enclosing my letter of October 18, 2006 that I sent to Aspen Environmental Group that you may not have seen.

My name is Vern Denham, I am the chair of the Pine Valley Community Planning Group. It has come to our attention by way of a newspaper article 2 weeks ago in the San Diego Union-Tribune that our rural community of Pine Valley California (population 1600) has been chosen as an alternative route for the San Diego Gas & Electric 500 KVA power line. According to information sent to me by a consultant for SDG&E approximately 38 homes in Pine Valley would be "TAKEN" for this project. Many of the homes in Pine Valley to be "TAKEN" are of historical significance, having been built of native rock in the 1930's and 1940's. Several more homes would be "TAKEN" from the community of Guatay which would geographically split the community in half. In our sister community of Descanso a Methodist church, a pre-school, and the historic Descanso Elementary School, plus numerous private homes will need to be "TAKEN". The Pine Valley Community Planning Group will hear this matter for the first time at our November 14 monthly meeting. I request a 45 day extension from the October 20th deadline so that we who are affected by this project will be able to comment on it.

Our community planning group, the Campo/Lake Morena Planning Group voted last night to support the Boulevard and Pine Valley Planning Groups in opposing the Sunrise Powerlink Project. We believe there has been a lack of facts surrounding this project and until we see a firm route and firm need, we cannot support it.

There are many concerns with the Sunrise Powerlink including but not limited to the following:

- Our back-country already bears the burden of the existing 500 KvSouthwest Powerlink
- Massive impacts to sensitive habitat, scenic viewsheds, wilderness areas, the national forest, state parks, rural communities, private properties and agriculture lands
- Growth inducing encourages and enables growth along route and elsewhere
- Groundwater flow impacts may result from blasting and setting extensive tower footings into fractured rock aquifers possibly affecting private wells

Since many of the alternate routes could affect our community directly, we are requesting that the CPUC hold local hearings on this project so our community members can comment.



On behalf of Castle Eurasia Corp. and Zen Media Corp., I would like to thank you, in advance, for your time and consideration of reviewing our request including my partner, Joshua Hunter for searching an alternative route that would mitigate critical, fatal and invasive impacts on 1,214 acre master planned development project along with both sides of I-8 at Dunnaway on/off ramps in Imperial County. My partner, Mr. Hunter and I also have been preparing to submit an application of Planned Community Development Plans encompassing 3,600-4200 homes surrounded by compact lakes and golf courses along with self sufficient its related infra structure, commercial, social facilitation development plans taking advantage of freeway visibility, accessibility and proximity on I-8. This project has been associated with top five public home builders. One of them was Lennar homes, California Corporation. As matter of fact and record, Ms, Kastoll of BLM met Lennar Homes staffs and consultants at her BLM office in El Centro.

For the record of public 2nd scoping meeting in El Centro, held on February, 05, 2007, Castle Eurasia Corporation/Zen Media Corporation are opposing "Proposed Project 500kV" and its Partial Alternative "FTHL" in Imperial Valley Substation Area suggesting by its president, along with its environmental consultant Susan Lamoureux of RGP in Irvine, "A Straight Line Approach" or "Short Cut Line Approach" on the basis for benefit of Cost/ Maintenance reduction in years/generations and Fairness to all people and industries including Agriculture, no special treatment to Agriculture either discriminatory to other industries and/or "Beneficiary bearing Cost/Responsibility Approach" on the basis for legitimacy principle, or those solar/wind or renewable energy companies are to end up leasing BLM lands paying Rent to BLM, therefore, BLM should bear responsibility and provide lands with SDG&E or IID. BLM owns millions of declassified lands which means nothing to do with endangered species under Yuha Desert Resources EIR/EIS, north/west side of I-8 and local main artery of Dunnaway Road under following reasons;

- Notice to public and concerned parties has not been properly given and time for implementing has been too short to follow up by general public such as Castle Eurasia/Zen Media Corporation, and it was not on January, 2007 until got informed of public notice by BLM on 2nd public scoping notice on Sunrise Powerlink Project. The general public has no way to recognize Aspen's consulting Agreement from the beginning stage, not from Utilities Companies, and/or Government Agencies, such as Simpra Energy, SDG&E, IID, BLM, and CPUC. The first letter I received from Simpra Energy was on December 16, 2006 demanding pre Eminent Domain rights. Thanks to Sierra Club and CPUC's Administrative Law Judge Weissman. It seems highly likely a prefabricated scenario to satisfy the due process required by CEQA/NEQPA.
- There seem to exist potential conflicts of interests commingled through public ii) agencies over private entities that have substantial business interest with proponent and other utility concerns. Aspen also represents for a Solar Energy Company, so called Stirling Energy Systems, Inc, a developing stage company which has already a huge solar energy selling contracts with SDG&E and which has been soliciting BLM, demanded and requested the public, land holders to sell their holdings under potential Eminent Domain threats. Aspen Environmental San Diego branch manager, Deborah called numerous times demanding to sell land, Stirling Energy, its VP, Mr. Webb, and Erica called to land owner for selling his holdings, the Proposed Master Planned Community Development in association with top five public home builders, which has already been endorsed by U.S. congressman for its constituents, Robert Finley, and my district, 44th Dist., Corona/Riverside, Ken Calvert to promote jobs, higher environments, tax basis, and Imperial County planning director, Supervisors and local business leaders have already identified this scaled and higher or same level of environment friendly community such as San Diego, Orange County, none to second level development along the freeway I-8 as The Gateway Project showing the New Image of Rising Imperial County.
- BLM has not yet performed its promises to provided landexchanges//andswap/landlease/accessgrant for the condition of acquiring this land from USDA/James Jedsen and BLM/Benjamin Koski, BLM Centro manager in 1992 at acquiring these properties. BLM has been refusing to provide general public with Yuha Desert Resources EIR/EIS. I have been demanding pertinent information about it for landexchange/landswap since 1992 under freedom of information acts.
- iv) Alternatives Screening Process page 6,7,8, and 9 of public notice clearly describes and demonstrates my requests for alternatives for numerous economic, social and environmental reasons.
- v) Castle Eurasia, Zen Media and its partners including Joshua Hunter informs CPUC/BLM of its legal counsel, Gregory N. Weiler, at Palmieri, Tyler, Weiner, Wilhelm & Waldrom LLP, 2060 Main St.,/East Tower., Suite 1300 Irvine, CA 92614-6228/ (949) 851-9400/fax/(949) 851-1554/gweiler@ptwww.com.

- vi) Castle Eurasia/Zen Media/its partner Joshua Hunter are informing CPUC/BLM of its sensitiveness of Physical, Severance, Incidental and Unforeseeable Contingency damages to This Project.
- vii) At Temecula Public Meeting, scheduled on Friday/Feb./09/07 at 1:00 to 3:00 P.M. my partner, counsel and I will submit more tangible and concrete alternatives for issued area on I-8 at Dunnaway on/off ramp in Imperial County.
