

While the Tribe has no specific information which it could provide to you for inclusion in your report on this Project, it believes that the project land falls within traditional Southern Pomo territory and, in fact, lies less than ten (10) miles away from the Tribe's historic reservation.

The Lytton Band is interested in the protection and preservation of Pomo artifacts and sites and believes that such cultural resources may be encountered during the project development. The Tribe believes that if there is any ground disturbance associated with the Project, there is a potential for inadvertent discoveries. The Tribe would therefore request special care be taken to assure the protection of any such previously undiscovered resources. In addition, if any other Pomo sites or human remains are encountered during your cultural survey, we would request that the Tribe be contacted immediately.

Once an archaeological or cultural survey is completed, the Tribe would request the opportunity to review and provide comments on the document.



Thank you for your correspondence and the Project update. Our firm represents the Lytton Rancheria of California with respect to cultural resources matters. The Lytton Rancheria is interested in the protection and preservation of Pomo artifacts and sites, and to the extent that any previously unknown sites or artifacts encountered are Pomo sites, the Band would request special care be taken to assure the protection of any such previously undiscovered resources.

PROJECT IMPACTS TO CULTURAL RESOURCES

The Lytton Rancheria's primary concerns stem from the Project's likely impacts on Native American cultural resources. The Lytton Rancheria is concerned about both the protection of unique and irreplaceable cultural resources, such as Pomo village sites, and archaeological items which would be displaced by ground-disturbing work on the Project, and on the proper and lawful treatment of cultural items, Native American human remains and sacred items likely to be discovered in the course of the work.

Further, the Tribe believes that if human remains are discovered. State law would apply and the mitigation measures and conditions of approval for the Projects must account for this. According to the California Public Resources Code. § 5097.98, if Native American human remains are discovered, the Native American Heritage commission must name a "most likely descendant," who shall be consulted as to the appropriate disposition of the remains.

While no cultural resources were encountered during a survey of the property, the Tribe believes that there is still a potential for the discovery of previously unknown subsurface

resources, and possibly additional unknown sites. As such, we would request that your recommendations include the following mitigation measures/conditions for the Project approvals:

- 1. If cultural resources are discovered during the Project construction (inadvertent discoveries), all work in the area of the find shall cease, and a qualified archaeologist and representatives of the culturally affiliated tribe shall be retained by the Project sponsor to investigate the find, and make recommendations as to treatment and mitigation of any impacts to those resources.
- 2. If human remains are encountered, all activity shall stop and the County Coroner must be notified immediately. All activity must cease until the County Coroner has determined the origin and disposition of said remains. The Coroner shall determine if the remains are prehistoric, and shall notify the State Native American Heritage Commission if applicable. Further actions shall be determined by the desires of the Most Likely Descendent.

The Lytton Rancheria appreciates the opportunity to provide comments on the cultural resources evaluations, and looks forward to working further with you to assure the protection of the resources.
