2. The estimated total cost of implementing the "Environmentally Superior Alternative" as identified in Subsection ES 11.3 of the South Bay Substation Relocation Project Draft Environmental Impact Report (SCH-2011071031).
3. Please identify all projects undertaken by SDG&E within the past five years that involved the repair, upgrade, modification, or undergrounding of subtransmission lines or other substation equipment inside or within a radius of three miles of the current site of the South Bay Substation. In addition, please identify the CPUC decision/determination that provided SDG&E with the authority to proceed with the action.
