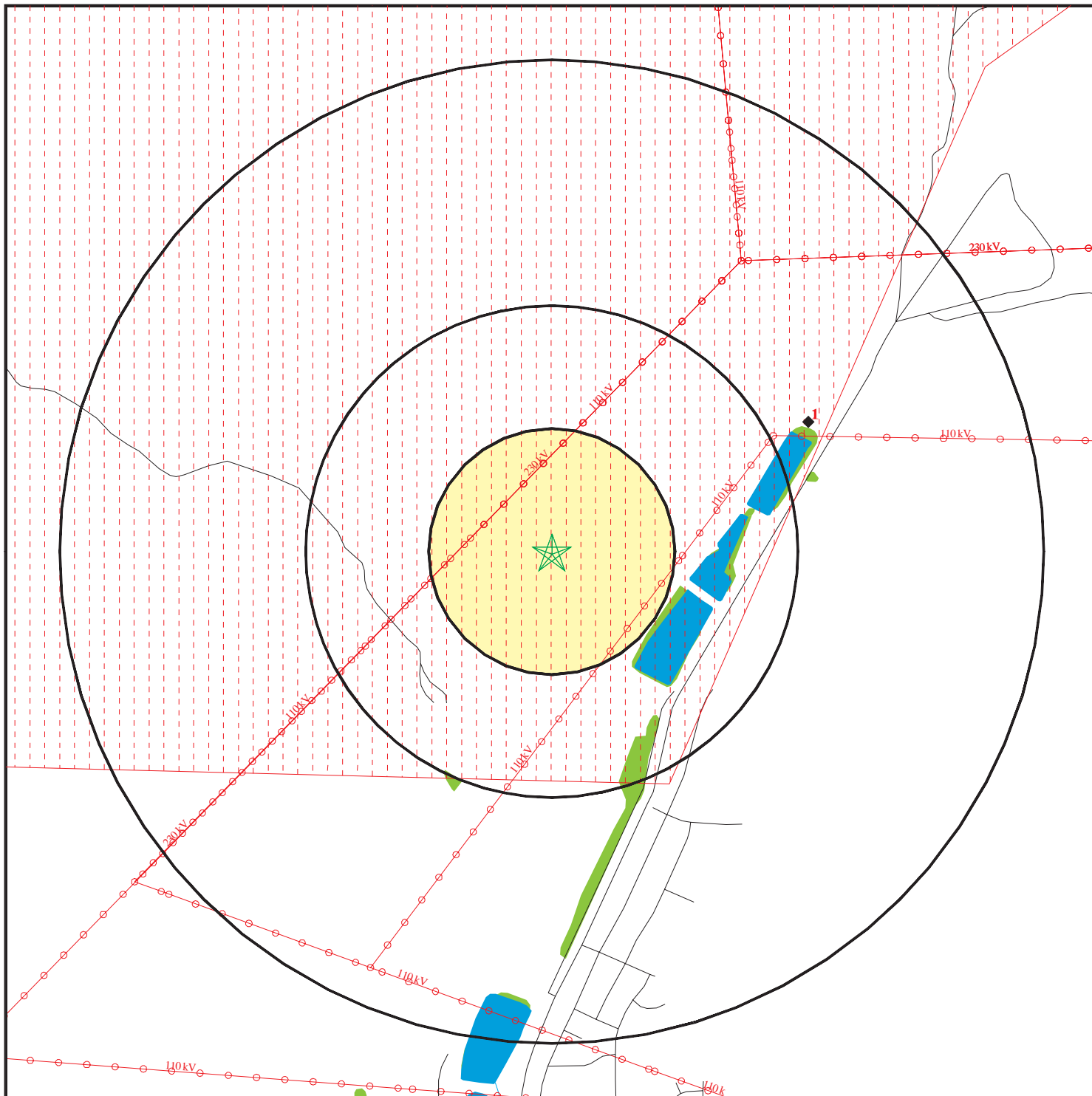

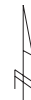

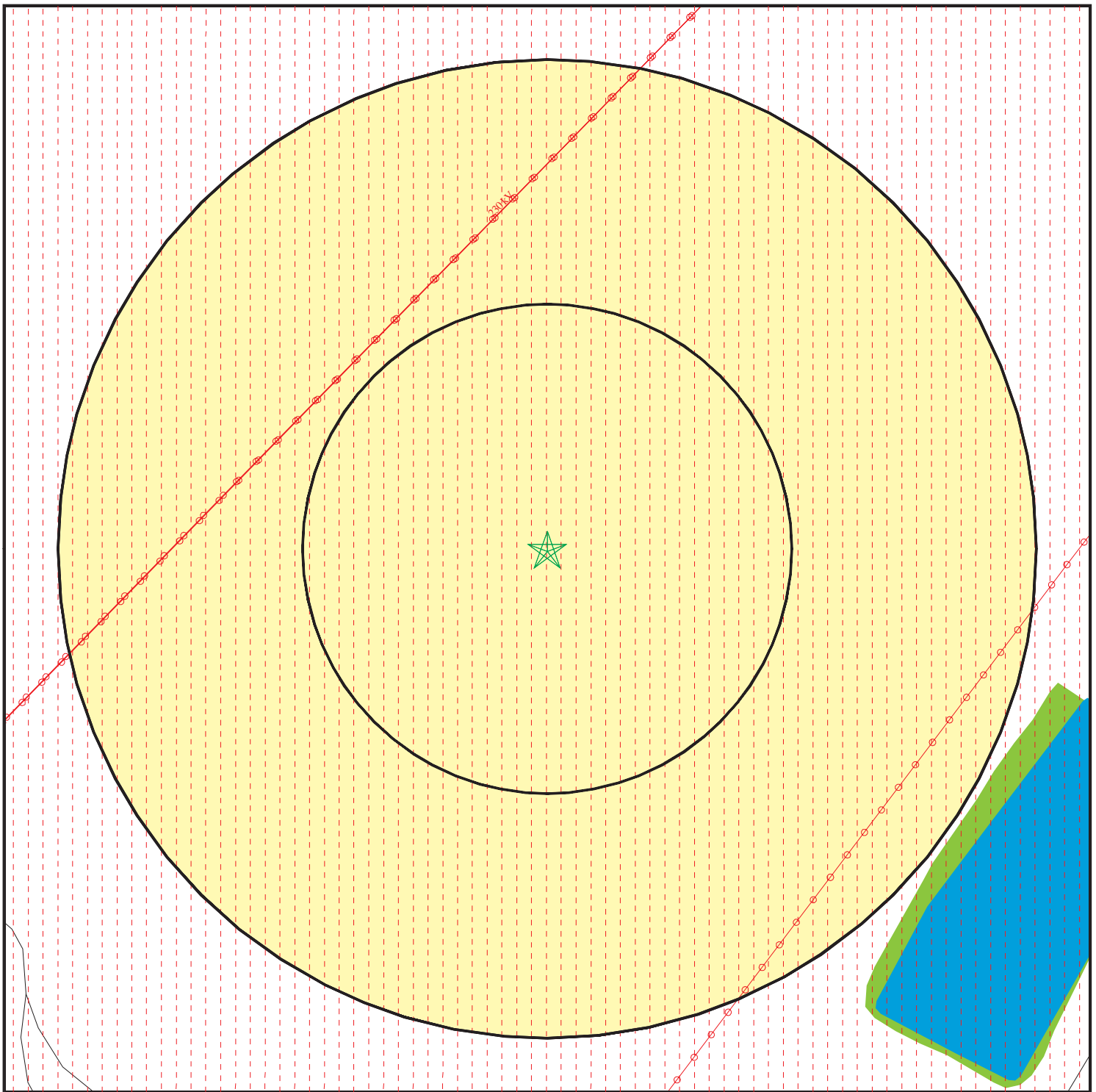

**FUDS Description Details:**

The site comprises 132.44 acres. The 132.44-acre site was acquired by a special use permit dated 7 December 1949 from the U.S. Forest Service. Since the disposal of the facility, the site has not been used by the Forest Service. In addition to the item proposed for removal, the Forest Service requested removal of various buildings, an electrical distribution system, and other miscellaneous debris. These additional items are in sound condition and are not considered unsafe. A number of the buildings are currently being used by the Federal Aviation Administration, California Institute of Technology, and others.

**FUDS History Details:**

The Air Force used the Mount Laguna Air Force Station as a radar station from 1949 to 1981. The Air Force built facilities and installed radar and other electronic equipment to support the facility. The facility was determined to be excess to the Air Force in 1981. The General Services Administration controlled this

facility until the property was transferred on 31 December 1984 to the Department of Agriculture. Custody and accountability for the site were assumed by the Department of Agriculture on 16 May 1985. 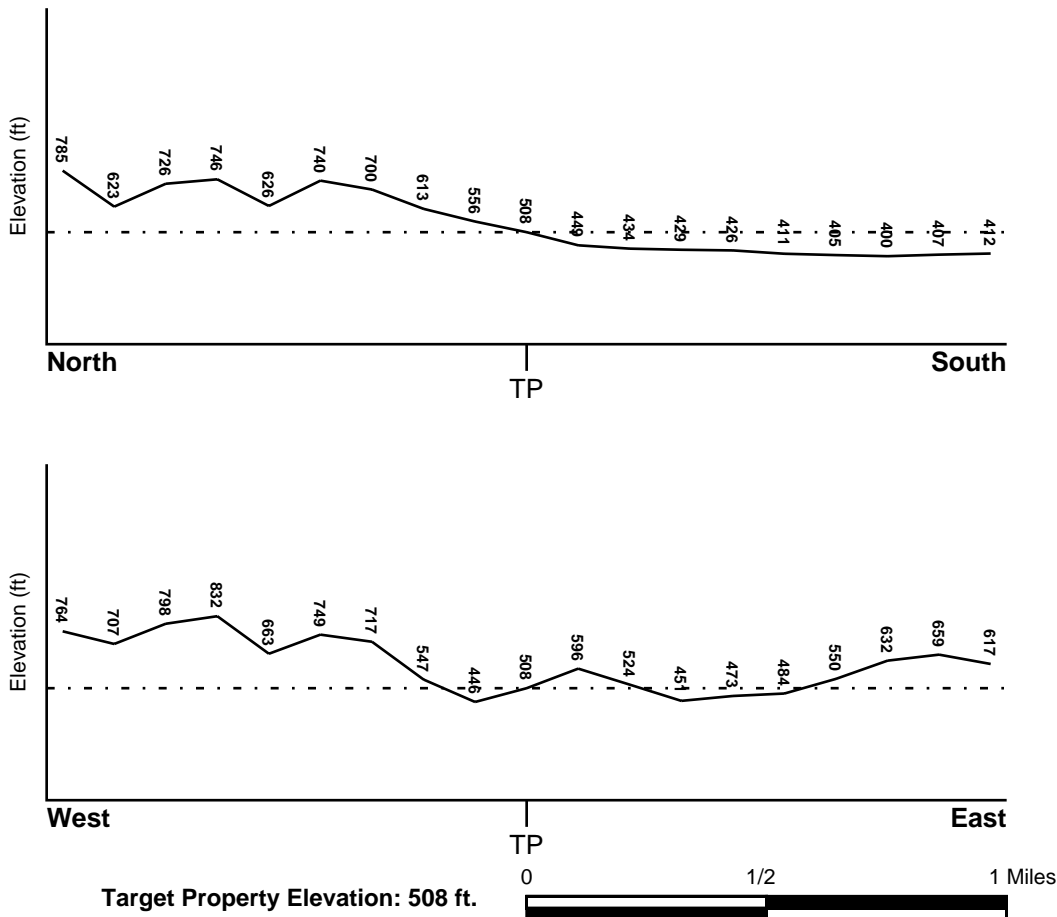

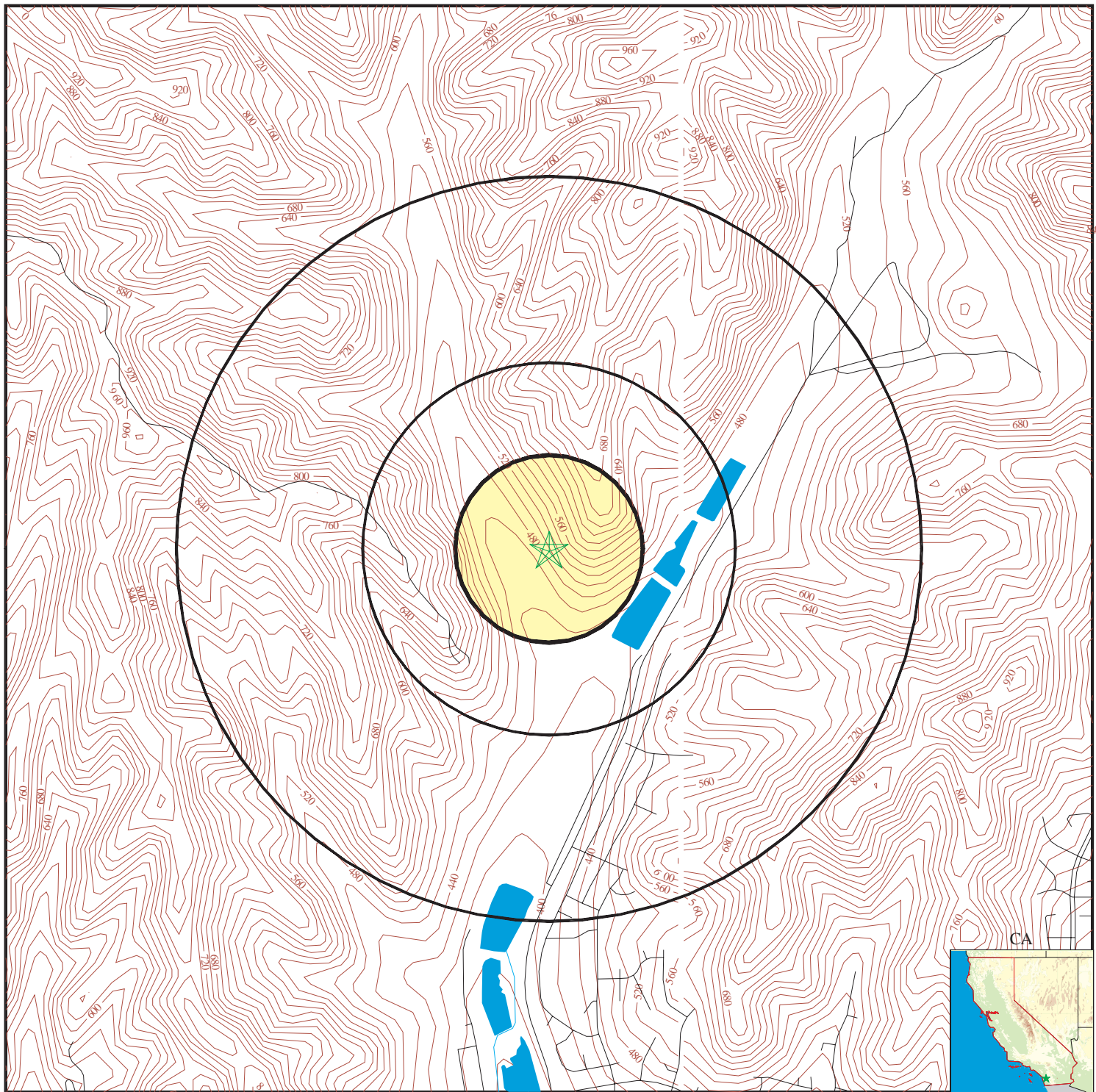
