Mr. Pinto Sr. noted an artifact count of around 116 near site CA-SDI-9036. Additionally he noted that preparations are being made to move boulders with milling features out of the direct impact areas. A few days later, Mr. Pinto reported 40 artifacts including fire affected (rocks, soil?) and possible charcoal for radiocarbon dating. He also notes that some bone was located and wasn't determined if it were human or faunal.

As a result of finding the bone in question, the surrounding area has since been established as an Environmentally Sensitive Area. Additionally, the bone has been taken to the Medical Examiner expert for formal analysis.
