# III. OBSERVATIONS

## LINK 1: Rough Acres, Jacumba, McCain Valley and Imperial Valley Substation

On May 2, D. Elliott located 6 red jasper worked stone items, removing them outside of the construction area after photo-documentation by ASM staff. On May 3 he again located stone items and bone material. Following documentation, he requested they be examined to determine whether they are human or animal. He returned to the site on May 4 for additional photography.

Mr. Mason identified one flake and one potsherd on May 4 at EP258 and two flakes at Plaster City on May 7.

On May 6, Mr. Mercado found lithic materials in the yard that extended the ESA and on May 7 he noted a quartz scatter on the road.

Ms. Najera identified one flake at EP348 on May 5 and 4 flakes and 3 pottery fragments at EP350 on May 6.

Ms. Santos notes on May 5 (EP349) and 6 (EP350), that some resources were observed outside an ESA and adjacent to an access road.

# IV. CONCERNS EXPRESSED

Mr. D. Elliott raised the question about moving items to a safe location rather than collecting them and sending them to a laboratory.

Ms. Santos noted that one access road near tower EP349 had to be moved to avoid cultural material. On May 6 she noted flakes along the ROW in an area that should have been roped off to protect the site. On May 7 she noted additional shatter debris. She also notes that some of the workers were having "racist rude conversations" and one threatened to write her up while she stood in the ESA.
