III. OBSERVATIONS

LINK 1: Rough Acres, Jacumba, McCain Valley and Imperial Valley Substation

Although she reported no cultural resources within the project area, Ms. Mack noted a scatter of materials between markers one hundred and two hundred that contained 8 flakes, 1 hammerstone, 3 cores, 2 core fragments, 1 chopper and 4 scrapers.

On May 10, Mr. Salazar resurveyed the area of Dunaway Yard and collected a few artifacts.

On May 10, Mr. D. Elliott noted 7 pieces of brownware pottery in a roped off area that will not be impacted. He left them there.

On May 10, K. Stokes, participated in the resurvey of Dunaway Yard. He noted fifteen isolates, two retouched flakes, four hammerstones and four "Debauched." All were collected. He also did a resurvey of the ESA boundary and found two flakes mere inches outside the ESA boundary.

IV. CONCERNS EXPRESSED

LINK 1: Rough Acres, Jacumba, McCain Valley and Imperial Valley Substation

Mr. Salazar noted on May 12 dense scatters of artifacts and would like to be notified when construction is scheduled at these locations and would like to be present when that construction is done.

On May 12, Mr. C. Elliott noticed another Native American monitor and an Archaeologist putting lithics into an ESA. He is concerned they were reducing a site. It is his opinion that Dunaway yard be relocated to avoid impacts.

Mr. Elliott called me immediately when he noticed these actions. I contacted Brian Williams and then the Native American monitor I had scheduled to be at that location while Brian contacted his monitor. We discussed the issue, the monitor said she felt conflicted over procedures, so we revisited the protocol. She also has written information in her possession confirming what to do in confusing situations in the future. She affirmed that she won't be moving artifacts in the future.

Mr. D. Elliott Sr. notes that very strong winds made working very difficult and recommends that all employees be provided helmet straps to avoid blowing helmets. He also notes concern for a lack of water being dispersed on dirt piles and mentions an oil rig spill which shut down that site.
