The helicopter was not in transit, but was hovering next to a tower to provide the worker access to the top of the tower for attaching aviation balls. While using a hand drill, the worker dropped it and it landed in an ESA below. The work area below this activity was clear of personnel. Mr. Thompson stated that the drill landed on top of a large rock, avoiding any impacts to nearby cultural resources. Subsequently, Mr. Thompson escorted the worker into the ESA to retrieve the drill and stated that no artifacts were disturbed.
