***Subject: Minor Project Refinement Request (MPRR) #24 — Access Road on Circuit 449 and Transmission Line 629C — Cleveland National Forest Power Line Replacement Projects (Application No. 12-10-009)***

Dear Ms. Reynolds:

On November 26, 2018, San Diego Gas & Electric (SDG&E) submitted Minor Project Refinement Request (MPRR) #24 to the California Public Utilities Commission (CPUC), to modify components of Circuit (C) 449 and Transmission Line (TL) 629C as described in the MPRR. In summary, SDG&E requested the following project refinements:

- A request to add approximately 930 feet of construction-only access road south of Poles Z100049 and Z100050 on C449 and TL629C. The requested construction-only access road will follow the Pacific Crest National Scenic Trail (PCT) for the entirety of the road's length and will be hand-brushed to approximately 12 feet wide. The new access road would replace use of the previously approved 273 feet of construction-only access road northwest of Pole Z100050.

The CPUC voted on May 26, 2016 to approve the Cleveland National Forest Power Line Replacement Projects (Decision 16-05-038) and a Notice of Determination was submitted to the State Clearinghouse (SCH#2013091070).

The Commission decision approving the Permit to Construct (PTC) authorizes Energy Division staff to approve requests by SDG&E for minor project refinements. The decision states that minor project refinements that may be necessary due to final engineering of the project may be approved so long as such minor project refinements are located within the geographic boundary of the study area of the EIR/EIS and do not, without mitigation, result in a new significant impact or a substantial increase in the severity of a previously identified significant impact based on the criteria used in the EIR/EIS; conflict with any mitigation measure or applicable law or policy; or trigger an additional permit requirement.

This letter documents the CPUC's thorough evaluation of all activities covered in MPRR #24 and that the changes requested in MPRR #24 are allowed pursuant to the Commission decision issuing the PTC. In accordance with the Mitigation Monitoring, Compliance, and Reporting Program, MPRR #24 was reviewed by CPUC to confirm that no new impacts or increase in impact severity would result from the requested activities.
