Pursuant to the California Environmental Quality Act (CEQA), the California Public Utilities Commission (CPUC) has prepared a Draft Initial Study/Mitigated Negative Declaration (Draft IS/MND) for consideration of the application (A.13-02-007) filed by Crown Castle on February 5, 2013 and subsequently amended on September 6, 2013, for Authority to Construct and Deviation from Public Utilities Code Section 320 for the San Mateo County Project (proposed project). The Draft IS/MND describes the proposed project, Applicant Proposed Measures, and evaluates potential environmental impacts associated with construction, operation and maintenance activities; identifies impacts that could be significant, and presents mitigation measures which, if adopted by the CPUC or other responsible agencies, could avoid or reduce impacts to a less than significant level.

## **Description of Proposed Project**

The proposed project would be located within an approximately 14.2-mile route along Hwy I, within a public ROW or existing utility easement, within unincorporated San Mateo County. The proposed project alignment would also traverse an existing 0.5-mile utility easement in Año Nuevo State Park.

The proposed project would consists of a total of 10 antennae, pole extenders, and associated equipment, two on each of five node poles (all existing utility poles); 14.2 miles of fiber-optic cable (12.8 miles across approximately 308 existing utility poles and 1.4 miles underground); guy wires and anchors on up to 70 existing utility poles, pending further engineering analysis and structural testing; and potentially replacing up to 14 existing utility poles to accommodate the new stress loads, pending further engineering analysis.

The objective of the proposed project is to expand wireless broadband services in rural, coastal areas of San Mateo County.

**Public Comment on the Draft IS/MND** The Draft IS/MND is available for a 30-day public comment period March 20, 2014 to April 18, 2014. The public may present comments and concerns regarding the proposed project and the adequacy of the Draft IS/MND.
