3. Draft EIR Comments and Responses

The agencies, organizations, and individuals that provided comments on the Draft EIR during the public review period, which began on June 15, 2009 and ended July 30, 2009, are documented in this chapter. A list of all commenters is provided in Section 3.1. The comments, which may have been delivered by letter, facsimile, email, or voicemail, or verbally at public meetings, and responses are presented in Section 3.2.

3.1 List of Commenters and Responses

Each comment document received or transcript of a verbal comment was assigned an identification code (e.g., A1). In this example, A1 refers to the first comment document received from a public agency. Responses to comments were assigned codes that correspond to the respective comment document or transcript (e.g., A1-1). In this example, A1-1 refers to the response to the first unique comment identified in comment document A1. Scanned versions of the original comment documents received or transcripts of verbal comments are provided in Section 3.2 and coded as shown in Table 3-1.
