12	for the Mesa 500 kV Substation Project (A.15-03-003)
13	Dear Ms. Orsaba:
14	Thank you for the opportunity to comment on the above-referenced Draft Environmental Impact

Report (DEIR) circulated by the California Public Utilities Commission (CPUC) on April 29,
2016. On behalf of Southern California Edison (SCE), the proponent of the Mesa Substation
Project (Proposed Project) that is the subject of the DEIR, this comment letter and the attached

18 table address issues that apply to the entire DEIR, with a primary focus on the analysis of

19 alternatives. In light of the information provided in this letter, SCE requests that the CPUC

20 prepare a Final EIR that dismisses the One-Transformer, Two-Transformer, and Gas-Insulated

21 Substation Alternatives from consideration because all three fail to meet basic CPUC and SCE

22 Project Objectives, none substantially reduce environmental impacts as compared to the

23 Proposed Project (and are thus not environmentally superior), and the One-Transformer

24 Alternative is not technically feasible.

# 25 I. OVERVIEW OF SCE'S COMMENTS ON THE DEIR

26 The DEIR concludes that the One-Transformer (1600 MVA) Substation, Two-Transformer

27 (1120 MVA) Substation, and Gas-Insulated Substation Alternatives, which were developed at

28 the CPUC's direction, are environmentally superior to SCE's proposed project. These

29 alternatives deviate from the very purpose of the Proposed Project. As noted in the DEIR, "[b]y

- 30 December 31, 2020 it is expected that approximately 4250 megawatts of electric generation in
- the Western Los Angeles Basin will be retired to comply with the State Water Resources Control
   Board Once-Through Cooling (OTC) policy, which aims to eliminate as much as possible coastal

2	or estuarine water usage for cooling." <sup>1</sup> The DEIR goes on to state that "a substantial number
3	of OTC units are slated to be retired" and that "OTC generation shutdown would stress the
4	existing transmission system and impact its ability to provide reliable electric service beginning
5	January 1, 2021 (CAISO 2014) under peak load conditions." <sup>2</sup> However, all three alternatives
6	considered in the DEIR would result in a delay in meeting the OTC requirement date and should
7	be dismissed because they fail to meet basic project objectives as stated by both the CPUC and
8	SCE, not the least of which would be failure to achieve an operating date that coincides with the
9	December 2020 OTC retirement date. Each of these alternatives would require significant
10	redesign of the Mesa project. This redesign will cause significant schedule delay to the operating
11	date. Further, contrary to the conclusion in the DEIR, <i>none</i> of the three alternatives are
12	environmentally superior to the Proposed Project (and none substantially reduce significant
13	environmental effects), due largely to the fact that all three alternatives fail to account for
14	additional air quality impacts and traffic impacts related to supplementary soil import that would
15	be needed if any reduced footprint option were chosen. In addition, the DEIR's environmental
16	analysis is flawed on the basis that remaining comparisons mistakenly conclude substantial
17	reductions in already less-than-significant impacts or the alternatives' impacts are found to be
18	only "negligibly" or "slightly" better than the Proposed Project and not "substantially" as
19	required by CEQA. Further, the One-Transformer Alternative is technically infeasible and
20	should be dismissed from consideration on that fact alone.
21	
22	First, the One-Transformer Alternative is technically infeasible due to the combination of the
23	following reasons:
24 25	• It is not typical equipment used in SCE's service territory or neighboring utilities' service territories.
26	• The non-standard, single-phase 533MVA transformers making up the 1600MVA bank.

	• Due to the custom nature and long lead time the single-phase 533MVA transformers are
35 36	not readily replaceable, and, as such, increase security risk due to lag time in replacement, particularly if multiple replacements were needed in the case of a natural

2 back-up to be stored on site, which would increase the transformer bank area beyond 3 what would be required for just three transformers. 4 • For security reasons and to mitigate the long lead time, SCE would also need to procure 5 three additional spares to be stored in a different location, for rapid restoration of multiple unit loss. Therefore, a total of 4 additional transformers would be required (1 to be stored 6 7 on-site and 3 to be stored off-site). 8 • Electrical power flows would be negatively affected by the single transformer 9 configuration versus a multiple transformer configuration, jeopardizing reliable 10 operation. 11 12 **Second**, the DEIR's analysis of alternatives incorrectly concludes that the One-Transformer D1-6 13 Bank (1600 MVA) Substation, the Two -Transformer Bank (1120 MVA) Substation, and the 14 Gas Insulated (GIS) Substation would achieve most of the basic project objectives. This is 15 incorrect. As explained in detail below, all three alternatives fail to meet basic CPUC and SCE 16 project objectives regarding the OTC policy date of December 31, 2020 and the One-17 Transformer and Two-Transformer alternatives also fail to meet project objectives regarding 18 NERC/WECC requirements and reliability concerns. 19 Third, the DEIR's comparison of the Proposed Project's potential environmental impacts and D1-7 the alternatives' environmental impacts is flawed. The DEIR analysis overlooks additional soil 20 21 import needs and air quality and traffic impacts that would result from a reduction in on-site 22 grading due to the reduction of the substation footprint under all three alternatives. All three 23 alternatives fail to account for additional air quality impacts and traffic impacts related to 24 supplementary soil import that would be needed if any reduced footprint option were chosen. 25 Further, any other reduction of other impacts would be, per the DEIR, "negligible" or "slight." 26 Fourth, the DEIR contains certain mitigation measures that should be deleted because they are D1-8 27 infeasible or inapplicable. D1-9 28 For these reasons, the Final EIR should dismiss the One-Transformer, Two-Transformer, and 29 Gas-Insulated Substation Alternatives from consideration because all three fail to meet basic 30 CPUC and SCE Project Objectives, none substantially reduce significant environmental effects 31 as compared to the Proposed Project (and are thus not environmentally superior), and the One-32 Transformer Alternative is not technically feasible. The Final EIR should also delete infeasible 33 or inapplicable mitigation measures.

For a single transformer unit failure, SCE would need to procure an extra transformer as a

# II. LEGAL STANDARDS GOVERNING THE ANALYSIS OF ALTERNATIVES IN A DEIR

- 36 As noted in the DEIR, the California Environmental Quality Act (Pub. Resources Code § 21000
- 37 et seq., CEQA) and its implementing Guidelines (14 CCR § 15000 et seq.) require that an EIR
- 38 describe "a reasonable range of alternatives to the project, or to the location of the project, which

1

would feasibly attain most of the basic objectives of the project but would avoid or substantially
lessen any of the significant effects of the project..." (14 CCR § 15126.6(a); DEIR, at p. 3-2.)

3 CEQA does not establish a stringent limitation on the factors which a lead agency may consider

4 when determining whether an alternative is feasible. Rather, CEQA provides that such a

5 decision may rest on "economic, legal, social, technological, or other considerations." (Pub.

6 Resources Code § 21081(a)(3).) Similarly, the CEQA Guidelines define "feasible" as: "capable

7 of being accomplished in a successful manner within a reasonable period of time, taking into

8 account economic, environmental, legal, social, and technological factors." (Pub. Resources

9 Code § 21061.1; 14 CCR § 15364.)

# 10 III. THE DEIR'S ANALYSIS OF THE ONE-TRANSFORMER (1600 MVA) 11 SUBSTATION ALTERNATIVE IS FLAWED

12 The One-Transformer Alternative should be dismissed from consideration because it is not

13 technically feasible, does not meet basic CPUC or SCE Project Objectives for several reasons,

14 and is not environmentally superior to the Proposed Project.

A. The One-Transformer (1600 MVA) Substation Alternative Is Not Technically
 Feasible.

The One-Transformer Alternative does not comply with SCE's Project Objective 7, submitted in
the Proponent's Environmental Assessment (PEA) but omitted in the DEIR, to design and

19 construct the Proposed Project in accordance with SCE's approved engineering, design and

20 construction standards. SCE's objective was not incorporated into the DEIR CPUC objectives

21 "...because it does not speak to the underlying purpose of the project."<sup>3</sup> To the contrary, utilizing

22 SCE standards will enable the project to facilitate compliance with OTC requirements and meet

23 project objectives on time with the least environmental impact. SCE standards are developed

- based on experience to ensure SCE constructs safe, reliable, and operable facilities on a
- 25 consistent basis. The use of standard-sized equipment also allows for long-term efficiencies to be
- 26 gained in foundation design, maintenance procedures, and the ability for spare equipment to be

27 utilized at many different locations, including sharing of equipment between utilities in

28 emergency situations, as evidenced by the large participation rates in the Spare Transformer

29 Equipment Program (STEP) that is managed by the Edison Electric Institute (EEI).

30 SCE does not currently have a standard design for a 1600 MVA transformer bank, nor is SCE

31 aware that such equipment is utilized in California or nationally as standard equipment. The

32 One-Transformer Alternative proposed by the CPUC would consist of three 533 MVA single-

- 33 phase transformers.
- 34 The three 1120 MVA transformer banks specified in the Proposed Project would each consist of

35 three 373 MVA single-phase transformers per transformer bank. By comparison, each

1 transformer in the One-Transformer Alternative would be approximately 40% larger in volume

- 2 than the Proposed Project's transformer bank and would result in higher current flow towards the
- 3 220 kV switchrack. The calculated current flow on the 220 kV side of a 1600 MVA transformer
- 4 bank exceeds 4000 Amps, which would require installation of 5000 Amp circuit breakers and
- 5 disconnect switches. If studies show that the short circuit duty on the 220 kV switchrack exceeds
- 6 63 kA, which is likely given the 220 kV lines would be on a common bus, then 80 kA circuit
- 7 breakers would be needed, which are not industry-standard size. Even if 220 kV 5000 Amp
- 8 circuit breakers and disconnect switches could be procured, it is reasonable to expect that the
- 9 schedule to obtain that equipment would be significantly longer than what would be necessary to
- 10 specify, procure, and receive the standard 4000 Amp equipment that is required for the Proposed
- 11 Project. These schedule impacts could result in impacts to the overall project in-service date.
- 12 Inclusion of non-standard equipment, such as the 533 MVA transformer banks and 5000 Amp
- 13 circuit breakers, also creates operations and maintenance concerns as this equipment would be
- 14 the only such units on the SCE system. Therefore, in addition to the aforementioned technical
- 15 issues, SCE would likely need to procure more than one spare 533 MVA single-phase
- 16 transformer due to the long procurement lead time and the unavailability of system spares for
- 17 this unique transformer size. Spare circuit breakers and disconnects may also be purchased for
- 18 similar reasons. Some of this spare equipment would need to be stored on-site at Mesa
- 19 Substation and off-site for location diversity, to facilitate rapid restoration. Consequently,
- 20 additional space would be required within the substation that was not apparently considered in
- 21 the rough schematic of this alternative as shown in Figure 3.4-1.<sup>4</sup>
- 22 The larger physical size of the alternative transformer bank presents several other technical
- 23 challenges. Transporting these larger-sized 533 MVA transformer bank units to the project site
- 24 would likely require use of larger-than-normal trucks and increased lane closures as compared to
- 25 other transformer bank shipping protocols, resulting in an impact to Traffic and Transportation
- that was not identified in the Comparison of Alternatives Section 5.3.2.1. The larger transformer
- 27 bank would also necessitate changes to the standard substation layout to accommodate the
- 28 increased length, width, and height of each transformer bank, and the additional spare units
- 29 would require additional space within the transformer bank area for storage.
- 30 Implementing this alternative as suggested with only one transformer bank would also change
- 31 the number of required positions in the 220 kV switchrack, not just the 500 kV switchrack and
- 32 transformer bank areas, thereby resulting in the need to redesign the entire 220 kV switchrack. It
- is anticipated that the redesign effort needed to incorporate the One-Transformer Bank (1600
- 34 MVA) Substation Alternative would require approximately 9-12 months to modify not only the

electrical design of both the 500 kV and 220 kV switchracks, as well as the transformer bank
areas, but also the overall site grading design to match the new substation layout. Considering
that the construction of the 220 kV switchrack is one of the critical activities to be performed
during Phases 1 and 2 of the overall construction sequencing, and must be completed prior to
demolition of the existing substation in order to clear an area sufficient to build the 500 kV
switchrack, the overall schedule impacts resulting from this redesign effort would significantly

7 jeopardize the successful completion of this project by the required in-service date.

# B. The One-Transformer (1600 MVA) Substation Alternative Does Not Meet Basic CPUC Project Objectives.

10 The One-Transformer (1600 MVA) Substation Alternative does not meet CPUC Project

11 Objectives 1 or 2.

12 CPUC Project Objective 1 is to:

Address projected violations of NERC Standard TPL-001-04, WECC Regional Business
 Practice TPL-001-WECC-RBP-2, and CAISO Planning Standards that would occur upon
 retirement by December 31, 2020, of generators that use OTC.

16 The One-Transformer Alternative does not address projected violations of NERC TPL-001-4

17 under all contingencies included in Appendix B of the DEIR, "Violations of NERC WECC and

18 CAISO Standards." For contingencies 4 and 5, transmission lines in the Serrano Corridor are

19 loaded to 98%.<sup>5</sup> However, the analysis performed by ELCON in the DEIR assumed 500/220 kV

20 transformer bank impedance that is lower than the minimum impedance per SCE standards, and

21 perhaps below what is readily available from the equipment suppliers. The case SCE provided to

- 22 ELCON included a higher impedance for the transformer bank associated with the Proposed
- 23 Project, in accordance with SCE standards. Increasing the transformer bank impedance
- 24 consistent with SCE standards would divert power from the Western portion of SCE's
- 25 transmission system to the Eastern portion thereby increasing loading on the Serrano Corridor.
- 26 This increased flow under contingencies 4 and 5 would cause post-contingency loading levels
- 27 that reach or exceed the emergency rating of critical lines in the Serrano Corridor. Higher

28 transformer bank impedances or slight changes in generation dispatch would further exacerbate

29 the thermal loading resulting in violation of CPUC Objective 1.

30 SCE must ensure current flows are in compliance with NERC TPL 001-4 standards under a

31 range of load and generation patterns. Transformer bank impedance is a critical parameter that

- 32 impacts current flow on the electric system. Under the One-Transformer Alternative, a specific
- 33 transformer bank impedance was modeled by ELCON in an attempt to fine-tune these flows and
- 34 avoid overloads. With this single transformer bank, under the lower impedance value used, the
- 35 transformer bank reaches its emergency rating following a contingency. Higher impedances

cause the heavily loaded Serrano Corridor to reach its emergency rating following a contingency.
 Therefore, the One-Transformer Alternative is inadequate.

3 In addition to violating TPL-001-04, the technical challenges associated with the design, testing

4 and procurement process for a 1600 MVA transformer bank would cause significant delays to

5 the project schedule resulting in the inability to meet the December 31, 2020 OTC retirement

6 date requirements per CPUC Objective 1. The normal lead time for procuring a standard

transformer bank is approximately 24 months. Per the current project schedule, SCE would need
to order transformers banks for the Proposed Project in early 2017 in order to meet the online

9 date of December 31, 2020. Due to the non-standard nature of these transformer banks, the

10 procurement time for a 1600 MVA transformer bank is likely to be closer to 36 months.

11 Therefore, even if SCE ordered the 1600 MVA transformer in early 2017, it would not likely

12 arrive until early 2020. In addition to the long lead-time, the larger, non-standard 1600 MVA

13 transformer bank would require a redesign of the substation configuration as well as the 220 kV

14 switchrack due to nonstandard terminal equipment/breakers for 5000 Amp. This redesign would

15 add approximately 9-12 months to the project completion time, thereby likely missing the

16 December 31, 2020 online date to meet OTC retirement requirements. If, as a result of this delay,

17 generating facilities are required to maintain operation beyond the OTC compliance date, the

18 environmental impacts associated with their operation would continue until such time as the

19 Mesa Project is ultimately completed.

20 The One-Transformer Alternative also violates CPUC Project Objective 2:

21 Avoid introduction of new violations of NERC, WECC, and CAISO standards.

22 The One-Transformer Alternative would introduce additional thermal overloads outside of those

23 included in Appendix B to the DEIR and therefore violates CPUC Objective 2. SCE noted a

24 specific contingency, which was not included in Appendix B, in response to Data Request ED-

- 25 SCE-06 Question 2a:
- An N-2 of the Rio Hondo Vincent #1 & 2 230 kV transmission lines would cause a
   single transformer to be loaded to 1698 MVA<sup>6</sup>
- 28 In the case provided by  $ELCON^7$ , the transformer bank impedance was lower than that modeled

29 by SCE. In ELCON's case, under an N-2 of the Rio Hondo – Vincent #1 and 2 220 kV

30 transmission lines, the 1600 MVA transformer bank loading reaches the 1920 MVA emergency

31 rating of the transformer bank. As SCE stated in response to Data Request ED-SCE-06, different

32 dispatch scenarios would increase loading on the 1600 MVA transformer bank:

Furthermore, the case provided is one snapshot of future operating conditions. With the recent passage of Senate Bill 350, the state renewable energy target has increased from

While SCE cannot predict exactly where new renewable generation would be located, generation connecting north of Vincent Substation would further exacerbate transformer bank loading at Mesa Substation. <sup>8</sup>	D1-14 cont.

1 • Outage of the Chino – Mira Loma No. 1 220 kV transmission line followed by an outage 2 of the Chino - Mira Loma No. 2 220 kV transmission line resulting in a thermal overload 3 of the Chino - Mira Loma No. 3 220 kV transmission line 4 • Proposed RAS disables two additional 220 kV transmission lines (Barre - Lewis and 5 Barre – Villa Park) to relieve overload 6 Under the Proposed Project, two transmission lines are lost due to the contingency (Chino-Mira 7 Loma No.1 and No. 2 lines), yet continuity of service to load in the Western LA Basin via the 8 Serrano Corridor is maintained. The One-Transformer Alternative disregards future needs of the Western LA 14 Basin. 15 SCE's Objective 3 for the proposed Mesa Project was: 16 Allow greater flexibility in the siting of future generation projects to meet local reliability 17 needs in the Western Los Angeles Basin while reducing the total amount of new 18 generation required by providing additional transmission import capability. 19 In developing its basic project objectives, the CPUC eliminated SCE's above objective with limited rationale.<sup>9</sup> By solely focusing on specific contingencies rather than the overarching 20 21 system need for the project, the CPUC has minimally addressed system needs with little 22 consideration for the future. As noted in SCE's PEA: 23 The construction of the Proposed Project provides an additional point of 500 kV service into SCE's metropolitan load center delivering power from Tehachapi wind resource area 24 25 or resources located in Pacific Gas and Electric service territory or the Northwest via the 500 kV bulk transmission network.<sup>10</sup> 26 27 In contrast, the One-Transformer Alternative would represent a 50% reduction in nameplate 28 power delivery capability via Mesa Substation (one-1600 MVA transformer bank compared to 29 three-1120 MVA transformer banks). Further, the feasibility of the One-Transformer Bank 30 Alternative is predicated on reliability of gas-fired resources in the LA Basin to operate at 31 maximum capacity. As demonstrated in Appendix B, the CPUC's proposed One- Transformer

Alternative results in the post-contingency loading in the Serrano Corridor to 98% of emergency rating. As such, future changes in power flow patterns, as well as further reduction of generation

- 1 resources in the Western Los Angeles Basin, would cause these highly loaded transmission lines
- 2 to overload. One such potential system change is exemplified by the limited operations of the
- 3 Aliso Canyon Gas facility, which may result in gas shortages in the Western LA Basin. Under
- 4 this alternative, even a minor reduction in gas-fired resources would create thermal overloads.
- 5 This would require implementation of additional measures to mitigate these potential overloads,
- 6 whereas the Proposed Project provides flexibility to address future system needs.

7 Furthermore, reducing the substation footprint as suggested under the One-Transformer

- 8 Alternative would also limit future grid expansion. The substation design was based on an
- 9 ultimate configuration that would allow for additional transformer banks and 500 kV
- 10 transmission lines should they be determined necessary in the future. To limit the substation
- 11 footprint would limit the ability for these grid assets to be included in the future, hindering
- 12 system expansion for both reliability projects as well as generators seeking to connect via the
- 13 CAISO's interconnection queue. Reducing the footprint, would result in escalated costs and
- 14 increased environmental impacts to expand the site in the future. Fully expanding the site to
- 15 SCE's Proposed Substation layout is necessary regardless of the alternative selected to minimize
- 16 future environmental impacts and limit costs.
- 17 18

# D. The DEIR's Identification of the One-Transformer Alternative As the Environmentally Superior Alternative is Flawed.

The DEIR asserts that the One-Transformer Alternative is considered environmentally superior 19 in nine resource areas.<sup>11</sup> However, the One-Transformer Alternative does not substantially 20 21 reduce environmental impacts. As noted above, CEQA requires that an EIR describe "a 22 reasonable range of alternatives to the project, or to the location of the project, which would 23 feasibly attain most of the basic objectives of the project but would avoid or substantially lessen any of the significant effects of the project..."<sup>12</sup> According to the DEIR, the Proposed Project 24 has significant and unavoidable impacts in three areas: (1) aesthetics, (2) air quality, and (3) 25 26 noise. The One-Transformer Alternative does not avoid or substantially lessen these significant 27 impacts. In fact, the One-Transformer Alternative *increases* air quality impacts by adding truck 28 trips and construction time, and Air Quality is the *only* significant and unavoidable impact area that the One-Transformer Alternative was ranked first in as compared to the other alternatives.<sup>13</sup> 29 30 Further, per the analysis in the DEIR, any other "reductions" to impact in other resource areas, 31 all of which are determined to already be less-than-significant, either with or without mitigation, 32 either do not substantially lessen significant environmental effects or are largely deemed to be 33 "negligible" or "slight" or "substantially the same" as compared to the Propose Project. In short, 34 the One Transformer Alternative is not environmentally superior to the Proposed Project.

- i. The One-Transformer Alternative results in an increase to air quality impacts as compared to the Proposed Project.
- 3 According to the DEIR, the One-Transformer Alternative would result in total reduced air 4 quality impacts over the construction period because the reduced substation footprint of about 5 11.6 acres would result in a shorter construction period and less ground disturbance, presumably because it would require less grading.<sup>14</sup> Also, according to the DEIR, although daily pollutants 6 would be about the same as the Proposed Project, the reduced construction period would result in 7 8 overall substantial decrease in total exhaust emissions and substantially reduce fugitive dust emissions from ground disturbance.<sup>15</sup> This analysis is flawed because it fails to take into account 9 the fact that the One-Transformer Alternative grading requirements for the remainder of the 10 11 Mesa Substation construction area would still need additional soil imports to balance the site, 12 soil that under the Proposed Project would have come from the grading work over a portion of 13 the 11.6  $\operatorname{acres}^{16}$  (as part of Phase 3).
- 14 Therefore, reduction of the proposed substation footprint by 11.6 acres actually *lengthens* the
- construction period and *increases* the total in exhaust emissions. Per Table 2-7 of the project 15
- description,<sup>17</sup> Phase 3 grading quantities included 50,000 cubic yards (CY) of exported soil 16
- based on the SCE Proposed Project. This represents approximately 5,000 truck trips for Phase 3. 17
- 18 The topography within the 11.6 acres is significantly higher in elevation than the proposed future
- 19 grades of the new substation; this accounts for approximately 150,000 CY of cut. As calculated,
- 20 the Proposed Project would use 100,000 CY of the soil cut in this area to serve as fill on the rest
- of the project site, and export 50,000 CY (approximately 5,000 truck trips). If the Phase 3 21
- 22 grading does not take place as planned in the Proposed Project, the project site would still need approximately 100,000 CY of fill.<sup>18</sup> So, if Phase 3 did not include this grading work, then the 23
- 24 grading quantities in Table 2-7 would change from 50,000 CY of export to 100,000 CY of
- 25 import, approximately 10,000 truck trips. This would double the amount of truck trips for Phase
- 26 3 (from 5,000 export to 10,000 trips for import) required to grade the site for construction of the
- 27 One-Transformer Alternative and would therefore bring the total truck trips to 20,000 for Phases

- 3 With regards to the project duration, the conventional construction equipment that was proposed
- 4 to be used in the SCE Proposed Project (e.g., scrapers) can move the soil on site approximately
- 5 ten times faster than it can be imported using trucks. This means that the project duration would
- be extended by more than 6 months under the One-Transformer Alternative, not shortened. This
  could compromise the ability to complete the project by December of 2020.
- . Come compromise are active to complete the project by December of 2020.
- 8 As such, the impact to the total exhaust emissions are greater than the Proposed Project, and the
- 9 One Transformer Alternative would result in a longer construction period by at least 6 months.
- 10 For these reasons alone, the One-Transformer Alternative is not environmentally superior to the
- 11 Proposed Project.
- 12 13
- ii. The One-Transformer Alternative does not substantially lessen impacts to any other resource area.

14 For the bulk of the analysis, the DEIR concludes that the One-Transformer Alternative would

- 15 only have a "slight" or "negligible" or "substantially the same" impact as compared to the
- 16 Proposed Project (e.g., for Aesthetics, Cultural Resources, Geology, GHG, Hydrology, Land
- 17 Use, Noise, Population and Housing, Public Services, and Recreation). For other resource areas
- 18 where the DEIR concludes a greater reduction in impacts, such as in Biological Resources,
- 19 Traffic and Hazards, that analysis is flawed.
- 20 For Biological Resources, the DEIR assumes that the 11.6 acres avoided under the One-
- 21 Transformer Alternative consists of "higher-value habitat" because "special-status bird species
- 22 (including California coastal gnatcatcher) are known to occur within this habitat."<sup>20</sup> The 11.6
- 23 acres, proposed to be avoided, is ruderal with exotic non-native plant species,<sup>21</sup> not mature
- coastal sage scrub that would be consistent with higher value habitat for the gnatcatcher. Further,
- 25 there has not been any documentation of successful nesting of special-status bird species within  $\frac{22}{2}$
- 26 the 11.6 acres,<sup>22</sup> which includes four years of data from the Tehachapi Renewable Transmission
- 27 Project (TRTP) and technical surveys for TRTP and Mesa.<sup>23</sup>Additionally, the mulefat scrub

19	oil is a function of appropriate safeguards in place to manage and control such releases. The

21	anticipate a release of oil from the largest single container, not a coincident release from all

23	would likely be approximately 40% larger by volume than the transformer banks required under	
24	the Proposed Project, meaning that each one would likely contain that much more oil as well.	
25	Therefore, there is actually a potential for more oil to be released under the One-Transformer

27	what is drawn in the DEIR.

## A. The Two-Transformer (2-1120 MVA) Substation Alternative Does Not Meet **CPUC Project Objectives.**

- The Two-Transformer (2-1120 MVA) Substation Alternative does not meet CPUC project
- Objective 1. CPUC Project Objective 1 is to:

- 1 Address projected violations of NERC Standard TPL-001-04, WECC Regional Business 2 Practice TPL-001-WECC-RBP-2, and CAISO Planning Standards that would occur upon 3 retirement by December 31, 2020, of generators that use OTC. 4 In the power flow case study provided to SCE by ELCON, the 220 kV bus configuration was 5 altered as compared to the Proposed Project. The Proposed Project operates the 220 kV bus in a 6 split configuration to prevent short circuit duty from exceeding the rated capabilities of the 7 standard 220 kV circuit breaker. According to the power flow case provided by ELCON, 8 however, the 220 kV bus tie breaker was closed with one transformer bank connected on either 9 side of that circuit breaker, which results in excessive short circuit duty values on the switchrack 10 when combined with the contributions from all twelve 220 kV transmission lines connected to 11 that switchrack. When the tie breaker was opened to alleviate the short circuit duty issue, it 12 resulted in one of the 500/220 kV transformer banks reaching its normal rating of 1120 MVA. 13 Just a slight modification in the renewable generation dispatch assumption or generation capacity in the Western LA Basin would cause an overload condition. Due to this thermal transformer 14 15 overload the Two-Transformer Alternative fails to satisfy CPUC Objective 1. Further, similar to 16 the effect on the One-Transformer (1600 MVA) Substation Alternative, implementing this 17 alternative as suggested with two transformer banks would also change the number of required 18 positions in the 220 kV switchrack, not just the 500 kV switchrack and transformer bank areas, 19 thereby resulting in the need to redesign the entire 220 kV switchrack. It is anticipated that the 20 redesign effort needed to incorporate the Two-Transformer (1120 MVA) Substation Alternative 21 would require approximately 9-12 months to modify not only the electrical design of both the 22 500 kV and 220 kV switchracks, as well as the transformer bank areas, but also the overall site 23 grading design to match the new substation layout. Considering that the construction of the 220 24 kV switchrack is one of the critical activities to be performed during Phases 1 and 2 of the 25 overall construction sequencing, and must be completed prior to demolition of the existing 26 substation in order to clear an area sufficient to build the 500 kV switchrack, the overall schedule 27 impacts resulting from this redesign effort would significantly jeopardize the successful 28 completion of this project by the required in-service date.
- 29 30

# B. The Two-Transformer (2-1120 MVA) Substation Alternative Does Not Meet SCE Project Objectives.

- 31 The Two-Transformer Alternative degrades reliability. SCE's Objective 1 was:
- 32 *Provide safe and reliable electrical service.*
- 33 As with the One-Transformer Alternative, the Two-Transformer Alternative ignores SCE's
- 34 objective of providing safe and reliable electrical service due to reliance on a RAS. As stated
- above, implementation of the proposed RAS results in the loss of four 220 kV transmission lines
- 36 which serve load in the Western LA Basin, including cutting off the entire Serrano Corridor.
- 37 This degrades reliability and reduces import capabilities.
- 38 Furthermore, the CPUC DEIR states that the two transformers would be

outage. Instead the grid would operate as if the substation was not in place.<sup>26</sup> 5 This statement is incorrect. If a transformer bank failed and both were taken out of service, this 6 would be an outage. As concluded in the CPUC's own analysis of the No Project Alternative, 7 without an outage, if the grid operated as if the substation were not in place, violations of NERC 8 TPL-001-4 criteria would result. The statement cited above from the DEIR recommends 9 designing the system so that a fault affecting a single transformer bank results in the loss of the 10 entire 500/220 kV transformation at Mesa Substation. This further represents the degraded 11 reliability provided by this Alternative in comparison to the Proposed Project. C. The Two-Transformer Substation Alternative is Not Environmentally Superior 12 13 to the Proposed Project. 14 The DEIR concludes that the Two-Transformer Alternative is environmentally superior to the D1-26 Proposed Project. This is incorrect. The rationale stated above regarding the flawed 15 16 environmental analysis of the One-Transformer Alternative similarly applies to the Two-17 Transformer Alternative. The only difference here is that in addition to creating more truck trips 18 and increasing impacts to air quality as compared to the Proposed Project and the other flawed 19 comparison analysis discussed above, any other purported potential reduction of impacts for this Alternative are even less than the One-Transformer Alternative due to the 8.3-acre reduction as 20 21 compared to the 11.6-acre reduction. 22 V. THE DEIR'S ANALYSIS OF THE GAS-INSULATED (GIS) SUBSTATION 23 **ALTERNATIVE IS FLAWED** 24 25 A. The GIS Substation Alternative Does Not Meet CPUC Project Objectives. 26 The GIS Alternative does not meet CPUC project Objective 1. CPUC Project Objective 1 is to: D1-27 27 Address projected violations of NERC Standard TPL-001-04, WECC Regional Business 28 Practice TPL-001-WECC-RBP-2, and CAISO Planning Standards that would occur upon 29 retirement by December 31, 2020, of generators that use OTC. 30 If the GIS Substation Alternative were selected, SCE would need to significantly redesign the 31 substation layout to modify not only the electrical design of all new GIS switchracks, as well as 32 the transformer bank areas, but also the overall site grading design to match the new substation 33 layout. This re-design would also most likely dramatically change the entire construction 34 sequencing plan because different grading requirements would be needed in order to install the 35 new GIS switchracks before other substation equipment is installed on the site. These procurement and re-design efforts would result in an 5 overall schedule delay of approximately 12-24 months and therefore result in not being able to successfully meet the December 31, 2020 online date. 6 7 B. The GIS Substation Alternative Is Not Environmentally Superior To The 8 **Proposed Project.** 9 The DEIR also concludes that the GIS Substation Alternative is environmentally superior to the Proposed Project. For all the reasons discussed above for the One-and Two-Transformer 10 Alternatives, the GIS Substation environmental analysis is also similarly flawed, except here, the 11 12 purported "savings" in acreage diminishes to just 7.3 acres. In addition, the DEIR concludes that 13 whatever impact decreases might be gained by this alternative, those purported decreases "do not outweigh the substantial increase in long-term greenhouse gas emission increase the GIS 14 Alternative would cause compared to the proposed project and to the other alternatives 15 considered." <sup>27</sup> Therefore, the GIS Substation Alternative is not environmentally superior to the 16 Proposed Project. 17 18 VI. THE DEIR CONTAINS ERRONEOUS AND INFEASIBLE MITIGATION 19 **MEASURES THAT SHOULD BE DELETED** 20 21 A. Mitigation Measure Hydrology-6 Should Be Deleted Because The Mesa 22 Substation Site Is Not Within A Dam Inundation Area. 23 24 The DEIR erroneously concludes that the Mesa Substation site is located in a dam inundation area.<sup>28</sup> Mitigation Measure Hydrology -6 (HY-6) would require SCE to install dam inundation 25 26 protection measures into the substation design, which could include a concrete perimeter wall 27 and flood gates at entry ways, elevation of substation equipment, and sealing equipment 28 buildings. 29 SCE reviewed the City of Monterey Park General Plan (2001) section related to the potential failure of the north and south dams surrounding the Garvey Reservoir.<sup>29</sup> In particular, Figure 30 31 SCS-4 (Flood Inundation Area: Garvey Reservoir and Laguna Basin), shows the Main Project



2 The Mesa Substation and nearby telecommunications, transmission, subtransmission, and

3 distribution infrastructure would not be located in the inundation area of the Garvey Reservoir.

4 Therefore, Mitigation Measure HY-6 is inapplicable and should be deleted.

#### 5 6

# B. Mitigation Measure Noise-2 Should Be Deleted Because It Is Impossible To Achieve.

7 Mitigation Measure Noise-2 requires the Mesa Substation Project comply with the Monterey

8 Park noise ordinance nighttime noise standard of 50-dBA in relation to the closest receptor.<sup>30</sup> As

9 noted in the DEIR, the ambient noise level in the vicinity of the nearest receptor is 52-dBA,

10 average 8-hour dBA.<sup>31</sup> SCE cannot comply with the mitigation measure as it is written because

11 no mitigation installed on the Project can effectively reduce the existing ambient noise level, not

12 caused by the Project, from 52-to- 50 dBA. SCE will be implementing Mitigation Measure

13 Noise-1, "Noise Control Plan" and will implement noise reduction measures into its design to the

14 extent feasible. Since Mitigation Measure Noise-2 is not possible as written, and since Mitigation

15 Measure Noise-1 requires a Noise Control Plan that will mitigate noise impacts, SCE requests

16 that Noise-2 be deleted from the DEIR.

### 1 VII. CONCLUSION

- 2 The DEIR's analysis of the One-Transformer Alternative, the Two-Transformer Alternative, and
- 3 the GIS Substation Alternative, is flawed. For the reasons stated above, all three alternatives
- 4 should be dismissed from consideration. Additionally, the One-Transformer Alternative is
- 5 technically infeasible, none of the three alternatives meet basic CPUC and SCE project
- objectives and none substantially lessen environmental impacts as compared to the Proposed
   Project. The DEIR should be modified to reflect these comments. Further, SCE has identified
- 8 mitigation measures that are infeasible or inapplicable that should be modified or deleted in the
- 9 DEIR.

Responses to comments D1-11, D1-12, D-13, D1-14, and D1-16 address how the One-Transformer-Bank Substation Alternative meets most of CPUC's project objectives and explains that meeting SCE's objectives from the PEA is not a requirement for alternatives under CEQA. Refer to response to comment D1-18 regarding the environmentally superior alternative.

#### D1-11 SCE Objectives

CEQA Guidelines section 15126.6(a) requires that alternatives considered in an Environmental Impact Report (EIR), among other requirements, meet most of the basic project objectives. Section 15124(b) of the CEQA Guidelines requires that an EIR contain a "statement of the objectives sought by the proposed project. . . . The statement of objectives should include the underlying purpose of the project." It is within the discretion of the Lead Agency to select objectives for the project. As stated in *In re Bay-Delta Programmatic Environmental Impact Report Coordinated Proceedings* (2008) 43 Cal.4th 1143, 1163, "The process of selecting the alternatives to be included in the EIR begins with the establishment of project objectives *by the lead agency*" (emphasis added). The CPUC's consideration of SCE's Objectives." Objective 7 from SCE's PEA is:

Design and construct the proposed project in conformance with SCE's approved engineering, design, and construction standards for substation, transmission, subtransmission, distribution, and telecommunications system projects.

Section 1.2.2.2 of the Draft EIR explains that the CPUC considered all of SCE's objectives in formulating its project objectives, and this specific objective was not incorporated into CPUC's objectives because it does not address the underlying purpose of the project. The underlying purpose of the proposed project is not to design and build a project that complies with SCE standards, but rather to accomplish the three CPUC objectives set forth below. Section 1.2.4, "Detailed Description of CPUC Project Objectives," describes the rationale for the CPUC's identification of the three

CEQA objectives for the proposed project. Those objectives are:

- Address anticipated violations of the North American Electric Reliability Corporation (NERC) Standard TPL-001-04 (NERC 2015), Western Electricity Coordinating Council (WECC) Regional Business Practice TPL-001-WECC-RBP-2 (WECC 2011), and California Independent System Operator (CAISO) Planning Standards that would occur upon retirement by December 31, 2020, of generators that use OTC.
- 2. Avoid introduction of new violations of NERC, WECC, and CAISO standards.
- 3. Maintain electrical service by minimizing service interruptions during project implementation.

The One-Transformer-Bank Substation Alternative meets all three of the CPUC's project objectives.

#### **Technical Feasibility**

In addition to meeting most of the basic project objectives, CEQA Guidelines section 15126.6(a) also requires that alternatives considered in an EIR be potentially feasible. "Feasible" is defined as "capable of being accomplished in a successful manner within a reasonable period of time, taking into account economic, environmental, legal, social, and technological factors" (CEQA Guidelines section 15364). In this comment, SCE identifies issues that it claims make the One-Transformer-Bank Substation Alternative technically infeasible. Specifically, SCE claims the following:

- SCE does not have a standard design for a 1600-megavolt ampere (MVA) transfer bank and is not aware that the equipment is used as standard equipment in California or the United States.
- Each transformer in the One-Transformer-Bank Substation Alternative would be 40 percent larger in volume than the transformers that would be utilized for the proposed project. This would require procurement of non-standard circuit breakers and disconnect switches, if such equipment could be procured. Procurement of such equipment could take significantly longer than it would for the proposed project.
- The larger transformer bank would also necessitate changes to the standard substation layout to accommodate the increased length, width, and height.

Redesign of the proposed project to incorporate the One-Transformer-Bank Substation Alternative would require an estimated 9 to 12 months to take into account the change in number of positions in the 220-kilovolt (kV) switchrack, change in number of positions in the 500-kV switchrack, change in overall site grading design, and change in size of the transformer bank areas.

SCE claims that it does not have a standard design for a 1600-MVA transformer bank and is not aware that the equipment is used as standard equipment in California or the United States. The CPUC acknowledges the statement that SCE does not have a standard design for the One Transformer-Bank Substation Alternative and is not aware of use of such equipment as standard equipment elsewhere. The CPUC, however, is aware of such a transformer being in use at the Bonneville Power Administration's Maple Valley 500/230-kV substation. The Maple Valley Substation utilizes a 1600-MVA transformer bank with three phases, each of which is 533 MVA, similar to the One-Transformer-Bank Substation Alternative.

The CPUC presumes that SCE's claim that the transformer bank would be 40 percent larger in volume than the proposed project's transformer bank is not a claim about size but about capacity, given that 1600 MVA is approximately 40 percent more than 1120 MVA. SCE claims that, due to the higher capacity, non-industry-standard circuit breakers and disconnect switches would be needed and procurement could take significantly longer than for the proposed project. It is reasonable to assume that nonstandard equipment may be necessary based on the design of the One-Transformer Alternative. It is also reasonable to assume it may take longer to procure. However, the CPUC has no evidence regarding the specific length of time required for procurement of equipment.

Regarding SCE's claim regarding the longer design and procurement time, it is reasonable to assume that design of the alternative substation may delay implementation of the alternative, compared to the implementation of the proposed project, given that SCE would currently be designing the proposed project. However, this additional time of approximately 9 to 12 months is insufficient evidence to revise the EIR's conclusion that the alternative is potentially feasible.

SCE also comments that the alternative transformer bank presents other technical challenges, including from transporting "larger-sized 533 MVA transformer bank units to the project site" on "larger-than-normal trucks." SCE does not state how much larger it believes a 533 MVA transformer would be. However, it is possible that transformers for the alternative may be the same size as or smaller than those for the proposed project. Based on the Maple Valley Substation, each transformer used for the alternative could occupy an area that is about 37 by 13 feet, with a height of about 15 feet (without brushings installed). For comparison, each transformer bank for the proposed project would occupy an area that is about 30 by 33 feet with a height of 35 feet, as described in the project description. Therefore, the CPUC is not aware of evidence to support the claim that the transformers used in a 1600-MVA transformer bank would most certainly be larger in size than the transformer used for the proposed project. The CPUC has insufficient evidence to revise the EIR's conclusion that the alternative is potentially feasible.

The EIR concludes that the One-Transformer-Substation Alternative is potentially feasible, as required by CEQA. However, the decision makers may consider the content of this comment, including SCE's statements regarding design standards and feasibility, as evidence in determining the feasibility of the One-Transformer-Substation Alternative.

#### **Environmental Impacts of the One-Transformer-Bank Alternative**

SCE notes the following regarding environmental impacts of the One-Transformer Bank Alternative:

• Non-standard transformer banks and circuit breakers would result in concerns

about operation and maintenance since it would be the only such equipment in the SCE system. Spare transformers, circuit breakers, and disconnects may have to be purchased and stored on site and off site, which would require additional space not shown in Figure 3.4-1.

• The larger size of the transformer banks may require use of oversized trucks and more lane closures and result in an impact to traffic.

SCE claims that spare equipment, such as circuit breakers, more than one spare transformer, and disconnects may need to be stored on site at Mesa Substation and that the One-Transformer-Bank Substation Alternative would require more space than is shown in the schematic in Figure 3.4-1 to account for storage. In response, the CPUC believes that Figure 3.4-1 sufficiently depicts the proposed alternative footprint, and the CPUC is not aware of any evidence to support the assertion that the schematic in Figure 3.4-1 is inadequate.

SCE claims that the Comparison of Alternatives analysis does not discuss additional lane closures needed to ship larger transformers on "larger-than-normal trucks." As previously described, it is possible that transformers could be the same size as or smaller than those used for the proposed project. While the transformers could also be larger than those used for the proposed project, it would be speculative at this point to assume that "larger-than-normal" trucks would be required to transport the transformer and that those trucks would cause subsequent lane closures greater than those examined in the proposed project because specifics about transformer size and necessary truck size cannot be known until design of the transformer. CEQA Guidelines section 15145 states that "[i]f, after thorough investigation, a Lead Agency finds that a particular impact is too speculative for evaluation, the agency should note its conclusion and terminate discussion of the impact." Therefore, the EIR properly excludes an analysis of this impact.

- D1-12 CEQA Guidelines section 15126.6(a) requires that alternatives considered in an EIR, among other requirements, meet most of the basic project objectives. The commenter states that the alternative does not address projected violations of NERC TPL-001-4 under each contingency included in Appendix B of the Draft EIR and specifically claims that the alternative does not address contingencies 4 and 5. The commenter correctly notes that contingencies 4 and 5 result in loading to 98 percent of capacity. The commenter states that the analysis assumed a lower transformer bank impedance than the minimum impedance under SCE standards; increasing the impedance to be consistent with SCE standards would result in higher loading under contingencies 4 and 5 that reach or exceed the emergency rating of transmission lines. However, designing and constructing the proposed project to meet SCE's standards, including SCE's standards for minimum impedance, is not part of objective 1 of the proposed project, or any objective 0 fthe proposed project, as described in response to comment D1-11. CPUC Objective 1 for the proposed project is:
  - 1. Address anticipated violations of the NERC Standard TPL-001-04 (NERC 2015), WECC Regional Business Practice TPL-001-WECC-RBP-2 (WECC 2011), and CAISO Planning Standards that would occur upon retirement by December 31, 2020, of generators that use OTC.

The alternative was designed with a specific impedance, and the alternative meets the objective when using that specified impedance. The fact that One-Transformer-Bank Substation Alternative was designed with a lower impedance than SCE's standard minimum impedance is not evidence that the alternative does not meet Project Objective 1. The alternative, as designed and evaluated in the EIR, would address anticipated violations in Appendix B and would therefore meet Objective 1.

SCE also states that the impedance may be below what is readily available from the equipment suppliers. It is presumed that SCE is suggesting that this kind of equipment may take longer to procure and not that the equipment is not available at the impedance specified in the Draft EIR. It is reasonable to assume that non-standard equipment may take longer to procure. However, the CPUC is not aware of evidence regarding the specific length of time required for procurement of this equipment.

The commenter also states that the lower impedance value results in "the transformer bank reach[ing] its emergency rating following a contingency." First, it is acceptable under NERC, WECC, and CAISO standards for a transformer bank to reach its emergency rating following a contingency. Furthermore, all anticipated violations to be addressed under Project Objective 1 are listed in Appendix B of the EIR. Therefore, thermal loading on the transformer bank at the upgraded Mesa Substation is not considered a violation to be addressed under Project Objective 1 and is not listed in Appendix B. However, this potential overload could affect whether Project Objective 2 is met. However, because it is acceptable under NERC, WECC, and CAISO standards for a transformer bank to reach its emergency rating following a contingency, SCE's claims do not show that the project does not meet Objective 2.

#### D1-13 Project Objective 1 is to:

1. Address anticipated violations of the NERC Standard TPL-001-04 (NERC 2015), WECC Regional Business Practice TPL-001-WECC-RBP-2 (WECC 2011), and CAISO Planning Standards that would occur upon retirement by December 31, 2020, of generators that use OTC.

The date associated with Project Objective 1 (December 31, 2020) for retirement of generators that use OTC is not an objective for implementation of the proposed project, but is rather a target date for retirement of OTC generation. The Statewide Advisory Committee on Cooling Water Intake Structures (SACCWIS) exists to ensure that schedules under the Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling do not disrupt California power supply. SACCWIS reports to the State Water Resources Control Board (SWRCB) and provides recommendations related to deadlines, project permitting constraints, and local area and grid reliability. The SWRCB may then amend the Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling. One possible amendment is to extend compliance dates. Therefore, retirement may occur after December 31, 2020. As a result, the inability of an alternative to be constructed by December 31, 2020, does not mean that alternative will not meet Project Objective 1. An alternative would meet Project Objective 1 if, after OTC generation retirement, whenever that ultimately occurs, the alternative would address projected violations. The proposed project would likely not come on line until after December 31, 2020, given a construction start date of early 2017 and anticipated construction timeline of 55 months, which would result in project

completion in late 2021. Therefore, the date associated with Project Objective 1 is a reference for when OTC generation is scheduled, but not guaranteed, to be retired. It is reasonable to assume that SCE has not designed a One-Transformer-Bank Substation Alternative and that implementing such an alternative would take longer than implementing the proposed project. Nonetheless, SCE's claims are not evidence that the One-Transformer-Bank Substation Alternative does not meet Project Objective 1.

SCE claims that the potential delay associated with implementation of the One-Transformer-Bank Substation Alternative would require OTC generating facilities to operate beyond the OTC generation compliance date, which would result in continued environmental impacts related to OTC generation operation until the project (or an alternative) is implemented. It appears unlikely, however, that the proposed project would be implemented until after the OTC generation compliance date (December 30, 2020). A later in-service date could result in delay of OTC generation retirement until at least late 2021. The CPUC cannot predict definitively how the final date of implementation of the project or an alternative would ultimately affect the OTC retirement deadline.

Insufficient information exists to provide a meaningful analysis of the environmental impacts of any potential delay of implementation of the project or an alternative. CEOA Guidelines section 15145 states that "[i]f, after thorough investigation, a Lead Agency finds that a particular impact is too speculative for evaluation, the agency should note its conclusion and terminate discussion of the impact." Assuming that SCE is correct in asserting that the alternative would result in delay of project implementation, the CPUC recognizes that delay of project implementation may cause delay of OTC retirement, which could result in continued environmental impacts from use of OTC. These impacts, which are already occurring under existing conditions, include thermal impacts from discharge of cooling water and impingement and entrainment impacts to marine life as a result of seawater withdrawal. It would be speculative to try to identify specific impacts related to extending the OTC generation retirement deadline. It is unknown, for example, which OTC generation would be kept on line in the case of OTC generation retirement delay—it is possible that either Redondo or Alamitos retirement may be delayed (CAISO 2016c). Which generator remains on line indicates which specific environmental impacts continue beyond the currently anticipated retirement deadline. The Redondo Beach Generating Station and the Alamitos Generating Station are located in two different environments and would have different ongoing environmental impacts on marine wildlife species if their retirement is delayed. The Redondo Beach Generating Station is located near the ocean and draws water from three submerged intake points within King Harbor and the Redondo Beach Marina (Tetra Tech 2008). Water is discharged north of the King Harbor breakwater, directly into the ocean, and near the entrance to King Harbor (EPRIsolutions 2005). The Alamitos Generating Station is located inland, 2 miles northeast of Alamitos Bay along the west bank of the San Gabriel River. The intake for Alamitos Generating Station comes from two manmade channels, which draws water from the Los Cerritos Channel. The water is discharged into the San Gabriel River (Tetra Tech 2008). Specific environmental impacts of OTC retirement delay cannot be provided without knowing which generator might be kept online pending Mesa Substation's final in-service date.

The capacity of the OTC generator(s) that would be utilized in the case of the delay is also unknown, given that capacity is dependent on overall demand. Facility and

capacity utilized affect the amount of cooling water that would be used and therefore determine severity of environmental effects. It would be speculative to attribute any of the impacts to delay associated with implementation of a project alternative (or the proposed project) because (1) impacts are currently ongoing under existing conditions and (2) there are other unpredictable factors that may affect OTC retirement deadlines.

Comparison of impacts between the proposed project and the One-Transformer-Bank Substation Alternative would also be speculative. The EIR therefore need not evaluate these impacts.

D1-14 CEQA Guidelines section 15126.6(a) requires that alternatives considered in an EIR, among other requirements, meet most of the basic project objectives. The commenter claims that an N-2 contingency of the Rio Hondo–Vincent No 1 and No. 2 230-kV Transmission Lines would result in a transformer at Mesa Substation to be loaded to 1698 MVA when using SCE's modeled impedance. However, designing and constructing the proposed project to meet SCE's standards, including SCE's standards for minimum impedance, is not part of Objective 2 of the proposed project, or any objective of the proposed project, as described in response to comment D1-11.

SCE also states that different dispatch scenarios, including increased renewable energy resources to meet the new California renewable energy requirements, would "further exacerbate transformer bank loading at Mesa Substation" if the generation is connected north of Vincent Substation. Power flow data used for Objective 2 are data provided by SCE that were used in its 2014 annual reliability assessment, as described in A3-8. Allowing for integration of renewable energy into the grid to meet new renewable energy requirements is not part of Objective 2 of the proposed project, or any objective of the proposed project.

CPUC Objective 2 for the proposed project is:

2. Avoid introduction of new violations of NERC, WECC, and CAISO standards.

A lower impedance and the SCE 2014 annual reliability assessment power flow data were used for the EIR analysis, which resulted in a finding that the One-Transformer-Bank Substation Alternative transformer would be loaded to 98 percent of the transformer's emergency rating, which is not a violation of NERC, WECC, and CAISO standards. Therefore, SCE's claims are not evidence that the One-Transformer-Bank Substation Alternative would not meet CPUC Project Objective 2.

However, the decision makers may consider SCE's standards and the modeled impedance value used for the alternative, as evidence of whether the One-Transformer-Substation Alternative is infeasible.

- D1-15 Refer to responses to comments D1-13 and D1-14.
- D1-16 The CPUC's consideration of SCE's objectives is discussed in Draft EIR Section 1.2.2.2, "Consideration of SCE's Objectives." SCE asserts that the EIR disregards SCE's first objective from the PEA, which was "Provide safe and reliable electrical service." As described on page 1-3 of the EIR, the CPUC incorporated this goal into CPUC Objectives

1 and 2. Addressing anticipated violations of reliability criteria as well as avoiding creation of new violations of reliability criteria are directly related to the provision of safe and reliable electrical service. CPUC's Objectives 1 and 2 are specific enough to aid CPUC in defining a reasonable range of alternatives to evaluate in the EIR.

SCE claims that implementation of a Remedial Action Scheme (RAS) is less reliable and reduces import capabilities when compared to the proposed project. The reliabilitybased objectives of the proposed project are to address a certain set of reliability criteria violations outlined in Appendix B of the EIR and to avoid introduction of new violations of reliability criteria. SCE states that the alternative is less reliable. The CPUC's study of the RAS found that implementation of the RAS for specific contingencies would avoid violations of reliability standards, as shown in Appendix B. Regarding import capabilities, as discussed in Section 1.2.4.1 of the EIR, thermal overloads following certain contingencies listed in Appendix B indicate that there is insufficient capacity on transmission lines to import energy to meet demand after OTC retirement. More energy would need to be imported through the Serrano Corridor, but it would have insufficient capacity. Although it is true that the One-Transformer-Bank Substation Alternative addresses all contingencies in Appendix B. It also provides adequate import capacity to meet Objectives 1 and 2.

SCE asserts that the EIR disregards SCE's third objective from the PEA, which was "Allow greater flexibility in the siting of future generation projects to meet local reliability needs in the Western Los Angeles Basin while reducing the total amount of new generation required by providing additional transmission import capability." SCE states that the CPUC has minimally addressed system needs with little consideration for the future. As explained on page 1-4 of the EIR, the CPUC used its discretion as the Lead Agency for the proposed project to craft objectives focused on projected issues to address specific contingencies that would cause violations of reliability criteria. Other than speculation about "future changes in power flow patterns, as well as further reduction of generation resources in the Western Los Angeles Basin," as well as a statement that "limited operations of the Aliso Canyon Gas facility ... may result in gas shortages," SCE does not indicate which specific, concrete future system needs the CPUC has insufficiently addressed, but rather states that the CPUC does not address the "overarching system need." The CPUC is not aware of evidence of probable system needs or future needs the proposed project is meant to address but would not address. Focusing on specific contingencies identified by SCE allowed the CPUC to consider a reasonable range of alternatives, as required by CEQA, that would address the specific violations the proposed project is meant to address, which are listed in Appendix B. The CPUC's CEOA project objectives therefore adequately took into account SCE's project objectives from the PEA as explained in the Draft EIR.

SCE states that limiting the substation footprint for the One-Transformer-Bank Substation Alternative would limit future grid expansion. Allowing for future grid expansion is not a CEQA objective for the proposed project. Allowing for future grid expansion for undefined needs at an unknown planning horizon is too broad to satisfy CEQA requirements to be a project objective because it would not help the CPUC define a reasonable range of alternatives.

SCE also claims that limiting the footprint of the Mesa Substation would result in

environmental impacts from expanding the substation in the future. However, as there are currently no future plans to upgrade the Mesa Substation beyond the proposed project, analyzing impacts from future expansions would be speculative and beyond the scope of this proposed project. (Draft EIR, p. 2-28 ["The extent and timing of any future expansion would be speculative because future demand is not defined and is often unpredictable in the long term given the number of variables affecting demand, such as energy efficiency, distributed generation, and demand response."].) Future projects may also be required to undergo environmental review pursuant to CEQA.

Additionally, the EIR concludes that the One-Transformer-Bank Substation Alternative meets all objectives. Eventual expansion of the substation is not needed to meet the project objectives. Therefore, eventual expansion of the One-Transformer-Bank Substation Alternative and the environmental impacts of that expansion are not considered in this EIR.

SCE's other related comments regarding cost and need of the proposed project are included in the project record for consideration by the decision makers. The comments do not raise an environmental issue; therefore, no further response is required.

D1-17 CEQA Guidelines section 15126.6(a) requires that an alternative evaluated in the EIR "avoid or substantially lessen any of the significant effects of the project," not that the alternative reduce a significant *unavoidable* impact of the proposed project. Therefore, the fact that the One-Transformer-Bank Substation Alternative does not substantially avoid or reduce a specific significant *and unavoidable* impact of the proposed project is not germane to whether the alternative meets the requirement under CEQA Guidelines section 15126.2(a). The One-Transformer-Bank Substation Alternative, Two-Transformer-Bank Substation, and Gas-Insulated Substation Alternative all substantially reduce significant impacts to biological resources, as described in responses to comments D1-20, D1-26, and D1-28, respectively. Therefore, they meet the CEQA requirement to avoid or substantially lessen any of the significant effects of the project.

> CEQA Guidelines section 15126.6(e)(2) contains the requirements for the environmentally superior alternative discussion in an EIR. It states that, "[i]f the environmentally superior alternative is the 'no project' alternative, the EIR shall also identify an environmentally superior alternative among the other alternatives." Refer to Section 5.4, "Environmentally Superior Alternative," for a discussion of the environmentally superior alternative and conclusion that the One-Transformer-Bank Substation Alternative is the environmentally superior alternative. In determining the environmentally superior alternative, any potential reductions in impacts are considered. CEQA allows the Lead Agency discretion in the methodology used to identify the environmentally superior alternative and does not mandate that slight reductions in impacts or that similar levels of impacts be ignored when determining the environmentally superior alternative. CEQA also does not mandate that the environmentally superior alternative analysis ignore reductions in impacts that are less than significant. Therefore, the environmentally superior alternatives analysis appropriately took into account all reductions in impacts.

D1-18 SCE asserts that the One-Transformer-Bank Substation Alternative would result in increases in the total exhaust emissions because additional soil imports would be

needed on site. The area excluded from the disturbance area under the One-Transformer-Bank Substation Alternative was to be used for fill material for other parts of the substation site. SCE states that, without the soil from this area, additional soil would have to be imported, increasing the number of truck trips needed for Phase 1 and Phase 3 by 5,000 trips. SCE states that soil can be moved within the site 10 times faster than it can be imported, so the project construction timeline would extend about 6 months longer than the proposed project due to the additional soil import.

The area in Phase 3 as shown on Draft EIR Table 2-7 is topographically higher, making it a reasonable assumption that more soil would need to be imported under the One-Transformer-Bank Substation Alternative when the area is excluded from the project footprint. The One-Transformer-Bank Substation Alternative would slightly increase total exhaust emissions but would still substantially decrease fugitive dust created when compared to the proposed project. On balance, there would be a moderate reduction in air quality impacts. Thus, the One-Transformer Bank Substation remains environmentally superior to the proposed project for Air Quality. The following revision has been made to the analysis to reflect this and to update acreages changes based on revised geographic information system (GIS) data submitted by the applicant:

#### Pages 5-4 to 5-5:

#### **Air Quality**

Construction of the One-Transformer-Bank Substation Alternative would result in total reduced increased air quality emissions impacts over the construction period, but reduced fugitive dust emissions. though the maximum daily emissions during construction would remain the same as for the proposed project. While the reduced substation size would require less import of materials for building the substation itself, a shorter construction period and less ground disturbance, but construction of the One-Transformer-Bank Substation Alternative would also reduce the disturbance area by excluding the Phase 3 area shown in Figure 2-4. Under the proposed project, this area was to provide some of the fill required at the substation site. Without this fill available, SCE estimates that an additional 5.000 truck trips will be needed, in total, to import soil to the site. The additional total trips would increase overall exhaust emissions, and would slightly increase the maximum number of trips per day when compared to the proposed project. it is assumed that daily construction activities would not change in intensity. It is assumed that soil import would be needed during Phase I, when general site grading would occur, which would be approximately 18 months long for the proposed project. With an additional 6 months needed for soil transport, Phase I would be 24 months long. An additional 5,000 trips over Phase I of construction [24 months] equates to an average of approximately 11 truck trips per day, or 22 passenger-car-equivalent (PCE) trips, on each day of construction. Given that Phase I would have a maximum of 2,144 PCE daily trips for the proposed project, an increase of about 1 percent in trips and exhaust emissions would result in a slight increase in maximum daily quality exhaust emissions. Thus, daily maximum criteria pollutant emissions would be negligibly increased about the same under the One-Transformer-Bank Substation Alternative compared to the proposed

project. However, the reduced construction period at the substation would result in an overall substantial decrease in total exhaust emissions (Impact AQ-2 and Impact AQ-3). However, the reduced disturbance area (about <u>11.6</u> <u>14.4</u> acres less than the proposed project) would substantially reduce fugitive dust emissions from ground disturbance (Impact AQ-2 and Impact AQ-3). <u>Given the substantial</u> <u>reduction in fugitive dust and the slight increase in maximum daily exhaust</u> <u>emissions, there would be a slight overall reduction in air quality impacts (Impact AQ-2 and Impact AQ-3).</u>

For consistency with this change in the analysis and to update acreages changes based on revised GIS submitted by the applicant, the following revisions have also been made to the EIR:

### Page ES-27, Table ES-3:

**Air Quality:** Substantially reduces total exhaust emissions as well as fugitive dust emissions from ground disturbance (Impact AQ-2, Impact AQ-3).

### Page 3-5:

### Page 5-11:

#### **Greenhouse Gas Emissions**

Overall greenhouse gas emissions from construction of the One-Transformer-Bank Substation Alternative would be <del>reduced compared to</del> greater than the proposed project. The smaller substation footprint would <u>require additional soil import due</u> to the reduced availability of on-site soil, as described under Air Quality, which would require more translate into less grading and therefore less heavy equipment use and fewer truck trips to import and export soil. Less grading would be required on site, which would reduce heavy equipment use on site. On balance, impacts would be similar to those of the proposed project, resulting in slightly reduced greenhouse gas emissions (Impact GHG-1) during construction.

All other construction impacts related to greenhouse gases under this alternative would be the same as those associated with the proposed project. Operations-related greenhouse gas emissions under this alternative would be the same as under the proposed project, since operations and maintenance activities would be about the same as under the proposed project.

### Page 5-7:

### Pages 5-12 through 5-13:

#### **Population and Housing**

It is presumed that the same maximum number of employees would be needed during construction under this alternative as under the proposed project. The duration of need for workers would, however, be <u>shorter about 6 months longer</u> than under the proposed project, as discussed under Air Quality. This could result in a negligible <u>increase in reduction of</u> the potential for temporary population growth in the area, compared to the proposed project, should construction workers relocate to the area. The impacts of this alternative and the proposed project would be substantially the same.

All other impacts related to population and housing would be the same as those associated with the proposed project.

### Page 5-13:

### **Public Services and Utilities**

The One-Transformer-Bank Substation Alternative would have a negligibly <u>increased reduced</u>-potential for need for public services due to hazardous materials spills, fire, theft, and vandalism, as well as lower production of wastewater and storm\_water as a function of the <u>longer shorter</u>-construction period at the substation site, <u>as discussed previously under Air Quality</u>.<del>and the</del> <del>reduced construction activity and substation footprint compared to the proposed</del> <del>project</del>. Impacts would be substantially the same as the proposed project.

The smaller disturbance area associated with the One-Transformer-Bank Substation Alternative would require less water for dust control during construction than the proposed project. This alternative would reduce ground disturbance by about <del>17</del> <u>20</u> percent, which may also reduce water use for dust control (Impact PSU-5) at the substation by <del>17</del> <u>20</u> percent.

All other impacts related to public services and utilities would be the same as those associated with the proposed project.

#### Recreation

It is presumed that the same maximum number of employees would be needed during construction of this alternative as for the proposed project. The duration of need for workers would, however, be slightly <u>longer shorter</u> than for the proposed project, as previously discussed under Air Quality, resulting in a small potential

<u>increase</u> decrease in the time that workers may need to relocate to the area. Thus, any increased use in recreational facilities due to temporary relocation of construction workers to the area could be negligibly <u>increased</u> <del>reduced</del>-under the One-Transformer-Bank Substation Alternative compared to the proposed project. The impacts of this alternative and the proposed project would be substantially the same.

All other impacts related to recreation under this alternative would be the same as those associated with the proposed project.

#### Page 3-9:

#### Potential to Substantially Reduce or Avoid Significant Impacts

This alternative would substantially reduce <u>the following several</u> significant impact<del>s, including</del>:

• Air Quality: Criteria pollutant <u>Fugitive dust</u> emissions during construction would be reduced since less ground disturbance and less grading would be required to accommodate the smaller substation footprint (reduces Impacts AQ-2, <u>and</u> AQ-3, and AQ-4).

**Biological Resources:** Gnatcatcher habitat and species impacts would be reduced since less activity would take place in gnatcatcher habitat (reduces Impacts BR-1, BR-2, and BR-4).The Environmentally Superior Alternative discussion has been revised as follows to take into account revisions in the comparison of alternative discussion made in response to comments D1-18, D1-20, D1-21, D1-22, D1-26, D1-28, and D2-221:

### Pages 5-25 through 5-26:

## 5.4 Environmentally Superior Alternative

All three alternatives discussed in Section 5.3, "Comparison of Alternatives," are considered environmentally superior to the proposed project. As shown in Table 5.3-3, the One-Transformer-Bank Substation Alternative is considered <u>the most</u> environmentally superior <u>alternative</u> in <u>seven nine</u> resource areas, and the Gas Insulated Substation Alternative is considered <u>the most environmentally</u> superior <u>alternative</u> in <u>two\_one</u> resource areas. For <u>four three</u> resource areas, <u>all-none of the</u> three alternatives would <u>be environmentally</u> superior to the proposed project <u>because they would result in similar impacts to the proposed</u>. For traffic and transportation, all three alternatives would increase impacts, but only slightly. have about the same level of impacts, and none is more environmentally superior than another; however, all three are environmentally superior to the proposed project.

Although the Gas Insulated Substation Alternative is environmentally superior for noise and aesthetics, this alternative could result in a substantial greenhouse gas impact that may exceed SCAQMD significance thresholds. As explained in Section 5.3.2.3, "Gas Insulated Substation Alternative," the Gas Insulated Substation Alternative would result in a substantial reduction in aesthetic impacts due to the

different switchrack equipment. Noise impacts would be only negligibly reduced, as a result of a shorter construction period in a small area close to sensitive receptors on Holly Oak Drive. The Gas-Insulated Substation Alternative may result in a significant impact related to greenhouse gases that would not occur under the proposed project or under the One-Transformer-Bank Alternative, Recent California greenhouse gas policy indicates that California has determined the reduction of greenhouse gases to be an important goal for the state. Executive Order B-30-15, signed by the Governor on April 29, 2015, set an aggressive greenhouse gas reductions goal—40 percent below 1990 levels by 2030. The 2030 goal ultimately is an interim benchmark to the 2050 goal of 80 percent below 1990 levels. The Executive Order is only the latest state greenhouse gas reduction policy of many, including the California Global Warming Solutions Act of 2006. The Executive Order recognizes several severe, adverse impacts of global warming, including loss of snowpack, drought, increased wildfires, increased smog, and heat waves (State of California 2015). Due to the potentially grave impacts of greenhouse gas emissions, as recognized in the State's latest aggressive policy action to reduce greenhouse gases, the decrease in long-term aesthetic and shortterm noise impacts do not outweigh the substantial increase in long-term greenhouse gas emissions increase the Gas-Insulated Substation Alternative would cause compared to the proposed project and to the other alternatives considered.

The One-Transformer-Bank Substation is environmentally superior to all alternatives and to the proposed project in most resource areas. In particular, it is environmentally superior for permanent impacts to biological resources, which is given substantial weight due to the permanence of the impacts and the importance of habitat that would be impacted by the proposed project. In areas where it is not environmentally superior, the Gas-Insulated Substation is superior. The Gas-Insulated Substation Alternative's long-term greenhouse gas impacts make it environmentally inferior to the One-Transformer-Bank Substation despite its benefits related to noise and aesthetics. The One-Transformer Bank Substation Alternative is therefore considered environmentally superior to the Gas-Insulated Substation Alternative. The One-Transformer Bank Substation Alternative is therefore the Environmentally Superior Alternative.

SCE notes that the delay in implementation could affect the potential to complete the project by December 2020. Public Resources Code section 21002 states that "public agencies should not approve projects as proposed if there are feasible alternatives or feasible mitigation measures available which would substantially lessen the significant environmental effects of such projects .... [I]n the event specific economic, social, or other conditions make infeasible such project alternatives ... individual projects may be approved in spite of one or more significant effects thereof." CEQA Guidelines section 15091(a) provides that a public agency cannot "approve or carry out a project for which an EIR has been certified which identifies one or more significant environmental effects of the project unless the public agency makes one or more written findings for each of those significant effects, accompanied by a brief explanation of the rationale for each finding." One possible finding, per CEQA Guidelines section 15091(a)(3) is that "[s]pecific economic, legal, social, technological, or other considerations, including provision of employment opportunities for highly trained workers, make infeasible the mitigation measures of project alternative

identified in the final EIR." An alternative is feasible if it can be "accomplished in a successful manner within a reasonable period of time, taking into account economic, environmental, legal, social and technological factors."

The EIR concludes that the One-Transformer-Substation Alternative is potentially feasible, as required by CEQA. However, the decision makers may consider the delay in implementation SCE associates with the One-Transformer-Bank Substation Alternative as evidence that speaks to whether the One-Transformer-Substation Alternative is infeasible.

D1-18a Figure 2-4 has been updated in the EIR to reflect that the current engineering of the proposed project includes the Operations Building and the Test and Maintenance Building in the northeast corner of the substation.

The One-Transformer-Bank Substation Alternative footprint is shown in Figure 3.4-1. SCE claims that under any alternative, the area in the northeast corner of the existing substation site would be graded for construction of the Operations Building and the Test and Maintenance Building. However, SCE is not responsible for designing the alternatives considered in the EIR. Alternatives considered in an EIR must be potentially feasible, avoid or substantially lessen any significant effect of the proposed project, and meet most of the basic project objectives. The CPUC has found that the One-Transformer-Bank Substation Alternative meets these requirements. CPUC has no evidence that exclusion of the northeast area referenced by SCE from the One-Transformer-Bank Substation Alternative would make the alternative infeasible, not meet most of the basic project objectives, or not avoid or substantially reduce a significant impact of the proposed project. Therefore, Figure 3.4-1 has not been revised.

- D1-18b SCE notes that the air quality calculations it conducted to support the analysis in the EIR utilize an estimated 30,000 truck trips as a result of grading activities. That truck trip number was subsequently revised (to a total of 15,000 trips) without updating air quality calculations. The addition of 15,000 truck trips across a 4.5-year construction period (the "excess" trips included in the air quality calculations) would not make an appreciable difference to daily emissions, the metric used to determine significance, and therefore would not affect the analysis or conclusions in the Draft EIR. No revisions were made to the EIR in response to this comment.
- D1-19 For the resources mentioned by the commenter, the EIR concludes the following regarding the impacts of the One-Transformer-Bank Substation Alternative when compared to the proposed project:
  - A slight reduction in visual impacts (Impact AE-1)
  - A negligibly lower reduction in impacts to undiscovered cultural resources (Impact CR-2)
  - A slight reduction in erosion impacts (Impact GEO-5)
  - Similar impacts to greenhouse gases (Impact GHG-1), as explained in response to comment D1-18

- Slightly reduced potential for water quality impacts (Impacts HY-1 and HY-3) and impacts on drainage patterns (Impact HY-4)
- Slightly reduced use of groundwater (Impact HY-2)
- No impact on land use (Impact LU-1)
- Similar impacts to construction noise (Impact NV-4), as explained in response to comment D2-221
- Substantially the same impacts to population and housing (Impact POP-1)
- Substantially the same impacts to public services, and a reduction in water use by 20 percent (Impact PSU-5)
- Substantially the same impacts to recreation (Impact RE-1)

See response to comment D1-20 regarding impacts to biological resources, response to comment D1-21 regarding impacts to traffic and transportation, and response to comment D1-22 regarding impacts to hazards.

D1-20 As the comment indicates, the One-Transformer-Bank Substation Alternative and the proposed Project would impact coastal California gnatcatcher habitat. However, compared with the proposed Project, the One-Transformer-Bank Substation Alternative would avoid impacts to approximately 9.5 acres of habitat, much of which has been identified as important coastal California gnatcatcher habitat by the United States Fish and Wildlife Service (USFWS) (Medak pers. comm. 2015; and see p. 4.3-4 of the Draft EIR "Agency Consultation"). Figure 5: Map 1 of 5 of the Draft EIR's Appendix D shows one nest and multiple observations of coastal California gnatcatcher, as well as observations of yellow warbler, loggerhead shrike, and peregrine falcon, all specialstatus species, within the 9.5 acres that would be avoided by the One-Transformer-Bank Substation Alternative. The EIR has been modified to include additional details about the importance of this habitat.

> The comment claims that the Draft EIR's analysis of biological impacts for the One-Transformer-Bank Substation Alternative is flawed. SCE claims that the approximate area avoided under this alternative is not high quality coastal California gnatcatcher habitat because it is "ruderal with exotic non-native plant species;" that there has been no documentation of successful gnatcatcher nesting in the area that would be avoided, based on four years of data; and therefore, that this alternative would not substantially lessen biological impacts.

The Draft EIR uses an appropriate method to identify much of the non-native vegetation southeast of the Mesa Substation as suitable habitat for coastal California gnatcatcher. The Draft EIR uses the same definition of gnatcatcher habitat as the Biological Resources Technical Report (Appendix D of the Draft EIR) does for gnatcatcher. Suitable gnatcatcher habitat is considered to be:

- Coastal sage scrub with greater than 50 percent cover, consisting of species such as California sagebrush and or California buckwheat, or
- Areas consisting of a matrix of sparse, scattered coastal sage scrub shrubs and

annual/biennial vegetation with sufficient morphological structure and density to support coastal California gnatcatcher nesting and provide foraging opportunities.

As shown in the Draft EIR's Figure 5: Map 1 of 5 of Appendix D, coastal California gnatcatcher has been observed numerous times over multiple years foraging and nesting in native and non-native vegetation (see Figure 4.3.1 of the Draft EIR for vegetation mapping) in the project area, including within the area that would be avoided by the One-Transformer-Bank Substation Alternative in the Mesa Substation area. Figure 10: Map 1 of 3 of the Draft EIR's Appendix D outlines gnatcatcher habitat southeast of the existing substation; approximately 9.5 acres of the gnatcatcher habitat identified in this figure would be avoided under the One-Transformer Alternative. This figure also shows expected temporary and permanent impacts of the proposed project on this habitat. Suitable gnatcatcher habitat for this map was identified using the criteria in the two bullet points above, and appropriately includes both native and nonnative vegetation (see Figure 4.3-1 of the Draft EIR). Table 11 of Appendix D of the Draft EIR calculates that the proposed project would impact approximately 23.45 acres of coastal California gnatcatcher habitat; the One-Transformer Alternative would avoid impacts to approximately 9.5 of those acres. Both the suitability of the non-native vegetation for gnatcatchers in the area, and the reduction in habitat area impacted under the One-Transformer Alternative are based on substantial evidence.

The comment states that no successful gnatcatcher nesting has occurred within the habitat avoided and considers this as evidence that the habitat is not quality habitat for the gnatcatcher and thus the One-Transformer-Bank Substation Alternative would not substantially lessen biological impacts. However, nesting attempts have been documented within the 9.5 acres identified as habitat (see Figure 5: Map 1 of 5 of the Draft EIR's Appendix D). In addition, successful nesting has been documented to occur adjacent to the area avoided and gnatcatchers appear to be utilizing the area that is contiguous with their successful nesting habitat for foraging during nesting season (see Figure 5: Map 1 of 5 of the Draft EIR's Appendix D). Figure 3A of Attachment A of the Draft EIR's Appendix G).

USFWS commented that the remaining gnatcatcher habitat in the project area, which includes the habitat avoided by this alternative, provides connectivity between gnatcatcher populations and is important for maintaining a viable population in the northern range of the species (Medak pers. comm. 2015). In addition, USFWS's comment on the Draft EIR acknowledges that the area adjacent to the Mesa Substation is gnatcatcher habitat, including the non-native vegetation that supports gnatcatcher foraging/sheltering, and recommended an increase in mitigation ratio for all gnatcatcher habitat permanently impacted by the project (see comment A1-3). In these comments, USFWS does not discount non-native vegetation that supports gnatcatchers nor suggest less mitigation. Based on this substantial evidence regarding the importance of the area avoided by this alternative for the gnatcatcher, the One-Transformer-Bank Substation Alternative would substantially lessen impacts on this species.

Figure 5: Map 1 of 5 of Appendix D also shows one least Bell's vireo sighting to the east of the existing substation site, in the 500-kV transmission corridor. Page 5-10 of the

Draft EIR listed least Bell's vireo as one of the special-status species that has been found in the areas southeast or east of the current substation. The commenter is correct that the habitat to the southeast of the substation, which includes the 11.6 acres avoided by the One-Transformer-Bank Substation Alternative, is not known least Bell's vireo habitat. However, the 11.6 acres contains habitat similar to the location where the vireo was observed (developed area with interspersed non-native vegetation) and is less than 0.25 mile away. Thus, the species could potentially utilize vegetation for foraging, cover, or resting within the avoided area. The EIR's conclusion that the One-Transformer-Bank Substation Alternative would substantially reduce biological resources impacts when compared to the proposed project is therefore supported by substantial evidence and expert analysis.

The comment also indicates coastal sage scrub would be impacted under the One-Transformer-Bank Substation Alternative. Approximately 0.16 acres of coastal sage scrub occurs on the Mesa Substation site that would be temporarily impacted under the proposed project and also under all of the evaluated alternatives (see Table 4.3-5 of the Draft EIR); this area of coastal sage scrub is not located within the approximately 11.6 acres in this area would be avoided under the One-Transformer Alternative (see Figure 4.3.1 of the Draft EIR for vegetation mapping). The comment does not identify locations where grading for the 220-kV and 66-kV tower pads, general grading/soil transfer, or drainage installation would occur, and does not offer evidence to show that these activities would have to occur in the approximately 11.6 acres this alternative would avoid in the area.

The following revision has been made to the EIR.

### Page 5-10:

Construction of the One-Transformer-Bank Substation Alternative would result in reduced impacts on biological resources compared to the proposed project. <u>California c</u>Coastal <u>California</u> gnatcatcher, least Bell's vireo, loggerhead shrike, peregrine falcon, Swainson's hawk, and yellow warbler have been sighted in the areas southeast and east of the current substation; <u>California</u> coastal <u>California</u> gnatcatcher is known to <u>forage and</u> nest in the area southeast of the current substation. Under the One-Transformer-Bank Substation Alternative, about 11.6 acres of habitat <u>southeast of the existing substation</u> would be avoided compared to the proposed projects. This habitat is also the higher-value habitat on the <u>substation site because specialSpecial</u>-status bird species (including nesting <u>and foraging coastal</u> California-coastal gnatcatcher) <del>are known to occurhave been</del> documented within the 11.6 acres that would be avoided by this alternative in this <u>area</u>within this habitat (Figure 5: Map 1 of 5, Appendix D of the Draft EIR).

Approximately 9.5 acres that would be avoided under the One-Transformer-Bank Substation Alternative has been identified as coastal California gnatcatcher habitat. Figure 5: Map 1 of 5 of the Draft EIR's Appendix D shows numerous occurrences of coastal California gnatcatcher within the avoided area, and Figure 10: Map 1 of 3 of the Draft EIR's Appendix D classifies approximately 9.5 acres of the 11.6 acres that would be avoided as gnatcatcher habitat. The area that would be avoided is classified primarily as non-native vegetation (Figure 4.3-1 of the Draft EIR); however, both native and non-native vegetation in the Mesa Substation area are considered gnatcatcher habitat (Figure 10: Map 1 of 3 of the Draft EIR's Appendix D). The USFWS (Medak pers. comm. 2015) expressed that the vegetation utilized by the coastal California gnatcatcher southeast of the substation, including much of the area that would be avoided by this alternative, is some of the only remaining habitat for the gnatcatcher between the Montebello Hills and the northernmost populations in the San Gabriel and Santa Susana Mountains, and thus helps to provide connectivity between gnatcatcher populations. The USFWS stated that this connectivity is "important for maintaining a viable population within the northern range of the species" and critical for achieving resiliency in response to environmental change (Medak pers. comm. 2015). Furthermore, the six black walnut trees that would be removed as part of the proposed project could be retained under this alternative. Impacts to avian and special-status species and habitat (Impact BR-1 and Impact BR-4) would be substantially reduced under the One-Transformer-Bank Substation Alternative compared to those associated with the proposed project.

D1-21 SCE asserts that the One-Transformer-Bank Substation Alternative would result in increases in the total truck trips because additional soil imports would be needed to the site.

As explained in response to comment D1-18, it is a reasonable assumption that more soil would need to be imported under the One-Transformer-Bank Substation Alternative when the area is excluded from the project footprint. The One-Transformer-Bank Substation Alternative would therefore increase traffic trips by about 5,000 total truck trips from Phase 1 to Phase 3. SCE states that soil can be moved within the site 10 times faster than it can be imported, so the project construction timeline would extend about 6 months longer than the proposed project due to the additional soil import. The following revision has been made to the analysis:

### Page 5-13 to 5-14:

#### **Traffic and Transportation**

Construction of the One-Transformer-Bank Substation Alternative would result in reduced increased total vehicle trips during construction., though the maximum daily vehicle trips would most likely remain the same as under the proposed project. The reduced substation size would result in a shorter construction period and less grading, resulting in fewer soil import and export trips, The One-Transformer-Bank Substation Alternative would exclude from the disturbance area the Phase 3 area shown in Figure 2-4, which, under the proposed project was to provide some of the fill required at the substation site. Without this fill available, SCE estimates that an additional 5,000 truck trips will be needed during construction, in total, to import soil to the site. but it is assumed that daily construction activities would not change in intensity. Thus, daily vehicle trips would be about the same under this alternative compared to the proposed project. However, the reduced construction period at the substation under the One-Transformer-Bank Substation Alternative would result in a net overall substantial decrease in traffic and transportation impacts (Impact TT-1 and Impact TT-2). The increased needs for soil import would prolong the construction period by about 6

months, as import of soil is more time consuming than transferring soil within the project area. It is assumed that the additional time would be allocated to the 18-month-long Phase I of construction because it is when general grading would occur. An additional 5,000 trips over 24 months of Phase I construction would equate to an average of approximately 11 truck trips per day. Applying a passenger car equivalent (PCE) of 2, this equates to 22 one-way PCE trips per day for 24 months. Given that Phase I would have a maximum of 2,144 PCE daily trips for the proposed project, there would be an increase of about 1 percent in trips under the One-Transformer-Bank Substation Alternative. This would represent a slight increase in traffic impacts, which would not affect the analysis or conclusions in the Draft EIR.

All other impacts related to traffic and transportation under this alternative would be the same as those associated with the proposed project.

### Page 5-9:

For consistency with this change in the analysis, the following revisions have also been made to the EIR:

### Page ES-37, Table ES-3:

• **Traffic and Transportation:** Substantially decreases total trips needed and duration of traffic impacts (Impact TT-1, Impact TT-2).

### Page 3-10:

- **Biological Resources:** Gnatcatcher habitat and species impacts would be reduced since less activity would take place in gnatcatcher habitat (reduces Impacts BR-1, BR-2, and BR-4).
- **Traffic and Transportation:** With less equipment to deliver to the site and less grading (soil import and export), less traffic would be generated and traffic impacts would be reduced (reduces Impacts TT-1 and TT-2).

### Page 3-5:

D1-22 SCE's assertion that a spill of transformer oil would be limited to the oil contained in one transformer is reasonable. It is unlikely that all three transformers included in the proposed project would leak at the same time. The Draft EIR has been revised as follows to reflect the potential for a spill of hazardous oil from the transformer under the One-Transformer-Bank Substation Alternative and that a spill of transformer oil would only reasonably involve oil from one transformer:

### Page 5-11:

#### **Hazards and Hazardous Materials**

Overall risk of hazards would be reduced under the One-Transformer-Bank Substation Alternative compared to the proposed projects. Under this alternative, the substation footprint would be <u>11.6</u> <u>14.4</u> acres smaller than under the proposed projects. The alternative would involve less ground disturbance, which means that slightly fewer hazardous materials overall would be used, transported, and disposed of; there would be slightly less chance of an accident (Impact HZ-1); and there would be slightly reduced potential for encountering contaminated soils (Impact HZ-2 and Impact HZ-4). Under this alternative, two groundwater wells slated to be decommissioned under the proposed project (wells OI-07C and OI-07B) would be retained; therefore, the potential for contamination of groundwater or soils via improper well abandonment (Impact HZ-2) would be slightly reduced under the One-Transformer-Bank Substation Alternative.

During operations, there would be only one transformer bank on site. The proposed project would result in an increase of 166,000 gallons of transformer oil being used on site for the 500-kV portion of the new substation, distributed among three transformer banks. Under the One-Transformer-Bank Substation Alternative, there may be more or the same amount of oil in any given transformer compared to the proposed project, depending on the manufacturer of the 1600-MVA transformer bank. Therefore, a potential spill under this alternative could release more or the same amount of oil than a potential spill involving one of the transformers under the proposed project. A spill is highly unlikely. Impacts during operation and maintenance may therefore be the same or negligibly greater than the proposed project. With only one 1600-MVA transformer, about one-third of the transformer oil (about 55,000 gallons) would be needed under this alternative than under the proposed project. Thus, there would be less oil stored on site under the One-Transformer-Bank Substation Alternative than under the proposed project, substantially reducing associated potential hazards (Impact HZ-1). On balance, the slight reduction in hazards during construction and negligibly greater or similar impacts during operation and maintenance would result in a slight overall decrease in hazards impacts under the One-Transformer-Bank Substation Alternative.

All other impacts related to hazards and hazardous materials under this alternative would be the same as those associated with the proposed projects.

The following revisions were made to the EIR for consistency with the changes made above:

### Page ES-27, Table ES-3 (One-Transformer-Bank Substation Alternative and Two-Transformer-Bank Substation Alternative):

• **Hazards and Hazardous Materials:** Slightly reduces risk of contamination of groundwater or soils from groundwater well abandonment. Slightly reduces chance of an accident and of encountering contaminated soils<del>. Substantially reduces hazards associated with transformers on the substation site</del> (Impact HZ-1, Impact HZ-2, Impact HZ-4).

### Page 5-17:

#### **Hazards and Hazardous Materials**

Overall risk of hazards would be reduced under the Two-Transformer-Bank Substation Alternative compared to the proposed project. Under this alternative, the substation footprint would be 8.3 <u>11</u> acres smaller than that associated with the proposed project. The alternative would involve less ground disturbance, which means that slightly fewer hazardous materials overall would be used, transported, and disposed of; there would be slightly less of a chance of an accident (Impact HZ-1); and there would be slightly reduced potential for encountering contaminated soils (Impact HZ-2 and Impact HZ-4).

During operations, there would be only two transformer banks on site. The proposed project would result in an increase of 166,000 gallons of transformer oil being used on site for the 500-kV portion of the new substation. With only two 1120-MVA transformers, about two-thirds of the transformer oil (about 110,000 gallons) would be needed under this alternative than under the proposed project. Thus, there would be less oil stored on site under the Two-Transformer-Bank Substation Alternative than under the proposed project. However, the same amount of oil would be used in each transformer, leaving the potential size of spill the same as the proposed project. Impacts (Impact HZ-1) would be similar to the proposed project, substantially reducing associated potential hazards (Impact HZ-1).

All other impacts related to hazards and hazardous materials under this alternative would be the same as those associated with the proposed project.

D1-23 As stated in CEQA Guidelines section 15126.6(a), "[t]he lead agency is responsible for selecting a range of project alternatives for examination ...." SCE is not responsible for selecting the range of alternatives or designing the alternatives. Alternatives considered in an EIR must be potentially feasible, avoid or substantially lessen any significant effect of the proposed project, and meet most of the basic project objectives. In this comment, SCE states it has modified the alternative by opening the tie breaker, which had been modeled as closed for the alternative. This modification therefore results in a configuration that is different than the alternative designed by the CPUC. SCE's comments are not pertinent as to whether the CPUC-defined Two-Transformer-Bank Substation Alternative meets the CPUC's project objectives.

SCE further states that with the tie breaker open, one of the 500/220-kV transformer banks would reach its normal rating of 1120 MVA. However, this is not a violation of reliability standards. SCE then claims that "a slight modification in the renewable generation dispatch assumption or generation capacity in the Western LA Basin would cause an overload condition" and that this alternative would not meet Objective 1. However, the CPUC believes that this alternative would meet all of the basic project objectives and "would address all violations except the violation resulting from the N-1-1 contingency involving an initial outage of the Chino–Mira Loma 220-kV No. 1 Transmission Line followed by an outage of the Chino–Mira Loma 220-kV No. 2 Transmission Line, which would result in a thermal overload on the Chino–Mira Loma 220-kV No. 3 Transmission Line." The Draft EIR also clarifies that "[i]mplementing the RAS in addition to building the two-transformer bank substation would address the thermal overload of the Chino–Mira Loma 220-kV No. 3 Transmission Line. All violations would be addressed under this alternative, and the alternative would therefore meet Objective 1."

The CPUC has found that the Two-Transformer-Bank Substation Alternative, as designed by CPUC, meets the requirements for alternatives under CEQA. As discussed in more detail above, the alternative would address all violations listed in EIR Appendix B, would not create additional violations, and would maintain electrical service by minimizing service interruptions during project implementation.

SCE asserts that there would be "excessive short circuit duty values on the switchrack"; however, this statement is unsupported by evidence (e.g., a short circuit duty value, threshold where values become excessive). Furthermore, it is possible that a fault reduction scheme may be needed. Methods could include opening a high-speed circuit breaker on the transformer or bus tie before opening a 220-kV line position for a fault on one of the 220-kV lines. Once the fault is cleared, the transformer or tie breaker could be automatically reclosed.

- D1-24 Refer to response to comment D1-13, which explains the relation of the OTC compliance date to the CPUC's CEQA project objectives. Although it is reasonable to assume that SCE will need a redesign for the Two-Transformer-Bank Substation Alternative and implementing such an alternative would take longer than implementing the proposed project, SCE's claims are not evidence that the Two-Transformer-Bank Substation Alternative does not meet Project Objective 1.
- D1-25 As described in response to comment D1-11, establishing project objectives is within the discretion of the Lead Agency.

The CPUC's consideration of SCE's objectives is discussed in Section 1.2.2.2, "Consideration of SCE's Objectives." Whether the Two-Transformer-Bank Substation Alternative meets SCE's objectives is irrelevant to whether the alternative meets most of the basic *CPUC objectives* and can, therefore, be brought forward for further analysis in the EIR.

SCE asserts that the Draft EIR incorrectly states that "[i]n the event that one transformer bank failed, the other transformer bank would automatically go out of

service. If both transformers were taken out of service due to failure of one transformer bank, there would not be an outage. Instead, the grid would operate as if the substation was not in place." However, the Draft EIR is correct because in the case that both 500/220-kV transformers were out of service, the 220-kV lines connected to the 220/66-kV transformers and 66/16-kV transformers would continue to serve load as if the current 220/66/16-kV substation were in service.

SCE also asserts that if the grid operated as if the substation were not in place, violations of NERC TPL-001-4 would occur. However, their assertions involve contingencies with three outages. Study of a third outage in a contingency scenario is not required under NERC TPL-001-4. SCE inaccurately compares a scenario involving outages of the transformers at the Two-Transformer Bank Substation Alternative to the No Project Alternative. The No Project Alternative represents an N-0 (no outages) contingency. In the case of the No Project Alternative, two additional outages would result in an N-1-1 or N-2 contingency, which must be studied under NERC, WECC, and CAISO standards. These contingencies would result in violations of reliability standards under the No Project Alternative, as explained in the EIR.

In contrast to the No Project Alternative, an outage of both transformers at the Two-Transformer-Bank Substation Alternative would be representative of an N-1-1 or N-2 contingency. An additional, unrelated outage somewhere else in the system would be representative of an N-1-1-1 or an N-3 contingency. There is no requirement to study the results of an N-1-1-1 or N-3 scenario for transmission planning under NERC, WECC, or CAISO standards. Therefore, any ill effects of an N-1-1-1 or N-3 contingency are not considered violations of reliability standards and would not impact whether this alternative meets Objective 2.

In the case of an N-1-1 or N-2 contingency involving the two transformers at the Two-Transformer-Bank Substation Alternative, the grid would operate as it would in "base case" contingency without the Mesa Substation, as shown in rows 84, 85, and 86 of Appendix B of the EIR. In these three scenarios, without the Mesa Substation, voltage levels would be above the minimum emergency voltage of 0.90 per unit allowed per Table 1 of the CAISO Planning Standards (CAISO 2015). Therefore, there would be no violations or outages and no impacts related to whether this alternative satisfies Objective 2 would occur.

D1-26 SCE's comment references its comments regarding the One-Transformer-Bank Substation Alternative and states that their comments similarly apply to the Two-Transformer-Bank Substation Alternative, but that the potential reduction of impacts is less under the Two-Transformer-Bank Substation Alternative. Therefore, each area addressed for the One-Transformer-Bank Substation Alternative is also addressed for this comment.

SCE asserts that the Two-Transformer-Bank Substation Alternative would result in increases in the total exhaust emissions because additional soil imports would be needed on site. The area excluded from the disturbance area under the Two-Transformer-Bank Substation Alternative was to be used for fill material for other parts of the substation site. SCE claims that, without the soil from this area, additional soil would have to be imported, increasing the number of truck trips needed for Phase

1 and Phase 3. Given SCE's claims that 5,000 additional total trips would occur under the One-Transformer-Bank Substation Alternative, which disturbs 11.6 acres less in the Phase 3 area than the proposed project, it is presumed that the Two-Transformer-Bank Substation Alternative would require an additional 3,575 trips because it would disturb 8.3 acres less in the Phase 3 area than the proposed project. SCE claims that the One-Transformer Bank Substation Alternative would result in a 6-month longer timeframe than the proposed project; therefore, the Two-Transformer Bank Substation Alternative would result in about a 4.5-month longer construction timeline than the proposed project due to the additional soil import.

The area in Phase 3 as shown on Figure 2-7 is topographically higher, making it a reasonable assumption that more soil would need to be imported under the Two-Transformer-Bank Substation Alternative when the area is excluded from the project footprint. The Two-Transformer-Bank Substation Alternative would slightly increase total exhaust emissions but would still substantially decrease fugitive dust created when compared to the proposed project. On balance, there would be a moderate reduction in air quality impacts. Thus, the Two-Transformer Bank Substation remains ranked as second in environmental superiority for Air Quality. The following revision has been made to the analysis to reflect this and to update acreages changes based on revised GIS submitted by the applicant:

#### Page ES-27 Table ES-3:

• **Air Quality:** Substantially reduces total exhaust emissions as well as fugitive dust emissions from ground disturbance (Impact AQ-2, Impact AQ-3).

### Page 5-15:

### Air Quality

Construction of the Two-Transformer-Bank Substation Alternative would result in total reduced increased air quality exhaust emissions impacts over the construction period, but reduced fugitive dust emissions. though the maximum daily emissions during construction would remain the same as under the proposed project. While the reduced substation size would require result in less import of materials for building the substation itself, a shorter construction period and less ground disturbance, but construction of the Two-Transformer- Bank Substation Alternative would also exclude from the disturbance area much of the Phase 3 area shown in Figure 2-4. Under the proposed project, this area was to provide some of the fill required at the substation site. Without this fill available, an estimated additional 3,575 truck trips would be needed, in total, to import soil to the site. The additional total trips would increase overall exhaust emissions, and would slightly increase the maximum number of trips per day when compared to the proposed project. it is assumed that daily construction activities would not change in intensity. It is assumed that soil import would be needed during Phase I, since that is when grading would take place, which would be approximately 18 months long for the proposed project. With an additional 4.5 months needed for soil transport, Phase I would be 22.5 months long. An additional 3,575 trips over an additional 4.5 months of construction equates to an average of approximately 8 truck trips per day, or 16 PCE trips, on each day of construction. Given that Phase I would have a

<u>maximum of 2,144 PCE daily trips, an increase in trips and exhaust emissions of</u> <u>less than 1 percent would result in a negligible increase in maximum daily exhaust</u> <u>emissions.</u> Thus, daily <u>maximum</u> criteria pollutant emissions would be <del>about the</del> <u>same negligibly increased</u> under the Two-Transformer-Bank Substation Alternative compared to the proposed project. <del>However, the reduced construction</del> <del>period at the substation would result in a net overall substantial decrease in total</del> <u>exhaust emissions (Impact AQ-2 and Impact AQ-3)</u>. The reduced disturbance area (about 11 acres less than the proposed project) would substantially reduce fugitive dust emissions from ground disturbance (Impact AQ-2 and Impacts.)

### Page 5-16:

#### **Greenhouse Gas Emissions**

Overall greenhouse gas emissions from construction of the Two-Transformer-Bank Substation Alternative would be reduced compared to greater than the proposed project. The smaller substation footprint would require additional soil import due to the reduced availability of on-site soil, as described under Air Quality, which would require more translate into less grading and therefore less heavy equipment use and fewer truck trips to import and export soil. Less grading would be required on site, which would reduce heavy equipment on site. On balance, impacts would be similar to those of the proposed project, resulting in slightly reduced greenhouse gas emissions (Impact GHG-1) during construction.

All other construction impacts related to greenhouse gases under this alternative would be the same as those associated with the proposed project. Operationsrelated greenhouse gas emissions would be the same as under the proposed projects, since operations and maintenance activities would be about the same as those performed for the proposed project.

#### **Population and Housing**

It is presumed that the same maximum number of employees would be needed during construction of this alternative as the proposed project. The duration of need for workers would, however, be shorter about 4.5 months longer than for the proposed project, as discussed under Air Quality. This could result in a negligible reduction of increase in the potential for temporary population growth in the area, compared to the proposed project, should construction workers relocate to the area. The impacts of this alternative and the proposed project would be

substantially the same.

All other impacts related to population and housing would be the same as those associated with the proposed project.

#### Page 5-18:

#### **Public Services and Utilities**

The Two-Transformer-Bank Substation Alternative would have a negligibly <u>increased reduced</u> potential for need for public services due to hazardous materials spills, fire, theft, and vandalism, as well as lower production of wastewater and storm\_water as a function of the <u>longer shorter</u> construction period at the substation site, <u>as discussed previously under Air Quality</u>.<del>and the</del> <del>reduced construction activity and substation footprint compared to the proposed</del> <del>project.</del> <u>Impacts would be substantially the same as the proposed project</u>.

The smaller disturbance area associated with the Two-Transformer-Bank Substation Alternative would require less water for dust control during construction than the proposed project. This alternative would reduce ground disturbance by about <del>12</del> <u>15</u> percent, which may also reduce water use for dust control (Impact PSU-5) at the substation by <del>12</del> <u>15</u> percent.

All other impacts related to public services and utilities would be the same as those associated with the proposed project.

#### Page 5-19:

#### Recreation

It is presumed that the same maximum number of employees would be needed during construction of this alternative as for the proposed project. The duration of need for workers would, however, be slightly <u>longer shorter</u>-than for the proposed project, <u>as previously discussed under Air Quality</u>, resulting in a small potential <u>increase decrease</u> in the time that workers may need to relocate to the area. Thus, any increased use in recreational facilities due to temporary relocation of construction workers to the area could be negligibly <u>increased reduced</u> under the Two-Transformer-Bank Substation Alternative compared to the proposed project. The impacts of this alternative and the proposed project would be substantially the same.

All other impacts related to recreation under this alternative would be the same as those associated with the proposed project.

#### Page 3-13:

#### Potential to Substantially Reduce or Avoid Significant Impacts

This alternative would substantially reduce <u>the following several</u> significant impact<del>s, including</del>:

- Air Quality: Criteria pollutant emissions during construction would be reduced since less ground disturbance and less grading would be required to accommodate the smaller substation footprint (reduces Impacts AQ-2, AQ-3, and AQ-4).
- **Biological Resources:** Gnatcatcher habitat and species impacts would be reduced since less activity would take place in gnatcatcher habitat (reduces Impacts BR-1, BR-2, and BR-4).

SCE disagrees with the comparative analysis of biological resources impacts. However, compared with the proposed project, the Two-Transformer-Bank Substation Alternative would avoid impacts to approximately 8.3 acres of habitat, much of which has been identified as important coastal California gnatcatcher habitat by the USFWS (Medak pers. comm. 2015; see p. 4.3-4 of the Draft EIR "Agency Consultation"). Figure 5: Map 1 of 5 of the Draft EIR's Appendix D shows multiple observations of coastal California gnatcatcher as well as observations of yellow warbler, loggerhead shrike, and peregrine falcon, all special-status species, within the approximately 8.3 acres southeast of the existing substation that would be avoided by the Two-Transformer-Bank Substation Alternative (see response to comment D1-20 for additional details about the classification of gnatcatcher habitat in the EIR). The EIR's conclusion that the Two-Transformer-Bank Alternative would substantially reduce biological resources impacts when compared to the proposed project is therefore supported by substantial evidence and expert analysis. The EIR has been modified to include additional details about the importance of this habitat:

### Pages 5-15 through 5-16:

Construction of the Two-Transformer-Bank Substation Alternative would result in reduced impacts on biological resources compared to the proposed project. <u>California cCoastal California gnatcatcher</u>, least Bell's vireo, loggerhead shrike, peregrine falcon, Swainson's hawk, and yellow warbler have been sighted in the areas southeast and east of the current substation; <u>California coastal California</u> gnatcatcher is known to <u>forage and</u> nest in the area southeast of the current substation. Under the Two-Transformer-Bank Substation Alternative, approximately 8.3 acres of habitat <u>southeast of the existing substation</u> would be avoided compared to the proposed project. This habitat is higher-value habitat on the substation site because special<u>Special</u>-status bird species (including <u>nestingforaging coastal California coastal</u> gnatcatcher) are known to occur have been documented within the approximately 8.3 acres that would be avoided within this habitat (Figure 5: Map 1 of 5, Appendix D of the Draft EIR).

<u>Approximately 6.5 acres of the 8.3 acres that would be avoided under the Two-</u> <u>Transformer-Bank Substation Alternative has been identified as coastal California</u> gnatcatcher habitat. Figure 5: Map 1 of 5 of the Draft EIR's Appendix D shows numerous occurrences of coastal California gnatcatcher within the avoided area, and Figure 10: Map 1 of 3 of the Draft EIR's Appendix D classifies approximately 6.5 acres that would be avoided as gnatcatcher habitat. The area that would be avoided is classified primarily as non-native vegetation (Figure 4.3-1 of the Draft EIR); however, both native and non-native vegetation in the Mesa Substation area are considered gnatcatcher habitat (Figure 10: Map 1 of 3 of the Draft EIR's Appendix D). The USFWS (Medak pers. comm. 2015) expressed that the vegetation utilized by the coastal California gnatcatcher southeast of the substation, including much of the area that would be avoided by this alternative, is some of the only remaining habitat for the gnatcatcher between the Montebello Hills and the northernmost populations in the San Gabriel and Santa Susana Mountains, and thus helps to provide connectivity between gnatcatcher populations. The USFWS stated that this connectivity is "important for maintaining a viable population within the northern range of the species" and critical for achieving resiliency in response to environmental change (Medak pers. comm. 2015). Furthermore, the six black walnut trees that would be removed as part of the proposed project could be retained under this alternative. Impacts on avian and special-status species and habitat (Impact BR-1 and Impact BR-4) would be substantially reduced under the Two-Transformer-Bank Substation Alternative compared to the proposed project.

SCE asserts that the Two-Transformer-Bank Substation Alternative would result in increases in the total truck trips because additional soil imports would be needed to the site. As explained previously in this response, it is a reasonable assumption that more soil would need to be imported under the Two-Transformer-Bank Substation Alternative when the area is excluded from the project footprint. The Two-Transformer-Bank Substation Alternative would therefore increase traffic trips by about 3,575 total truck trips from Phase 1 to Phase 3. SCE claims that soil can be moved within the site 10 times faster than it can be imported, so the project construction timeline would extend about 4.5 months longer than the proposed project. The following revision has been made to the analysis:

Page ES-27, Table ES-3:

• **Traffic and Transportation:** Substantially decreases total trips needed and duration of traffic impacts (Impact TT-1, Impact TT-2).

### Page 5-19:

#### **Transportation and Traffic**

Construction of the Two-Transformer-Bank Substation Alternative would result in <u>increased</u> total <del>reduced</del> vehicle trips <u>during construction</u>. though the maximum daily vehicle trips would most likely remain the same as for the proposed project. The reduced substation size would result in a shorter construction period and less grading, resulting in fewer soil import and export trips, <u>The Two-</u> Transformer Bank Substation Alternative would exclude from the disturbance area much of the Phase 3 area shown in Figure 2-4, which, under the proposed project, was to provide some of the fill required at the substation site. Without this fill available, it is estimated that an additional 3,575 truck trips would be needed

during construction, in total, to import soil to the site. but it is assumed that daily construction activities would not change in intensity. Thus, daily vehicle trips would be about the same under this alternative compared to the proposed project. However, the reduced construction period at the substation under the Two-Transformer-Bank Substation Alternative would result in an overall substantial decrease in traffic impacts (Impact TT-1 and Impact TT-2). The increased need for soil import would prolong the construction period by about 4.5 months, as import of soil is more time consuming than transferring soil within the project area. It is assumed that the additional time would be allocated to the 18-month long Phase I of construction because that is when general grading of the site would take place. An additional 3,575 trips over an additional 4.5 months of construction of Phase I equates to an average of approximately 8 truck trips per day. Applying a passenger car equivalent (PCE) of 2, this equates to 16 one-way PCE trips per day for 4.5 months. Given that Phase I would have a maximum of 2,144 PCE daily trips, an increase in trips of less than 1 percent would result in a negligible increase in maximum daily trips.

All other impacts related to traffic and transportation under this alternative would be the same as those associated with the proposed project.

### Page 3-13:

- **Biological Resources:** Gnatcatcher habitat and species impacts would be reduced since less activity would take place in gnatcatcher habitat (reduces Impacts BR-1, BR-2, and BR-4).
- **Traffic and Transportation:** With less equipment to deliver to the site and less grading (soil import and export), less traffic would be generated and traffic impacts would be reduced (reduces Impacts TT-1 and TT-2).

SCE also asserts that the conclusion that the Two-Transformer Alternative is not environmentally superior because of incorrect conclusions about truck trips, air

quality impacts, and biological resources impacts. Revisions to analyses for those resources are addressed within this response. Revisions have been made to the environmentally superior alternative analysis in Section 5.4, "Environmentally Superior Alternative," to reflect the changes to the resource analyses, as shown in response to comment D1-18.

SCE notes that the extension of the project duration by more than 4.5 months could compromise the ability to complete the project by December 2020. As described in detail in response to comment D1-13, implementing the project by December 2020 is not an objective of the project.

- D1-27 It is reasonable to assume that SCE has not been designing a GIS substation and it would take a longer amount of time to implement a GIS Substation Alternative than to implement the proposed project. The environmental impacts from this alternative have been adequately examined in Chapter 5 of the Draft EIR. Please also refer to response to comment D1-13, which explains the relation of the OTC compliance date to the CPUC's CEQA project objectives. The CPUC will consider the CAISO's comments regarding the Gas Insulated Substation Alternative when making their final decision on the proposed Project and the feasibility of alternatives.
- D1-28 SCE's comment references its comments regarding the One-Transformer-Bank Substation Alternative and states that their comments similarly apply to the Gas-Insulated Substation Alternative, but that it provides less potential to reduce impacts. Therefore, each area addressed for the One-Transformer-Bank Substation Alternative is also addressed for this comment.

SCE asserts that the Gas-Insulated Substation Alternative would result in increases in the total exhaust emissions because additional soil imports would be needed on site. The area excluded from the disturbance area under the Gas-Insulated Substation Alternative was to be used for fill material for other parts of the substation site. SCE claims that, without the soil from this area, additional soil would have to be imported, increasing the number of truck trips needed for Phase 1 and Phase 3. Given that SCE claims that 5,000 additional total trips would occur under the One-Transformer-Bank Substation Alternative, which disturbs 11.6 acres less in the Phase 3 area than the proposed project, it is presumed that the Gas-Insulated Substation Alternative would require an additional 3,150 trips because it would disturb 7.3 acres less in the Phase 3 area than the proposed project. SCE claims that the Gas-Insulated Substation Alternative would result in a 6-month longer timeframe than the proposed project; therefore, the Gas-Insulated Substation Alternative would result in a bout a 4-month longer construction timeline than the proposed project due to the additional soil import.

The area in Phase 3 as shown on Figure 2-7 is topographically higher, making it a reasonable assumption that more soil would need to be imported under the Gas-Insulated Substation Alternative when part of the Phase 3 area is excluded from the project footprint. The Gas-Insulated Substation Alternative would slightly increase total exhaust emissions but would substantially decrease fugitive dust created when compared to the proposed project. On balance, there would be a slight reduction in air quality impacts. Thus, the Gas Insulated Substation Alternative remains ranked as third

in environmental superiority for Air Quality. The following revision has been made to the analysis to reflect this information and to update acreage changes based on revised GIS submitted by the project applicant:

#### Page ES-38, Table ES-3:

• Air Quality: Substantially reduces total exhaust emissions as well as fugitive dust emissions from ground disturbance (Impact AQ-2, Impact AQ-3).

#### Page 5-20:

#### **Air Quality**

Construction of the Gas-Insulated Substation Alternative would result in reduced total increased air quality exhaust emissions impacts over the construction period, but reduced fugitive dust emissions. though the maximum daily emissions during construction would remain the same as for the proposed project. While the reduced substation size would require result in less import of materials for building the substation itself, a shorter construction period and less ground disturbance, but construction of the Gas-Insulated Substation Alternative would exclude from the disturbance area much of the Phase 3 area shown in Figure 2-4. Under the proposed project, this area was to provide some of the fill required at the substation site. Without this fill available, an additional 3,150 truck trips would be needed, in total, to import soil to the site. The additional trips would increase overall exhaust emissions, and would increase the maximum number of trips per day when compared to the proposed project. it is assumed that daily construction activities would not change in intensity. It is assumed that soil import would be needed during Phase I, when general grading would occur, which would be about 18 months long for the proposed project. With an additional 4 months needed for soil transport, Phase I would be 22 months long. An additional 3,150 trips over an additional 4 months of construction equates to an average of approximately 7 truck trips per day, or 14 PCE trips, on each day of construction. Given that Phase I would have a maximum of 2,144 PCE daily trips, an increase in trips and exhaust emissions of less than 1 percent would result in a negligible increase in maximum daily exhaust emissions. Thus, maximum daily criteria pollutant emissions would be negligibly higher under the Gas-Insulated Substation Alternative as for the proposed project. However, the reduced construction period at the substation would result in a net overall substantial decrease in exhaust emissions (Impact AQ- $\frac{2}{2}$  and Impact AO-3). The reduced disturbance area (about  $\frac{7}{2}$ -10 acres less than the proposed project) would substantially reduce fugitive dust emissions from ground disturbance (Impact AQ-2 and Impact AQ-3). Overall, there would be a moderate reduction in air quality impacts.

All other impacts related to air quality under this alternative would be the same as those associated with the proposed project.

Page 5-22:

#### **Greenhouse Gas Emissions**

The Gas-Insulated Substation Alternative would reduce <u>be greater than the</u> greenhouse gas emissions from construction compared to the proposed project. <u>Less grading and heavy equipment use would be required on site, which would</u> <u>reduce heavy equipment use on site. However, the The smaller substation footprint</u> would <u>require additional soil import due to the reduced availability of on-site soil,</u> <u>as described under Air Quality, which would require more translate into less</u> <u>grading and therefore less heavy equipment use and fewer</u> truck trips to import and export <u>soil.</u>, <u>resulting in On balance, impacts would be similar to those of the</u> <u>proposed project. slightly reduced greenhouse gas emissions (Impact GHG-1)</u> <del>during construction.</del> All other construction impacts related to greenhouse gases under this alternative would be the same as those associated with the proposed project.

#### Page 5-24:

#### **Population and Housing**

It is presumed that the same maximum number of employees would be needed during construction of this alternative as for the proposed project. The duration of need for workers would, however, be <u>shorter about 4 months longer</u> than for the proposed project, as discussed under Air Quality. This could result in a negligible <del>reduction of increase in</del> the potential for temporary population growth in the area, compared to the proposed project, should construction workers relocate to the area. The impacts of this alternative and those of the proposed project would be substantially the same.

#### Page 5-24:

#### **Public Services and Utilities**

The Gas-Insulated Substation Alternative would have a negligibly <u>increased</u> <del>reduced</del> potential for the need for public services due to hazardous materials spills, fire, theft, and vandalism, as well as lower production of wastewater and storm water as a function of the <u>longer shorter</u> construction period at the substation site, <u>as discussed previously under Air Quality</u>. <del>and the reduced construction activity</del> <del>and substation footprint compared to the proposed project</del>. <u>Impacts would be</u> <u>substantially the same as the proposed project</u>.

The smaller disturbance area associated with the Gas-Insulated Substation Alternative would require less water for dust control during construction than the proposed project. This alternative would reduce ground disturbance by about  $\frac{11}{14}$  percent, which may also reduce water use for dust construction at the substation by  $\frac{11}{14}$  percent.

All other impacts related to public services and utilities would be the same as for the proposed project.

#### Page 5-24:

#### Recreation

It is presumed the same maximum number of employees would be need during construction of this alternative as for the proposed project. The duration of need for workers would, however, be slightly <u>longer shorter</u> than for the proposed project, resulting in a small potential <u>increase decrease</u> in the time that workers may need to relocate to the area. Thus, any increased use in recreational facilities due to temporary relocation of construction workers to the area could be negligibly <u>increased reduced</u>-under the Gas-Insulated Substation Alternative compared to the proposed project. The impacts of this alternative and those of the proposed project would be substantially the same.

#### Page 3-14:

As a result of the decreased ground disturbance, this alternative would substantially reduce the following significant impacts of the proposed project:

- Air Quality: Less grading would be required, reducing heavy equipment emissions. Fewer truck trips for soil import and export, equipment delivery, and materials delivery would reduce exhaust emissions (reduces Impacts AQ-2, AQ-3, and AQ-4).
- **Biological Resources:** Gnatcatcher habitat and species impacts would be reduced since less activity would take place in gnatcatcher habitat due to the size reduction of the 500-kV switchrack (reduces Impacts BR-1, BR-2, and BR-4).

SCE disagrees with the comparative analysis of biological resources impacts. However, compared with the proposed project, the Gas-Insulated Substation Alternative would avoid impacts to approximately 7.3 acres of habitat southeast of the existing substation, much of which has been identified as important coastal California gnatcatcher habitat by the USFWS (Medak pers. comm. 2015; see p. 4.3-4 of the Draft EIR "Agency Consultation"). Figure 5: Map 1 of 5 of the Draft EIR's Appendix D shows one nest and multiple observations of coastal California gnatcatcher as well as observations of yellow warbler, loggerhead shrike, and peregrine falcon, all special-status species, within the 7.3 acres that would be avoided by the Gas-Insulated Substation Alternative (see response to comment D1-20 for additional details about the classification of gnatcatcher habitat in the EIR). The EIR's conclusion that the Gas-Insulated Substation Alternative would substantially reduce biological resources impacts when compared to the proposed project is therefore supported by facts and

expert analysis.

The EIR has been modified to include additional details about the importance of this habitat:

#### Pages 5-20 through 5-21:

Construction of the Gas-Insulated Substation Alternative would result in reduced impacts on biological resources compared to the proposed project. The reduced substation footprint would avoid biological resources that the proposed project would impact. <u>California cC</u>oastal <u>California</u> gnatcatcher, least Bell's vireo, loggerhead shrike, peregrine falcon, Swainson's hawk, and yellow warbler have been sighted in the areas southeast and east of the current substation; <u>California</u> coastal <u>California</u> gnatcatcher is known to <u>forage and</u> nest in the area southeast of the current substation. Under the Gas-Insulated Substation Alternative, about 7.3 <del>fewer</del> acres of habitat <u>southeast of the existing substation</u> would be avoided compared to the proposed project. This habitat is also part of the higher-value habitat on the substation site because many of specialSpecial-status bird species (including nesting <u>and foraging coastal</u> California-coastal gnatcatcher) <del>are known to occur within this habitat</del> have been documented within the approximately 7.3 acres (Figure 5: Map 1 of 5, Appendix D of the Draft EIR).

Approximately 4.2 acres of the 7.3 acres that would be avoided under the Gas-Insulated Substation Alternative has been identified as coastal California gnatcatcher habitat. Figure 5: Map 1 of 5 of the Draft EIR's Appendix D shows numerous occurrences of coastal California gnatcatcher within the area avoided, and Figure 10: Map 1 of 3 of the Draft EIR's Appendix D classifies approximately 4.2 acres that would be avoided as gnatcatcher habitat. The area that would be avoided is classified primarily as non-native vegetation (Figure 4.3-1 of the Draft EIR); however, both native and non-native vegetation in the Mesa Substation area are considered gnatcatcher habitat (Figure 10: Map 1 of 3 of the Draft EIR's Appendix D). The USFWS (Medak pers. comm. 2015) expressed that the vegetation utilized by the coastal California gnatcatcher southeast of the substation, including much of the area that would be avoided, is some of the only remaining habitat for the gnatcatcher between the Montebello Hills and the northernmost populations in the San Gabriel and Santa Susana Mountains, and thus helps to provide connectivity between gnatcatcher populations. The USFWS stated that this connectivity is "important for maintaining a viable population within the northern range of the species" and critical for achieving resiliency in response to environmental change (Medak pers. comm. 2015). Furthermore, three of the six black walnut trees on the substation site that would be removed as part of the proposed project could likely be retained under this alternative. Impacts to avian and special-status species and habitat (Impact BR-1 and Impact BR-4) would be substantially reduced under the Gas-Insulated Substation Alternative compared to the proposed project.

SCE asserts that the Two-Transformer-Bank Substation Alternative would result in increases in the total truck trips because additional soil imports would be needed to the site. As explained previously in this response, it is a reasonable assumption that

more soil would need to be imported under the Gas-Insulated Substation Alternative when the area is excluded from the project footprint. The Gas-Insulated Substation Alternative would therefore increase traffic trips by about 3,150 total truck trips from Phase 1 to Phase 3. SCE claims that soil can be moved within the site 10 times fast than it can be imported, so the project construction timeline would extend about 4 months longer than the proposed project. The following revision has been made to the analysis:

#### Page ES-28, Table ES-3:

• **Traffic and Transportation:** Substantially decreases total trips needed and duration of traffic impacts (Impact TT-1, Impact TT-2).

#### Page 5-25:

#### **Transportation and Traffic**

Construction of the Gas-Insulated Substation Alternative would result in total increased reduced vehicle trips, though the maximum daily vehicle trips would remain approximately the same as under the proposed project. The reduced substation size would result in a shorter construction period and less grading resulting in fewer soil import and export trips The Gas-Insulated Substation Alternative would exclude from the disturbance area much of the Phase 3 area shown in Figure 2-4, which, under the proposed project, was to provide some of the fill required at the substation site. Without this fill available, it is estimated that an additional 3,150 truck trips would be needed during construction, in total, to import soil to the site., but it is assumed that daily construction activities would not change in intensity. Thus, daily vehicle trips would be about the same under this alternative compared to the proposed project. However, the reduced construction period at the substation under the Gas-Insulated Substation Alternative would result in an overall substantial decrease in total traffic and transportation impacts (Impact TT-1 and Impact TT-2). An additional 3,150 trips over an additional 4 months of construction during Phase 1 equates to an average of approximately 7 truck trips per day. Applying a passenger car equivalent (PCE) of 2, this equates to 14 one-way PCE trips per day, on each day of construction. Given that Phase I would have a maximum of 2,144 PCE daily trips, an increase in trips and exhaust emissions of less than 1 percent would result in a negligible increase in maximum daily trips. The increase in trips associated with the Gas-Insulated Substation Alternative would slightly increase a significant impact of the proposed project, but the impact would be mitigated to less than significant with the same mitigation measures proposed to be implemented for the proposed project.

D1-29 SCE's assertion that the proposed project is not within any dam inundation area as shown on the City of Monterey Park's General Plan Figure SCS-4: Flood Inundation Areas: Garvey Reservoir and Laguna Basin is correct. The following corrections have been made to Section 4.8, "Hydrology and Water Quality," of the Draft EIR to reflect this information.

### Page 4.8-6:

Portions of the City of Monterey Park lie within the inundation area for the Garvey Reservoir; however, the Mesa Substation site is not within this area (City of Monterey Park 2001). The Mesa Substation site is in an inundation area for the Garvey Reservoir if the south dam fails. If the reservoir's south dam were to fail, fFlood depths would be 6 to 7 feet. From there, water would come up against State Route 601 and then eventually flow through freeway undercrossings (City of Monterey Park 2001). Staging Yard 5 and structure replacement in the City of Commerce are also in the Garvey Reservoir inundation zone, but farther from the reservoir itself. Floodwaters would reach the City within 15 minutes (City of Commerce 2008).

#### Page 4.8-26:

The Mesa Substation site, transmission lines, subtransmission lines, nearby telecommunications lines, and Staging Yards 1, 2 and 3 would be located within the inundation area of the Garvey Reservoir should the south dam fail. A failure of the Garvey Reservoir south dam is unlikely during construction. Although the proposed project would not exacerbate the existing flood conditions, a dam failure when workers are present, however, could result in significant impacts due to the close proximity of the dam. MM HY-5 would be implemented to require training on an evacuation route in the event of a dam failure. Impacts would be less than significant after mitigation.

#### Page 4.8-27:

However, if the Garvey Reservoir south dam fails, it would take about 15 <u>minutes</u> for flood waters to cover the work area. The flood waters would have traveled through State Route 60 underpasses, which should slow the water.

#### Page 4.8-27:

The Mesa Substation and nearby telecommunications, transmission, subtransmission, and distribution infrastructure would be located in the inundation area of the Garvey Reservoir. The total number of telecommunications, transmission, subtransmission, and distribution structures in the inundation zone would be reduced as a result of the proposed project. Thus, there would be no adverse impact related to structures in a dam inundation area with regards to transmission, subtransmission, and distribution structures. A dam failure is a very low probability event, given that repairs were conducted in 1999, and the proposed project would not exacerbate the existing conditions. However, impacts to the substation in the event of a dam failure could be catastrophic, including potentially widespread outages and severe damage to substation equipment. This would be a significant impact. MM HY-6 would be implemented to reduce dam inundation impacts. Impacts would be less than significant with mitigation.

#### Page 4.8-30:

<u>MM HY-6</u>: Dam Inundation Substation Protection. SCE shall incorporate dam inundation measures into its substation at the design phase to reduce the potential for widespread outages and equipment damages in the event of failure of the south dam at Garvey Reservoir. Measures could include:

- Concrete perimeter wall and flood gates at entry ways;
- Elevation of key substation equipment above inundation levels; or
- Sealing of equipment buildings.

- D1-30 See Response to comment D2-181.
- D1-31 This comment summarizes comment D1. Refer to responses to comments D1-18, D1-20, D1-21, D1-22, D1-26, and D1-28 regarding the comparison of alternatives analysis and to response to comment D1-18 regarding the environmentally superior alternative. Refer to responses to comments D1-11, D1-12, D1-13, D1-14, D1-16, and D1-18, which speak to the feasibility of the One-Transformer-Bank Substation Alternative. 

## **Response to Comment Set D2: Jack Horne**

D2-1 The buffer distance of 50 feet contained in the mitigation measure is correct. The 10foot buffer distance mentioned in the text of the cultural resources section is incorrect and is a typographical error. The California Public Utilities Commission (CPUC) considers a buffer distance of 50 feet appropriate to protect the resource, given the nature of construction activities and vehicle movement. The following revisions were made to pages 4.4-25 and 4.4-26 to correct the typographical error.

## Page 4.4-25:

Mitigation Measure (MM) CR-1 requires a qualified archeologist, approved by the CPUC, to erect flagging to create a 1050-foot buffer around the historic era debris and concrete enclosure. MM CR-1 also requires signs to be erected indicating that construction equipment, materials, and personnel shall stay out of the flagged area. Therefore, impacts resulting from installation of the telecommunications lines would be less than significant with mitigation.

## Page 4.4-26:

MM CR-1 requires a qualified archeologist, approved by the CPUC, to erect flagging to create a 1050-foot buffer around the historic-era concrete footings and shack. MM CR-1 also requires signs to be erected indicating that construction equipment, materials, and personnel shall stay out of the flagged area. Therefore, impacts resulting from the use of Staging Yard 7 during construction under this criterion would be less than significant with mitigation.

Southern California Edison's (SCE's) recommendation regarding evaluation of the eligibility of the historical era debris (resource P-19-186889) and concrete footings and shack (SAY-S-1) is noted; however, the commenter provided no substantiation as to why the changes to the mitigation measure are needed. The changes to the mitigation measure proposed by SCE make the measure less stringent. The CPUC believes the mitigation is feasible and is necessary to reduce impacts to resources P-19-186889 and SAY-S-1 to less than significant; therefore, no changes to the mitigation measure were made.

D2-2 The revision to MM CR-3 has been made as requested so that SCE will be notified upon discovery of a previously unknown cultural resource. A revision has also been made to correct the noted typographical error.

## Pages ES12-ES-13, Page 4.4-30, and Page 8-18:

<u>MM CR-3</u>: **Previously Unidentified Cultural Resources.** If a previously unknown cultural resource is discovered during project construction activities, work shall be halted within 100 feet of the resource, and protective barriers shall be installed along with signage identifying the area as an "environmentally sensitive area." Entry into the area shall be limited to authorized personnel, and the CPUC-approved cultural resources specialist/<del>archaeologist</del>-qualified archaeologist<u>, SCE</u>,

and the CPUC shall be notified immediately.

- D2-3 The commenter's suggested change to MM CR-3 to include SCE as a responsible party is noted and included in the record for consideration by the decision makers. The CPUC recognizes that SCE would implement mitigation measures; however, the CPUC, as the CEQA Lead Agency, maintains responsibility for ensuring all mitigation is effectively implemented. The CPUC-approved cultural resources specialist/qualified archaeologist has the necessary expertise and is therefore appropriately assigned the discretion to determine whether another method would provide superior mitigation to cultural resources impacts and to ensure adherence to the procedures in MM CR-3. MM CR-3 has not been revised in response to the suggestion to add SCE as an organization to be a responsible party for determining whether another method would provide superior mitigation to cultural resources impacts.
- D2-4 The commenter's suggested change to include SCE as a responsible party is noted and included in the record for consideration by the decision makers. The CPUC recognizes that SCE would implement mitigation measures; however, the CPUC, as the CEQA Lead Agency, maintains responsibility for ensuring all mitigation is effectively implemented. The CPUC-approved cultural resources specialist/qualified archaeologist has the necessary expertise and is therefore appropriately assigned the discretion to determine if there is a potential for the resource to be a historical resource. A revision has been made to correct the noted typographical error. No changes have been made in response to the suggestion to add SCE as an organization to be a responsible party for determining if a resource is a historical resource.

## Page ES-13, Page 4.4-30, and Page 8-18:

- **Determination if a resource is an historical resource.** The CPUC-approved cultural resources specialist/qualified archaeologist, in consultation with the CPUC, shall determine if there is a potential for the resource to be a historical resource. If there is no potential for the resource to qualify as a historical resource, work shall resume after CPUC concurrence. If there is a potential for the resource to be a historical for the resource to be a historical resource to be a historical resource, the qualified archaeologist shall prepare an Evaluation Plan.
- D2-5 A revision has been made to correct the noted typographical error.

## Page ES-13, Page 4.4-30, and Page 8-18:

• **Evaluation Plan.** The resource-specific Evaluation Plan shall detail the procedures to be used to determine if the discovery is an historical resource. The Evaluation Plan shall include sufficient discussion of background and context to allow the evaluation of the resource against the historical resource criteria. It shall include a description of procedures to be used in the gathering of information to allow the evaluation. These techniques may include (but are not limited to): excavation, written documentation, interviews, and/or photography. For archaeological resource testing, the Evaluation Plan shall describe the archaeological testing procedures, including, but not limited to: surface collection (if surface artifacts are discovered), test excavations

(including type, number, and location of test pits and/or trenches), analysis methods, and reporting procedure. The Evaluation Plan shall be submitted to CPUC for review. Once approved, the Evaluation Plan shall be implemented in the field. The report resulting from this work shall include evaluation of the discovery, based on the significance criteria set forth in the Evaluation Plan, indicating if it is an historical resource. If the discovery is not found to be an historical resource, and CPUC concurs with that determination, protective barriers may be removed, and work may proceed in the area of the discovery. If the discovery is determined to be an historical resource, SCE shall prepare a Data Recovery Plan.

D2-6 A revision has been made to correct the noted typographical error.

## Page ES-13, Page 4.4-31, and Page 8-18:

- **Data Recovery Plan.** Data Recovery Plans for historic<u>al</u> resources that cannot be fully avoided shall be prepared in accordance with CEQA Guidelines section 15126.4(b)(3)(C) and PRC section 21083.2, as applicable. The Data Recovery Plan shall outline how the recovery of data from the resource will mitigate impacts to that resource to below a level of significance. The Data Recovery Plan shall describe the level of effort, including numbers and kinds of excavation units to be dug, excavation procedures, laboratory methods, samples (e.g., pollen, sediment, as appropriate) to be collected and analyzed, analysis techniques that will yield information relevant to the aspects of the site that make it an historic<u>al</u> resource, and reporting procedure. This plan shall be submitted to the CPUC for review and approval. Once approved, the applicant shall implement the approved plan. Once the data recovery field work is complete, a Data Recovery Field Memo shall be prepared.
- D2-7 MM CR-4 is consistent with the cited text on page 4.4-28, whether or not the word "all" is used. The requirement of MM CR-4 is to monitor ground disturbing activities in areas of moderate to high potential to contain paleontological resources. No changes to the mitigation measure have been made in response to this comment.
- D2-8 Areas of moderate to high paleontological sensitivity are identified in Table 4.4-7 of the Draft Environmental Impact Report (EIR). MM CR-4 has been revised to reflect that areas as designated by the Paleontological Resources Management Plan with moderate to high potential to contain paleontological resources are identified in Table 4.4-7.

## Page ES-13, Page 4.4-31, and Page 8-19:

<u>MM CR-4</u>: Paleontological Resources Monitoring. Prior to the start of construction, the applicant shall retain a qualified paleontologist. The qualified paleontologist shall be approved by the CPUC and shall monitor all ground-disturbing activities that take place within areas that have a moderate to high potential to contain paleontological resources, consistent with designations shown in Table 4.4-7. The Paleontological Resources Management Plan (APM-CUL-01) shall show a map of areas requiring monitoring consistent with Table 4.4-7. The paleontological networks with the authority to halt construction in the vicinity

of any potential paleontological resource finds to begin implementation of MM CR-7.

D2-9 The following revision has been made to MM CR-5 to provide for consultation with the applicant regarding whether avoidance is feasible.

## Page ES-13, Page 4.4-31, and Page 8-19:

<u>MM CR-5</u>: Follow Paleontological Resource Discovery Protocol. In the case that a previously unknown paleontological resource is discovered during construction activities, all work within 15 meters of the resource shall be stopped, and the CPUC-approved paleontologist shall determine, <u>after consulting with SCE</u>, whether the resource can be avoided. If the discovery can be avoided and no further impacts will occur, no further effort shall be required.

D2-10 The commenter's suggested change to include SCE as a responsible party in MM CR-5 is noted and included in the record for consideration by the decision makers. The CPUC-approved paleontologist has the necessary expertise and is therefore appropriately assigned the discretion to determine if there is another method that would provide superior mitigation of impacts to the resource. The paleontologist may consult SCE. No changes have been made in response to the suggestion to include SCE as a responsible party, as SCE as an entity does not have the expertise necessary to determine if there is another method that would provide superior mitigation. A revision has been made to correct the noted typographical error.

## Page ES-14, Page 4.4-32 and Page 8-19:

If the resource is unique, then work shall remain stopped, and the approved paleontologist shall consult with the applicant and the CPUC regarding methods to ensure that no substantial adverse change would occur to the significance of the resource pursuant to CEQA. Preservation in place, i.e., avoidance, is the preferred method of mitigation for impacts to paleontological resources and shall be required to mitigate impacts to previously undiscovered resources unless the CPUC-approved paleontologist cultural resources specialist/qualified archeologist determines that another method would provide superior mitigation of impacts to the resource. Other methods include ensuring that the fossils are recovered. prepared, identified, catalogued, and analyzed according to current professional standards under the direction of a qualified paleontologist. Methods of recovery, testing, and evaluation shall adhere to current professional standards for recovery. preparation, identification, analysis, and curation, such as the 2010 Society of Vertebrate Paleontology Standard Procedures for the Assessment of Adverse Impacts to Paleontological Resources. Work can commence following recovery and CPUC approval.

D2-11 SCE's comment is noted and the following edits have been made to the EIR.

## Page ES-23:

## MM PS-1: Relocation Agreement with <u>Municipal Metropolitan</u> Water District.

Prior to construction that would take the MWD's 72-inch Middle Feeder Pipeline out of service, the applicant shall reach an agreement with the MWD that will identify an alternate alignment that crosses the project site. This relocation agreement will enable the MWD to maintain reliable deliveries of treated water to its member agencies during relocation of the pipeline. SCE shall submit to the CPUC information from the MWD confirming that relocation of the pipeline will not result in inability to adequately serve customers. SCE shall submit this documentation at least 30 days prior to the pipeline being taken out of service.

Changes were also made to the Section 4.14, "Traffic and Transportation," to reflect this updated information.

## Page 4.14-30:

#### **Operation and Maintenance**

Prior to <u>construction</u> of the proposed substation, the applicant would also develop a landscaping plan, consulting with the City of Monterey Park Department of Community and Economic Development (Building Division) and the Metropolitan Water District.

D2-29 The following changes have been made based on information provided by SCE.

## Page 2-52:

Prior to construction of the proposed Mesa Substation, the applicant would conduct site preparation activities such as vegetation clearing, grading, installing a

temporary chain-link fence around the substation perimeter, and constructing a new driveway to provide access to the construction equipment and vehicles. Prior to <u>construction</u> commencement of the proposed substation, the applicant would also develop a landscaping plan, consulting with the City of Monterey Park Department of Community and Economic Development (Building Division) <u>and the Metropolitan Water District</u>.

D2-30 The following changes have been made to the description of access driveways for the proposed substation in the EIR based on updated project information provided by SCE.

## Page 2-54:

It would be about 25 feet wide. Once <u>Temporal</u> Phase 3 begins, the applicant would establish the primary substation access driveway from Potrero Grande Drive <u>approximately 700 feet west of closer to</u> Greenwood Avenue. This driveway would be about <u>50150</u> feet wide. <u>Also, a new 26-foot wide paved driveway will be</u> <u>provided on Greenwood Avenue approximately 525 feet south of Potrero Grande</u> Drive for operation and maintenance purposes of the new test and operations <u>buildings.</u> During substation operations, each permanent access driveway (Potrero Grande Drive, Greenwood Avenue, and East Markland Drive) would have a rolling gate installed to control access to the Mesa 500-kV Substation site.

D2-31 The following change has been made to the description of Phase 1 construction activities in the EIR based on updated project information provided by SCE.

## Page 2-62:

- Assembly and erection of various transmission and subtransmission structures, including:
  - Eight 220-kV LSTs,
  - Ten 66-kV TSPs and six 66-kV vaults,
  - Four 66-kV duct banks and four vaults,
  - Five 16-kV duct banks, and four vaults, and
  - <u>EightFive</u> telecommunication manholes and six duct banks,
- Construction of the Operations Building.
- D2-32 The following change has been made to the description of retaining walls needed during Phase 1 based on updated information provided by SCE.

## Page 2-62:

Two temporary retaining walls would be constructed during initial site grading in the southwest portion of the Mesa Substation site, near the existing 220-kV LSTs. These walls would create sufficient space to assemble and erect the replacement towers. When the new towers are constructed, the retaining walls would be removed and grading around those areas would be completed.

In addition, t<u>T</u>he applicant would construct two permanent retaining walls within the Mesa Substation site. One wall would be located on the north side of the substation along Potrero Grande Drive and would be approximately 1,500 feet long and approximately 18 feet tall. The second wall would be located on the northeast side of the substation along Greenwood Avenue, approximately 250 feet long with a maximum height of 16 feet. In both cases, the substation perimeter wall would be mounted to the top of the retaining wall. In these cases, the exterior view of the substation, looking from either Potrero Grande Drive or Greenwood Avenue, would only consist of the substation perimeter wall.

D2-33 The following clarification has been made regarding construction activities based on SCE's comment.

## Page 2-67:

Following <u>installation of permanent facilities</u> <del>construction activities</del> at each site, the applicant would remove all temporary structures and components. The holes resulting from pole removal would be backfilled using excavated soil from other construction areas.

D2-34 The following changes have been made to description of structures based on information provided by SCE.

## Page 2-70:

## **Transition Structures**

The applicant would install transition structures following a sequence similar to that described for TSP and wood pole installation.

## Wood Pole Installation

Each wood pole would require a hole to be excavated using either an auger, backhoe, or with hand tools. The wood poles would be placed in temporary laydown areas at each pole location. While on the ground, the wood poles may be configured (if not preconfigured) with the necessary cross arms, insulators, and wire stringing hardware before being set in place. The wood poles would then be installed in the holes, typically by a line truck with an attached boom. Wood guy stub poles and wood guard structure poles would be installed similarly to wood poles.

## **Light-Weight Steel Pole Installation**

LWS poles would be installed similarly to wood poles.

D2-35 Information regarding wood pole and light-weight steel pole installation was added to the EIR based on information provided by SCE. Refer to response to comment D2-34 above for in-text changes.

D2-36 The following clarification has been added to the EIR based on SCE's comment.

## Page 2-72:

Trenching activities would be temporary and staged to ensure that open trench segments would not exceed the area required for duct bank installation. While constructing in public access areas, the applicant would install steel plates over open trenches <u>during inactivity</u> to maintain vehicle and pedestrian traffic. Prior to construction activities, the applicant would also make provisions for emergency vehicle access in coordination with local agencies.

D2-37 The following change has been made to the description of underground construction based on updated project information provided by SCE.

## Page 2-71:

The proposed project would include a total of approximately <u>4.2</u>3.4 miles of new underground subtransmission lines and also would use existing underground features. For underground construction associated with the proposed project, the applicant would conduct the following activities.

D2-38 The following addition to the EIR has been made based on SCE's comment.

## Page 2-74:

The applicant anticipates that horizontal boring operations for the proposed project would excavate between 590 to 1,180 CY of material. Following the duct bank installation, the crew would backfill the bore pits with native materials and cover the duct bank with at least 36 inches of engineered or native fill, as appropriate. Any excess soil material would be <u>utilized onsite or</u> hauled off site and disposed of at an approved disposal facility.

D2-39 The following addition to the description of Clean Water Act (CWA) requirements in the EIR has been made based on SCE's comment.

## Page 2-81:

Construction of the proposed project would disturb a surface area greater than 1 acre. Therefore, the applicant would be required to obtain coverage under the General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities, Order 2009-0009-DWQ as amended by Order 2010-0014-DWQ and 2012-0006-DWQ from the State Water Resources Control Board. Commonly used BMPs are storm water runoff quality control measures (boundary protection), dewatering procedures, and concrete waste management. The SWPPP would be based on final engineering design and would include all proposed project construction components.

D2-40 SCE states that coordination of its operations and maintenance (0&M) activities with Metropolitan Water District's 0&M activities related to the relocated Middle Feeder pipe is needed and suggests including Metropolitan Water District's O&M activities in this section. The following change to the EIR has been made:

## Page 2-83:

Additional O & M activities at the proposed Mesa Substation would include maintenance of non-electrical facilities, including restrooms, air conditioning, and general facilities housekeeping, and MWD's relocated Middle Feeder.

D2-41 The following correction to the hyperlink to the CPUC's webpage regarding electric and magnetic fields (EMFs) was made based on SCE's comment. The link SCE provided was not valid; the text was revised to include the valid link.

## Page 2-85:

D2-42 CPUC policy does not restrict the consideration of EMF reduction measures to those measures known or deemed feasible during initial project design; therefore, SCE's recommended edit was not made as suggested. Instead, the following clarification was made regarding the implementation of low cost/no-cost EMF reduction measures based on CPUC policy.

## Page 2-85:

SCE would incorporate the following low-cost/no-cost measures into the design of the proposed project <u>if feasible.</u>

D2-43 The following addition to the description of CWA requirements in the EIR has been made based on SCE's comment.

## Page 2-89:

D2-45 The first suggested sentence from the commenter would be a better addition to the impacts section where visual simulations are discussed rather than in the introduction to this section. The first sentence suggested by the commenter has been added to the introduction to Section 4.1.3 for Environmental Impacts to provide additional clarity.

## Page 4.1-18:

Environmental impacts for construction and operation of the proposed project are described below. Visual simulations have been prepared for the KOPs analyzed to better understand the aesthetic impacts from the proposed project; however, all visual simulations included in this section are conceptual only.

The second sentence recommended by the commenter has been added to discussions of key observations points (KOPs) 1 and 3 in the impacts section where the options for landscape treatment along Potrero Grande Drive are discussed. However, it should be noted that SCE's statement that it will meet with the City and discuss final landscaping and perimeter wall materials is not necessarily a condition of approval designed to address the City's interests. MM AES-3 was developed to ensure the City's interest in reducing aesthetic impacts from the proposed project are addressed for the appearance of the landscaping and wall proposed for Potrero Grande Drive.

The following revisions were made to Section 4.1.3.3 under KOP 1.

## Page 4.1-30:

Figure 4.1-5c shows a visual simulation of the proposed project from KOP 1 with the implementation of Landscape Option 1. Figure 4.1-5d shows a visual simulation of the proposed project from KOP 1 with the implementation of Landscape Option 2 along Potrero Grande Drive. <u>SCE has stated it will meet with the City of Monterey Park to discuss final landscaping and perimeter wall materials (including the spacing of pilasters).</u>

The following revisions were made to Section 4.1.3.3 under KOP 3.

## Page 4.1-36:

Figure 4.1-5e shows a visual simulation of the proposed project from KOP 3 with implementation of Landscape Option 1. Figure 4.1-5f shows a visual simulation of the proposed project from KOP 3 with implementation of Landscape Option 2 along the substation perimeter wall facing Potrero Grande Drive. <u>SCE has stated it will meet with the City of Monterey Park to discuss final landscaping and perimeter wall materials (including the spacing of pilasters).</u>

D2-46 The text has been revised per the comment to clarify that the central component of the proposed project is the construction of a new, larger substation to replace the existing Mesa Substation on the same site.

The following revisions have been made to Section 4.1.1.1.

## Page 4.1-1:

The central component of the proposed project is <u>the construction of a new, larger</u> <u>substation to replace the existing Mesa Substation on the same site. Some</u> <u>additional work would also occur near the existing substation.</u> <del>work that would</del> <del>occur at or adjacent to the proposed Mesa Substation site.</del> The proposed project is located in an area of transition between the high, rugged San Gabriel Mountains approximately 10 to 15 miles to the north and the broad, gently sloping coastal plain to the south. The terrain within this transition area consists of rolling to steep hills intermixed with some flatter areas and various drainages. The San Gabriel Mountains provide a vivid backdrop to many views in the area. Although some remnants of native oak woodland, riparian, coastal sage scrub, and grassland habitats still exist, much of the area's vegetation now consists of non-native, ornamental plantings. The area is highly developed with housing, commercial and industrial, freeways, and other land uses, including some parks and open space areas.

The second part of this comment refers to the character of the broad area around the site rather than the site itself. Therefore, it is not appropriate to add the suggested language without also discussing the variety of other land uses in the area (landfill, schools, etc.). It is sufficient and accurate to say this area is highly developed. The site and its surroundings are discussed in more detail in the following paragraph and later when discussing specific views in the area. No changes to the text have been made.

D2-47 SCE requests that the "impact conclusion" be changed for travelers on Potrero Grande Drive. However, the CPUC believes SCE actually seeks changes to the "viewer sensitivity" rating and not the impact conclusion itself. Regardless, the City of Monterey Park General Plan (City of Monterey Park 2001) identifies Potrero Grande Drive as a key arterial road that should be given high priority "for upgrading the City's image." Furthermore, as stated in the Aesthetics section, this street is experienced on a regular basis by local area residents traveling for personal reasons, as well as people commuting to and from work at the business park and other locations. Given that this street is recognized as important to the City's image, a large portion of viewers are residents of the surrounding neighborhoods, and views are regularly experienced by pedestrians and others traveling at slower speeds than viewers on the Pomona Freeway, travelers on Potrero Grande Drive would have higher awareness of and concern for views than travelers on the Pomona Freeway. Therefore, viewer expectations for both roadways are not similar and visual sensitivity for travelers on Potrero Grande Drive remains moderate. No changes to the text have been made.

D2-48 SCE requests that the "impact conclusion" and "viewer sensitivity" rating be changed for the commercial area west of the substation site. However, although the City of Monterey Park identifies Potrero Grande Drive as a key arterial road that should be given high priority "for upgrading the City's image," viewer groups using the motel located along the south side of Potrero Grande and adjacent to the project site typically would not consist of local area residents. Based on local area residents' familiarity with the surrounding environment, they have greater awareness and concern for a particular view in their local area than visitors would have. Although a large proportion of users of the gas station may consist of local area residents, the higher awareness of and concerns for views by this viewer group are captured in the viewer group of travelers on Potrero Grande Drive. For these reasons, the viewer sensitivity for the viewer group for the commercial area has been changed to moderately low. However, it should be recognized that this change to the level of viewer sensitivity for views from the commercial area does not change the viewer sensitivity or affect the visual sensitivity or conclusions of significance for views from Potrero Grande Drive.

The following revisions have been made to Table 4.1-1.

D2-49 The following revisions to Section 4.1.3.3 have been made.

## Page 4.1-22:

Transmission, subtransmission, and distribution work adjacent to the substation would require work in various locations for short durations as <u>poles structures</u> are installed or removed, and conductor is installed.

D2-50 The following revisions to Section 4.1.3.3 have been made.

# Page 4.1-22:

Figures 4.1-4a and 4.1-4b show existing views from areas within the vicinity of Goodrich Substation in the City of Pasadena. The temporary tubular steel pole (TSO) structure and loop-in would be installed as part of the proposed project and that would be present during the construction phase would be visible from I-210 as well as nearby residences and a community college. However, other existing tall metal lattice transmission towers, a cell phone tower, and other tall metal structures associated with Goodrich Substation would be visible alongside the temporary infrastructure. The additional contrast would be minimal and vividness, intactness, and unity of views from these areas would not be substantially reduced.

## Page 4.1-21:

Given that there would be an overall net reduction or maintenance of the total number of structures at KOPs 2 and 4 (and approximately one less 500-kV structure, eight fewer 220-kV structures, and 41 fewer subtransmission <del>poles</del> <u>structures</u> overall), the result would be either maintenance or slight improvement of the existing visual quality of the area. In addition to the contrast produced by

their form, line, and texture, transmission lines could also produce strong contrast due to the reflectivity of conductors or color or finish of structures, especially if they have a shiny, metallic, galvanized finish.

D2-51 The following revisions to Section 4.1.3.3 have been made.

# Pages 4.1-23 through 4.1-24:

Installation of marker balls may be recommended by the FAA on structures over 200 feet above ground per FAA Advisory Circular 70/7460-1L (FAA 2015). The location and other details of marker balls would be recommended by the FAA after SCE submits an FAA Form 7460-1 once engineering has been completed to the point where actual heights of structures are known. The three proposed 500-kV structures would range from approximately 140 to 200 feet aboveground. Conductors would be placed 12 to 14 feet below the top of the LST (see Figure 2-5). The ground surface is about level in the area of the two conductor spans. Notably, the recently constructed TRTP 500-kV transmission line does not have marker balls. Together, this indicates that no conductor would be located over 200 feet from the ground and that no marker balls are likely to be required recommended by the FAA. If, however, during final engineering, the conductor is placed more than 200 feet above the ground, then marker balls may be required recommended along these two spans, which together measure about 1,200 linear feet.

D2-52 Viewer sensitivity is correctly identified as moderate for viewer groups on Potrero Grande Drive. (See response to comment D2-47.)

The CPUC recognizes that Data Request Set A.15-03-003 ED-SCE-01 Follow Up 3 indicates that the wall height will be 12 feet and not 10 feet. SCE provided an updated visual simulation with its comment. However, this does not change the CPUC's conclusion regarding aesthetic impacts.

The rationale provided by the commenter fails to include the discussion following the quoted text describing existing conditions for views from KOP 1, which states: "The other tall metal structures associated with the substation visible in the distant foreground and middleground are mostly screened by the tall trees and therefore are less noticeable."

The commenter incorrectly bases its rationale on the view having low scenic quality and moderately low viewer sensitivity, whereas the conclusions of significance in the analysis are based on the increase in the amount of contrast and reductions in unity, intactness, and vividness produced by the proposed project for views with moderate visual sensitivity. Furthermore, the analysis of aesthetic impacts in the EIR is more robust, providing a detailed rationale for each of the two landscape options proposed by SCE. The analysis for Landscape Option 1 states: "With implementation of MM AES-2 and MM AES-3, impacts under this criterion would remain significant and unavoidable for several years for views from KOP 1 before trees grow to maturity. As the trees in the landscaping mature, they would screen more of the substation and soften the contrast, and impacts would then be less than significant." The analysis for Landscape Option 2 states: "the landscaping allowed under this option still excludes trees and other larger plants that would serve a visual screening function and that would be taller than the walls to reduce contrast. Thus, impacts under this criterion would be somewhat reduced by implementing MM AES-2 and MM AES-3 but would remain significant at KOP 1 for this option, even after implementation of mitigation." Thus, in the absence of a selected option, the conclusion of "significant with mitigation" identified immediately below the "Mesa Substation" header reflects the level of impact represented by implementation of Landscape Option 2.

For the reasons described above, the commenter's suggested change has not been made.

D2-53 The following revisions to Section 4.1.3.3 have been made.

## Page 4.1-29:

Work within the North and South Areas includes the replacement of a single LST with a similar LST in the City of Commerce, installation of a temporary pole and 220-kV tie-in at Goodrich Substation in Pasadena that would be removed <u>once the temporary tie-in is no longer neededfollowing construction</u>, and the conversion of an existing streetlight source line. The new LST in Commerce would not be noticeably different from the existing LST; therefore, impacts would be less than significant. The new telecommunications components at Goodrich Substation would be underground in an already disturbed area and therefore would not be noticeable during operation. No visual impact would result from operation and maintenance at Goodrich Substation due to the 220-kV tie-in because operation and maintenance would be the same as under existing conditions. Conversion of the overhead street light source line to underground would remove from view an existing overhead line that contrasts somewhat with its surroundings. Although minor, removal of this element would result in a beneficial aesthetic impact; therefore, there would be no impact associated with this component.

D2-54 The EIR includes the visual simulations provided by SCE in the Proponent's Environmental Assessment (and as updated by the applicant in their Draft EIR comment letter) and the CPUC used the same assumptions as SCE in its analysis in the Draft EIR. Thus, the following revisions to Section 4.1.3.3 have been made.

# Page 4.1-30:

The simulation in Figure 4.1-5c shows a new masonry screening wall and new street trees lining the sidewalk along the edge of the site and Potrero Grande Drive. Although the new, taller LSTs, TSP, and other metal structures would remain dominant in this view, the row of street trees extending above the new masonry wall would help partially screen views of the lower portions of elements in the substation and would partially screen the wall. The trees are shown at approximately 15 to 20 years old, which may be approximately 5 to 10 years after planting, depending on their species and size and age at planting. The trees would also somewhat reduce the contrast produced by the new, tall metal structures and wall by softening the angular patterns of the wall and metal structures. However, for several years following planting, until the street trees are large enough to

substantially screen views of the lower portions of elements in the substation and the wall, Gcontrast would remain moderately strong and intactness and unity for views from Potrero Grande Drive would be substantially reduced for views from Potrero Grande Drive with moderate visual sensitivity. During this extended period, until the trees eventually mature, Landscape Option 1 would therefore result in a significant impact. During this extended period of time unless the street trees are similar in size to the existing vegetation within a few years after construction. Contrast would be moderately strong, the sole TSP would be dominant as a strong vertical feature, and the new landscaping would not soften vertical lines as much as the existing vegetation. Visual sensitivity is moderate. The existing vividness, intactness, and unity would therefore be substantially reduced. Landscape Option 1 would therefore result in a significant impact.

- D2-55 For the reasons described above in response to comment D2-52, the commenter's suggested change has not been made.
- D2-56 The following revisions to Section 4.1.3.3 have been made.

## Page 4.1-30:

MM AES-<u>2-3</u> would require that the applicant provide landscape screening and aesthetic treatment along Potrero Grande Drive to reduce aesthetic impacts of the proposed project. MM AES-3 requires design approval of the final Landscape and Aesthetic Treatment Plan by <u>CPUC the City</u> prior to construction.

D2-57 Viewer sensitivity is correctly identified as moderate for viewer groups on Potrero Grande Drive. (See response to comment D2-47.)

Aesthetic impacts are based on an analysis of existing conditions and the changes to views with the addition of new structures and removal of existing screening vegetation proposed with the project. The analysis for KOP 3 states: "All of the existing mature trees and other vegetation on and immediately adjacent to the substation site and visible in the existing view would be removed. Vegetation to be removed includes a number of tall trees that currently screen the lower portions of transmission structures and most of the other metal structures at the substation; the vegetation also softens the otherwise geometric patterns at the current substation site."

Based on the revised visual simulations submitted by SCE with its comments on the Draft EIR, the analysis for KOP 3 Landscape Option 1 has been revised to less than significant with mitigation.

The following revisions have been made to Section 4.1.3.3.

#### Page 4.1-36:

#### Landscape Option 1

The simulation in Figure 4.1-5e shows a new masonry screening wall, new street trees lining the sidewalk along the edge of the site and Potrero Grande Drive, and new metal operations and test and maintenance buildings. The trees are shown at

approximately 15 to 20 years old, which may be approximately 5 to 10 years after planting, depending on their species, and size, and age at planting. With installation of the new street trees and screening wall under Landscape Option 1, vividness would be only slightly reduced in the long term from the existing condition. In the short term, vividness would be substantially reduced before the trees reached mature height. The trees would also somewhat reduce the contrast produced by the new, tall metal structures and wall by softening the angular patterns of the wall and metal structures. The new masonry screening wall and row of street trees would help screen views of the lower portions of elements in the substation, thereby reducing overall contrast to moderate and resulting in only a slight reduction in intactness and unity. However, for several years following planting, until the street trees are large enough to substantially screen views of the lower portions of elements in the substation, the metal buildings, and the wall, contrast would remain moderately strong and intactness and unity would be substantially reduced for views from Potrero Grande Drive with moderate visual sensitivity. During this extended period, until the trees eventually mature, Landscape Option 1 would therefore result in a significant impact and slightly reduce the contrast.; however, the trees would not substantially screen views of the new metal buildings or central TSP in the view, intactness and unity would be substantially reduced, and contrast would be moderately strong. Because the existing vividness, intactness, and unity would be reduced, contrast is moderately strong, and visual sensitivity is moderately high, the proposed project would substantially degrade the existing visual character and quality of the site and its surroundings. Therefore, aesthetic impacts for KOP 3 would be significant under Landscape Option 1.

To reduce aesthetic impacts of the proposed project for KOP 3 under Landscape Option 1 and ensure the site's visual character and quality are maintained at a level similar to the existing condition, MM AES-3 would require that the applicant provide aesthetic treatment for the operations and test and maintenance buildings and also provide landscape and aesthetic treatment along Potrero Grande Drive. MM AES-3 requires design approval of a final Landscape and Aesthetic Treatment Plan by CPUC prior to construction. Ultimately, the majority of the visible infrastructure is present against most of the visible sky and cannot be effectively screened or modified to reduce its visual dominance. With implementation of MM AES-3 and MM AES-4, impacts under this criterion would be somewhat reduced, but would remain significant at KOP 3. MM AES-3 would require that the applicant provide landscape screening and aesthetic treatment along Potrero Grande Drive to reduce aesthetic impacts of the proposed project. MM AES-3 requires design approval of the final Landscape and Aesthetic Treatment Plan by the City prior to construction. With implementation of MM AES-2 and MM AES-3, impacts under this criterion would remain significant and unavoidable for several years for views from KOP 3 before trees grow to maturity. As the trees in the landscaping mature, they would screen more of the substation and buildings and soften the contrast. and impacts would then be less than significant.

D2-58 The text has been revised to address some of the commenter's suggested changes. As explained in response D2-57, based on the project revisions submitted by SCE, the analysis for KOP 3 Landscape Option 1 has been revised to less than significant with mitigation.

The following revisions have been made to Section 4.1.3.3.

## Page 4.1-36:

Although the new LSTs would be similar in appearance to the existing LSTs, they would be taller and closer to viewers traveling along Potrero Grande Drive. As a result, they would be more dominant than the existing LSTs. The new TSPs, tall metal switchracks, and <del>new metal operations and test and maintenance</del> buildings would add new geometric forms and lines to the view. These changes, in combination with removal of the existing tall trees and other vegetation on and around the site, would produce strong contrast and reduce the intactness and unity of views from Potrero Grande Drive.

Additionally, the following revisions have been made to Section 4.1.3.3.

## Page 4.1-36:

The new masonry screening wall and row of street trees would help screen views of the lower portions of elements in the substation, thereby reducing overall contrast to moderate and resulting in only a slight reduction in intactness and unity. However, for several years following planting, until the street trees are large enough to substantially screen views of the lower portions of elements in the substation, the metal buildings, and the wall, contrast would remain moderately strong and intactness and unity would be substantially reduced for views from Potrero Grande Drive with moderate visual sensitivity. During this extended period, until the trees eventually mature, Landscape Option 1 would therefore result in a significant impact and slightly reduce the contrast\_; however, the trees would not substantially screen views of the new metal buildings or central TSP in the view, intactness and unity would be substantially reduced, and contrast would be moderately strong. Because the existing vividness, intactness, and unity would be reduced, contrast is moderately strong, and visual sensitivity is moderately high, the proposed project would substantially degrade the existing visual character and quality of the site and its surroundings. Therefore, aesthetic impacts for KOP 3 would be significant under Landscape Option 1.

To reduce aesthetic impacts of the proposed project for KOP 3 under Landscape Option 1 and ensure the site's visual character and quality are maintained at a level similar to the existing condition, MM AES-3 would require that the applicant provide aesthetic treatment for the operations and test and maintenance buildings and also provide landscape and aesthetic treatment along Potrero Grande Drive. MM AES-3 requires design approval of a final Landscape and Aesthetic Treatment Plan by CPUC prior to construction. Ultimately, the majority of the visible infrastructure is present against most of the visible sky and cannot be effectively screened or modified to reduce its visual dominance. With implementation of MM AES-3 and MM AES-4, impacts under this criterion would be somewhat reduced, but would remain significant at KOP 3. MM AES-3 would require that the applicant provide landscape screening and aesthetic treatment along Potrero Grande Drive to reduce aesthetic impacts of the proposed project. MM AES-3 requires design approval of the final Landscape and Aesthetic Treatment Plan by the City prior to construction. With implementation of MM AES-2 and MM AES-3, impacts under this criterion would remain significant and unavoidable for several years for views from KOP 3 before trees grow to maturity. As the trees in the landscaping mature, they would screen more of the substation and buildings and soften the contrast, and impacts would then be less than significant.

D2-59 The following revisions have been made to Section 4.1.3.3.

# Page 4.1-42:

Figure 4.1-5h shows existing and potential views of the proposed project from KOP 6 looking west from the westbound (northern) lanes of the Pomona Freeway near its undercrossing of Greenwood Avenue. <u>An updated visual simulation includes a</u> 12-foot high perimeter wall.

D2-60 CPUC recognizes that SCE submitted a revised visual simulation for KOP 7 with its comment letter. However, KOP 7 is representative of views from the vicinity of the KOP, which includes the surrounding residential neighborhood. As such, LSTs and tubular steel poles (TSPs) that are taller than the existing LSTs and TSPs would still be seen in views from the vicinity of KOP 7 and would still alter views of the distant mountains. In addition, the new substation would include structures expanded over a broader area of the site. Based on the analysis of the revised visual simulation, aesthetic impacts for KOP 7 would still be significant. Although implementation of MM AES-5 would help reduce the impacts, they would remain significant after

implementation. For these reasons, the commenter's suggested changes have not been made.

D2-61 Based on SCE's comment, the following revisions to MM-AES-2 have been made in ES, 4.1, and MMRP.

Pages ES-5, 4.1-51 through 4.1-52, and 8-3:

**MM AES-2**: **Minimize Clearing and Ground Disturbance and Restore Improve Disturbed Areas to Pre-Project Conditions.** Clearing and ground disturbance required for construction, including but not limited to, access roads, pulling sites, construction and maintenance pads, and construction laydown areas, shall be the minimum required, and the applicant shall restore improve all disturbed areas not required for operation and maintenance to pre-construction conditions <u>or better</u> to the extent feasible. Restoration Improvement would not be feasible if, for example, a landowner other than SCE does not wish the area to be restored improved. Areas around new or rebuilt transmission structures that must be cleared during the construction process or other areas of ground disturbance shall be regraded and revegetated to be restored to an appearance that would replicate <u>or improve</u> preconstruction conditions. The CPUC shall verify appropriate restoration improvements of disturbed areas. For all paved areas (e.g., streets, sidewalks, and parking areas) disturbed by construction, the applicant shall restore these areas to pre-project conditions in compliance with permits for work within these areas. D2-62 Based on SCE's comment, the following revisions to MM AES-3 have been made in ES, 4.1, and MMRP.

Pages ES-5, 4.1-52, and 8-3:

MM AES-3: Landscape and Aesthetic Treatment along Potrero Grande Drive. Prior to construction, the applicant shall prepare a Landscape and Aesthetic Treatment Plan that will, at a minimum, provide vegetative screening, with the use of California native and/or drought tolerant vegetation, and other aesthetic treatments (e.g., decorative caps on block walls) along Potrero Grande Drive and in the vicinity of the new entry drive at the substation, and provide aesthetic treatment of the operations and test and maintenance buildings and their immediate surroundings. The Landscape and Aesthetic Treatment Plan shall not conflict with NERC CIP requirements in CIP-014-2 (Physical Security) or related NERC findings. Aesthetic treatments along Potrero Grande Drive shall include design enhancements for the masonry screening wall, adjacent walkway, pavement surfaces, and planting areas and may include raised and median planters or other design enhancements. Aesthetic treatment of the operations and test and maintenance buildings and their immediate surroundings shall include improved color selection and design for the buildings and landscaping of their surroundings that will help screen views of the buildings and blend them with their surroundings. All color finishes for built elements shall be flat and non-reflective. The final Landscape and Aesthetic Treatment Plan along Potrero Grande Drive shall be prepared by a professional landscape architect licensed to work in California. The applicant shall consult with the City of Monterey Park in development of the Landscape and Aesthetic Treatment Plan and both this plan and the final designs for the buildings shall be subject to design review and approval by the City. The Landscape and Aesthetic Treatment Plan shall be provided to the CPUC for final review and receive final approval from the CPUC prior to construction of these buildings and aesthetic treatments along Potrero Grande Drive. The final approved Landscape and Aesthetic Treatment Plan shall be fully implemented within four months of beginning operation of the new substation. The Landscape and Aesthetic Treatment Plan shall include the Landscape and Irrigation Plan and Wall Plan required to be submitted to the City for its review and approval as part of the overall permitting process. Copies of the final approved Landscape and Aesthetic Treatment Plan and associated City permits shall be provided to the CPUC prior to construction of these buildings and aesthetic treatments along Potrero Grande Drive. The final approved Landscape and Aesthetic Treatment Plan shall be fully implemented within four months of beginning operation of the new substation.

D2-63 KOP 7 is representative of views from the vicinity of the KOP (i.e., from the surrounding residential neighborhood) and the revised visual simulation submitted by SCE with its comments on the Draft EIR shows a conceptual view from within this area. As such, views from the vicinity of KOP 7 would include some metal structures other than the LSTs and TSPs that are up to 35 feet high, including transformer banks and new permanent buildings. For this reason, SCE's suggested modification to MM AES-5 has not been made. However, MM AES-5 has been modified as follows in ES, 4.1, and

MMRP to clarify the types of structures up to 35 feet high that would be subject to this mitigation measure.

# Pages ES-5, 4.1-52, and 8-3:

**MM AES-5**: **Glare Reduction.** To reduce potential glare from components of the proposed project and help blend them into the landscape setting, the finishes on all new transmission and other structures with metal surfaces shall be non-reflective and new conductors shall be non-specular. With the exception of LSTs, TSPs, and switchracks, all metal structures up to 35 feet high<u>, including transformer banks</u> and new permanent buildings, visible from the vicinity of KOP 7 shall have finishes that are dark in color or otherwise colored to help blend the structures with their surroundings.

D2-64 The air quality analysis shows that unmitigated construction emissions would be above significance thresholds for reactive organic gases (ROG), carbon monoxide (CO), oxides of nitrogen (NO<sub>X</sub>), particulate matter less than or equal to 10 microns in diameter (PM<sub>10</sub>), and particulate matter less than or equal to 2.5 microns in diameter (PM<sub>2.5</sub>). The analysis shows that use of higher tiered (Tier III and Tier IV) diesel engines will significantly reduce emissions. The use of higher tiered diesel engines, along with the other mitigation measures, will reduce actual PM<sub>10</sub> and PM<sub>2.5</sub> emissions below significance thresholds; however, the ROG, NO<sub>X</sub>, and CO emissions will still be above significance thresholds. While MM AQ-2 and MM AQ-4 require the purchase of volatile organic compound/ROG and NO<sub>X</sub> offset credits to reduce emissions below significance thresholds, every effort must be made to reduce actual emissions.

Emission control technologies are commercially available today that can greatly reduce air pollutants emitted from existing diesel engines. Diesel retrofit technologies can significantly reduce PM, NO<sub>x</sub>, CO, and ROG. The California Air Resources Board (CARB) provides a list of currently verified diesel retrofit technologies at: http://www.arb.ca.gov/diesel/verdev/vt/cvt.htm

The CPUC recognizes that it may not be technically feasible to retrofit all lower tiered diesel equipment to reach Tier IV emission standards; however, any emission reductions that are technically feasible will benefit the air quality surrounding the construction sites. Therefore, SCE's due diligence to investigate and implement technically feasible control options for lower tiered diesel engines is required. The language in the mitigation measure has been revised to remove the requirement to reach Tier IV standards; however, retrofit control strategies must still be investigated and implemented if possible.

The text has been revised as follows.

# Pages ES-6, 4.2-21, and 8-4:

<u>MM AQ-1</u>: Construction Emission Reduction Measures. SCE shall implement the following emission reduction measures for all construction activities:

1. All off-road diesel-powered construction equipment with engines greater than

100 horsepower (hp) shall be compliant with Tier 4 off-road emissions standards where available. In the event that equipment with a Tier 4 engine is not available for any off-road engine larger than 100 hp, <del>that engine shall be</del> <del>operated with tailpipe retrofit controls that reduce exhaust emissions of NO<sub>x</sub> to no more than Tier 4 emission levels. SCE shall investigate all available diesel retrofit technologies to reduce emissions. Any technologically feasible retrofit control technologies must be implemented. If emission levels equivalent to Tier IV standards cannot be reached, the emissions shall be reduced to the maximum extent possible based on the selected retrofit technology. Diesel retrofit technologies investigated shall include, but are not limited to, the Air Resource Board currently verified diesel emission control strategies. SCE shall document the results of its investigation for review by the CPUC.</del>

- 2. All off-road diesel-powered construction equipment with engines greater than 50 hp shall be compliant with Tier 3 off-road emissions standards where available. In the event that equipment with a Tier 3 engine is not available for any off-road engine larger than 50 hp, that engine shall be operated with tailpipe retrofit controls that reduce exhaust emissions of NO<sub>x</sub> to no more than Tier 3 emission levels. SCE shall investigate all available diesel retrofit technologies to reduce emissions. Any technologically feasible retrofit control technologies must be implemented. If emission levels equivalent to Tier III standards cannot be reached, the emissions shall be reduced to the maximum extent possible based on the selected retrofit technology. Diesel retrofit technologies investigated shall include, but are not limited to, the Air Resource Board currently verified diesel emission control strategies. SCE shall document the results of its investigation for review by the CPUC.
- 3. Equipment with an engine not compliant with the Tier 3 or Tier 4 standards, as applicable, will be allowed on a case-by-case basis only when the applicant has documented that no Tier 3 or Tier 4 equipment (or emissions equivalent retrofit equipment) is available for a particular equipment type. Each case shall be documented with signed written correspondence by the appropriate construction contractor, along with documented correspondence from at least two construction equipment rental firms representing a good faith effort to locate engines that meet Tier 3 or Tier 4 requirements, as applicable. Documentation will be submitted to CPUC staff for review before equipment is used on the project.
- D2-65 Concerning SCE's comment on item 4, the verification of equipment tier and any applicable control technologies is required to ensure actual emissions are mitigated to the extent practicable. However, the language in the mitigation measure has been revised to allow for unforeseen equipment replacement.

# Pages ES-6, 4.2-22, and 8-9:

4. Submit to CPUC staff and/or construction monitors a copy of each piece of construction equipment's certified tier specification, best available control technology (BACT) documentation, and/or CARB or SCAQMD operating permit, as applicable, at least 15 days prior to mobilization of each applicable unit of equipment. In the event that unforeseen equipment replacement is required

after the initial notification, replacement equipment may be used so long as notification is submitted 24 hours prior to mobilization of the replacement equipment.

D2-66 The CPUC agrees with SCE that tracking use will take effort on the part of SCE and the reviewing agency; however, tracking actual emissions from equipment use is not unusual. For example, the Aliso Canyon Turbine Replacement project, for which CPUC is the Lead Agency, required daily tracking.

Tracking would ensure that adequate credits are purchased to mitigate volatile organic compound/ROG emissions to less than significant levels. Past projects have shown that emissions estimates have varied widely from actual emissions. For example, on the Aliso Canyon Turbine Replacement project, estimated emissions were overestimated for all years of construction even with fine-tuning based on previous years' data. Equipment tracking during construction gives the CPUC data to ensure that underestimation—and therefore under mitigation—do not occur. Without usage data, there is no way to validate MM AQ-2. The CPUC has therefore decided that tracking is needed in order to monitor adequate implementation of MM AQ-2.

MM AQ-2 has not been revised in response to SCE's comment.

D2-67 The air quality analysis shows that unmitigated construction emissions would be above significance levels for NO<sub>X</sub>. The analysis shows that the use of higher tiered diesel engines (Tier III and Tier IV) would significantly reduce NO<sub>X</sub> emissions; however, the NO<sub>X</sub> emissions would still be above significance thresholds. While MM AQ-4 requires the purchase of NO<sub>X</sub> offset credits to reduce NO<sub>X</sub> emissions below significance thresholds, every effort must be made to reduce actual emissions.

The revisions to MM AQ-1 (see response to D2-65) require  $NO_x$  emission controls to the extent practicable; therefore, the language in MM AQ-3 has been revised to eliminate Option 2 given that best available control technology devices would not be available for the proposed project.

# Pages ES-6, 4.2-22, and 8-5:

<u>MM AQ-3</u>: Measures to Reduce NO<sub>x</sub> Emissions. Prior to construction, the applicant and SCE will submit proposed additional measures to reduce daily emissions of NO<sub>x</sub> to CPUC staff for review and approval, with the measures implemented depending on the amount of Tier III and Tier IV engines available at the time of construction. Measures may include the following:

- 1. The use of 2010 and newer haul trucks (e.g., material delivery trucks and soil import/export) or the use of trucks that meet EPA 2007 model year  $NO_X$  emissions requirements if 2010 model year or newer diesel trucks cannot be obtained.
- 2. A requirement that, during project construction, all construction equipment shall be outfitted with BACT devices certified by CARB and that achieve emissions reductions that are no less than what could be achieved by a Level 3

diesel emissions control strategy for a similarly sized engine as defined by CARB regulations.

- 3. Other measures as determined appropriate by the applicant <del>and SCE</del> in consultation with the SCAQMD.
- D2-68 See response to comment D2-66.
- D2-69 The following change to the description of non-native vegetation was made based on recommendations from SCE.

## Page 4.3-6:

This vegetation type is dominated by weedy non-native plants that thrive in areas repeatedly disturbed by human activity. In the proposed project area this vegetation type includes crimson fountain grass (*Pennisetum setaceum*), black mustard, short-podded mustard, wild radish, tocalote (*Centaurea melitensis*), prickly lettuce (*Lactuca serriola*), telegraph weed (*Heterotheca grandiflora*), Russian thistle (*Salsola tragus*), woolly mullein (*Verbascum thapsus*), and sweet fennel (*Foeniculum vulgare*). This habitat type typically supports few wildlife species but is used extensively by coastal California gnatcatcher for foraging and breeding to the south of the current Mesa Substation. Non-native vegetation within the proposed project area also supports <u>foraging</u> loggerhead shrike-and least Bell's vireo.

- D2-70 SCE identifies that some information provided in Appendix F of the Draft EIR (Rare Plant Survey Report) was not incorporated into Table 4.3-2 and suggests different conclusions for several species in Table 4.3-2. These changes suggested by SCE clarify, amplify, or make insignificant modifications to the EIR. The following three specific changes are suggested to this table by SCE:
  - 1. Adding that Nevin's barberry was observed during a protocol survey in 2015 and that the surveying biologist noted the individual appeared to be planted.

The following change was made to the EIR to provide additional information about species occurrences:

# Page 4.3-13:

*Present:* This species was observed in Whittier Narrows Natural Area adjacent to an existing distribution pole and paved pathway within the corridor for Telecommunications Route 3 during December 2014 field surveys <u>and spring 2015</u> <u>protocol surveys; however, it appears to be a planted individual</u>.

2. Modifying the listed potential to occur for intermediate mariposa-lily, Plummer's mariposa-lily, and Southern tarplant to reflect either a low potential to occur or that the species is absent from the proposed project area to reflect the 2015 Protocol Rare Plant Survey.

The rare plant survey report was included in the Draft EIR as Appendix F. Table 4.3-2 of the Draft EIR describes special status plant species present in the proposed project area or with a moderate or high potential to occur in the project area. Although the intermediate mariposa-lily, Plummer's mariposa-lily, and Southern tarplant were not observed during protocol surveys, they meet the definition of having a moderate or high potential to occur as defined on page 4.3-12. In the EIR, a species was considered to have a moderate potential to occur if three conditions were met:

- 1. The project area is located within the geographic range of the species.
- 2. Habitat is present in the project area but is of poor to marginal quality.
- 3. The species was observed between 1 and 5 miles from the proposed project area within the last 20 years.

Species were considered to have a high potential to occur if three conditions were met:

- 1. The project area is located within the geographic range of the species.
- 2. Suitable habitat is present in the project area.
- 3. The species has been observed within the last 20 years in the project area or within 1 mile of the project area.

The species' potentials to occur continue to meet these definitions listed in the Draft EIR. Lack of observed occurrences on the proposed Project site during 2015 protocol surveys is not determinative. The project area remains within the geographic range of these species. Poor to marginal quality habitat for the lilies is onsite, and populations 1 to 5 miles away were documented in 2015; therefore, both intermediate and Plummer's mariposa-lily continue to meet the definition of moderate potential to occur. Southern tarplant was observed within a half a mile and suitable habitat occurs along Telecommunications Route 3 adjacent to the Rio Hondo; thus, Southern tarplant continues to meet the definition of high potential to occur. Changes to the existing determination of potential to occur were not made because the definitions and determinations of likelihood were based on expert analysis and substantial evidence and still apply, even after consideration of SCE's comment. However, the following modifications to descriptions of the each plant were made to include additional detail from the referenced survey.

# 3. Incorporating the Coulter's matilija poppy into Table 4.3-2.

Coulter's matilija poppy is a California Native Plant Society (CNPS) rare plant ranked 4.2 and was identified during 2015 protocol rare plant surveys within the project survey area. The Draft EIR identified the presence of this species in Appendix F, the "Rare Plant Survey Report." The report describes the observation of a small patch of Coulter's matilija poppy (three individuals) within the Wittier Narrows Natural Area adjacent to a nature trail near Telecommunication Route 3. The report concludes that the poppy occurrence was planted and is outside project impact areas; examination of disturbance area locations confirms that the occurrence is outside planned project areas, including outside the known access road in Wittier Narrows. There are no other known occurrences within 5 miles of the project area, based on the CNDDB. Although not expected, if an individual of this species were to propagate in an area that would be impacted, mitigation already identified in the Draft EIR would avoid or reduce impacts to less than significant, including MM BR-8: Restoration of Special-status Plants. The following changes to the EIR were made.

# Page 4.3-32:

Additional mitigation measures specific to individual special-status species that have a moderate to high potential for presence, and may be impacted as a result of construction activities, are discussed in further detail below, by species. Specialstatus plants that are known to be present in the project area include Nevin's barberry, and Southern California black walnut, and Coulter's Matilija poppy. The

Southern tarplant, Plummer's mariposa-lily, and intermediate mariposa-lily have a moderate potential to occur.

# Page 4.3-34:

# Coulter's Matilija Poppy

<u>Coulter's Matilija poppy is not listed under FESA or CESA. However, Coulter's</u> <u>Matilija poppy is a CNPS rare plant ranked 4.2, meaning it is of limited distribution</u> <u>and moderately threatened in California. This species was identified during 2015</u> <u>protocol rare plant surveys within the project survey area. During these surveys, a</u> <u>small patch (three individuals) of the poppy was observed within the Whittier</u> <u>Narrows Natural Area adjacent to a nature trail near Telecommunications Route 3.</u> <u>The report generated from the surveys (Appendix F) concludes that the species</u> <u>occurrence was planted and would be outside of the proposed project area. There</u> <u>are no other known occurrences of this species within a 5-mile radius of the</u> <u>proposed project area.</u>

No project activities, including ground disturbance, equipment use, or vegetation

removal, are planned that would impact the known poppy occurrence. The nearest work activities would consist of installing telecommunications line on an existing pole approximately 100 feet away. SCE would utilize an existing access road and paved Nature Center trail south of the occurrence to install the cable and for maintenance activities during operations. While not expected, if an individual of this species were to be found in an area that would be impacted during construction, construction activities may result in direct impacts to the species. Indirect impacts could occur from the generation of fugitive dust or the spread of invasive weeds. These impacts to the poppy would be significant.

APM-BIO-01 and APM-BIO-02 would reduce impacts to this species by requiring pre-construction surveys for special-status plants and the development of a Revegetation Plan, and APM-AIR-01 would reduce excessive dust build-up that could indirectly impact this species; however, impacts would still be significant. Implementation of MM BR-1 would require pre-construction surveys in all areas of temporary and permanent disturbance. MM BR-2 would require that project work areas be clearly delineated to prevent inadvertent encroachment that would impact sensitive species or their habitat. MM BR-4 would require the preparation of a Noxious and Invasive Weed Control Plan and outlines requirements that must be included in the plan in order to reduce impacts associated with the spread of noxious and invasive weeds. MM BR-5 would require workers receive training in plant identification, the proposed project's environmental commitments, and how best to avoid impacting sensitive plant species. If a Coulter's Matilija poppy is found within the proposed project area, MM BR-8 would require avoidance or mitigation. Implementation of identified APMs, MM BR-1, MM BR-2, MM BR-4, MM BR-5, and MM BR-8 would reduce impacts on Coulter's Matilija poppy to a less than significant level.

# Page 4.3-62:

<u>MM BR-8</u>: Restoration of Special-status Plants. The applicant shall complete pre-construction surveys during the appropriate blooming period to identify special-status plants, including <u>Coulter's Matilija poppy</u>. Plummer's mariposa lily, intermediate mariposa lily, and Southern <del>California</del> tarplant populations in the proposed project component areas where suitable habitat is present. Special-status plants shall be identified by a qualified biologist and flagged or surrounded with fencing in such a way that disturbance of the populations or individuals shall be avoided.

D2-71 SCE requests the EIR be revised to say that least Bell's vireo was seen foraging during migration and not observed foraging at the Mesa Substation, but rather at the 500-kV transmission corridor adjacent to the substation. The text in Table 4.3-3 of the EIR has been revised to clarify where in the Mesa Substation area the occurrence was observed. The Biological Resources Technical Report (Appendix D of the Draft EIR) concludes that the species was observed foraging at the Mesa Substation site. The commenter does not provide sufficient evidence (e.g., additional information in a survey report) that the species was observed migrating instead of residing in the area; therefore, the EIR is not modified to identify this occurrence as "during migration" to avoid potential confusion.

Table 4.3-3 was revised as follows in response to this comment.

D2-72 The following changes have been made to clarify the Draft EIR's description of California black walnut, Nevin's barberry, and Southern tarplant's status as a special-status species.

## Page 4.3-33:

The California black walnut is ranked as an S3 species, indicating that the species is vulnerable (CDFW 2010). In addition, it is ranked by the CNPS as 4.2, indicating that the species is of limited distribution and is fairly endangered moderately threatened in California (CNPS 2015).

## Page 4.3-32:

Nevin's barberry is listed as endangered under the CESA and FESA and has a CNPS rare plant ranking of 1B.1, meaning that it is rare, threatened, or endangered in

California and elsewhere and is <del>extremely endangered</del><u>seriously</u> threatened in California

## Page 4.3-34:

Southern tarplant is not listed under FESA or CESA. However, it has a CNPS rare plant ranking of 1B.1, meaning that it is rare, threatened, or endangered in California and elsewhere and is <u>extremelyseriously endangeredthreatened</u> in California. This species is known to emerge readily after disturbance creates openings in the herbaceous layer. The species also contributes substantially to the soil seedbank (CCBER n.d.).

Additional changes were made to ensure consistency throughout the section regarding CNPS rare plant ranking definitions.

# Page 4.3-35:

Plummer's mariposa-lily is not listed under FESA or CESA. However, it has a CNPS rare plant ranking of 4.2, which means that it is a species of limited distribution and <u>moderately threatened</u> fairly endangered in California. Potential habitat for this species occurs along Telecommunications Route 3; however, this habitat is not of

high quality.

# Page 4.3-11:

These are further subcategorized by threat ranks:

- 0.1: Seriously threatened<del>endangered</del> in California
- 0.2: <u>Moderately threatened</u> Fairly endangered in California
- 0.3: Not very <u>threatened</u>endangered in California
- D2-73 Southern tarplant's potential to occur in the proposed project area meets the definition of "high potential to occur" as shown in the response to comment D2-70. The following correction to the description of the species' potential to occur was made.

## Page 4.3-35:

Work within suitable habitat where this species has <u>highmoderate</u> potential to occur primarily includes installation of telecommunications cable on existing poles. A 275-foot segment of telecommunications cable at the eastern terminus of Telecommunications Route 1 would also be installed underground in new conduit.

SCE comments that the California Department of Fish and Wildlife (CDFW) defines populations as occurrences in its California Natural Diversity Database (CNDDB). Further, SCE asserts that new occurrences of the species, up to 0.25 miles away, would be considered the same population as those plants recorded nearby in CNDDB and, because of this, impacts to a few individuals of a larger population would not necessarily constitute a significant impact.

CDFW has explained its mapping methodology for CNDDB in an introductory video available on its website: https://www.wildlife.ca.gov/Data/Training. Based on information in this tutorial, CDFW does not map populations of species on CNDDB. When evaluating individual species occurrences, even those reported with precise GPS coordinates, CDFW maps a minimum buffer of 1/8 mile around the coordinate. If two occurrences are close enough that the minimum buffer overlaps (i.e., within <sup>1</sup>/<sub>4</sub> of a mile), the occurrences are grouped together and considered to be the same. Specific polygons in CNDDB made up of several nearby occurrences may indicate a population of individual plants, but may also be multiple reports of the same individual, or may be separate individuals that are not considered a population. For these reasons, it cannot be concluded that an individual discovered in the Telecommunications Route 3 impact area would be automatically categorized by the CNDDB as part of the known nearby population. In addition, protocol surveys cannot prove absence of a species in a given area in the future, as the species may populate a new area. Thus, the reasons SCE provides for the substitution of "would" for "could" are not supported by the evidence presented.

CEQA Guidelines section 15064(f) requires that "[t]he decision as to whether a project may have one or more significant effects shall be based on substantial evidence in the record of the lead agency." The analysis of impacts on Southern tarplant is supported by substantial evidence, including analysis of potential habitat and known occurrences from multiple sources, including the Biological Resources Technical Report (Appendix D of the Draft EIR) and the rare plant surveys (Appendix F of the Draft EIR), as well as information regarding the CNDDB from CDFW. The conclusions in the EIR are supported by substantial evidence in the record, and therefore no changes were made to the EIR in response to this comment.

- D2-74 Plummer's mariposa-lily's potential to occur in the proposed project meets the definition of "moderate potential to occur" as discussed in the response to comment D2-70. SCE's additional recommendations are based on the assertion that the likelihood should be changed from "moderate potential" to "absent." Therefore, no further edits based on SCE's comment have been made.
- D2-75 Intermediate Mariposa-lily's potential to occur in the proposed project meets the definition of "moderate potential to occur" as discussed in the response to comment D2-70. SCE's additional recommendations are based on the assertion that the likelihood should be changed from moderate potential to absent. Therefore, no further edits based on SCE's comment were made.
- D2-76 SCE asserts that the discussion of impacts on amphibians within Impact BR-1 should be modified because they could not practically install fencing during telecommunication line stringing and that fencing could increase biological impacts. However, MM BR-2 does not require the installation of exclusionary fencing in all areas. MM BR-2 requires installation of exclusionary fencing around laydown and work and staging areas, where necessary and appropriate, to prevent inadvertent encroachment into adjacent habitat or the encroachment of special status species into work areas. As stated by SCE, the installation of fencing along roads for stringing telecommunications line may not be necessary and appropriate due the absence of ground disturbance activities or lack of adjacent habitat at these locations. Therefore, the EIR was not revised per SCE's suggestion in this comment; however, the following change was made to clarify the use of exclusionary fencing.

# Page 4.3-36:

Therefore, SCE would implement MM BR-1, which requires pre-construction surveys; MM BR-2, which requires installation of exclusionary fencing to delineate the designated work areas and avoid sensitive resources, <u>such as western</u> <u>spadefoot</u>, <u>as necessary and appropriate</u>; MM BR-5, which requires implementation of a WEAP to inform workers of the sensitive biological resources with a potential to be impacted by the project and relevant permits; MM BR-9, which requires the appropriate level of construction monitoring by a qualified biologist; and MM BR-10, which requires covering steep walled trenches and excavations at the end of each work day.

D2-77 The comment recommends text edits regarding white-tailed kite and additional text explaining why raptors are not discussed separately.

Nesting raptors are protected under the Migratory Bird Treaty Act and California Fish and Game Code, and impacts from construction activities could potentially occur on nesting raptors even though the potential for nesting of special-status raptor species is low. Contrary to SCE's comment that raptors are not discussed further, raptors are included in the general discussion of impacts from construction activities on nesting birds; thus, "raptors will not be discussed further" was not added to the text.

In response to this comment, the EIR text is modified as follows.

# Page 4.3-39:

The proposed project area contains suitable habitat for several special-status birds as well as those protected by the MBTA and Fish and Game Code. Raptor species, such as the peregrine falcon, <u>white-tailed kite</u>, and Swainson's hawk, were observed within the main project area during surveys and may have been foraging or flying through. <u>Due to limited habitat</u>, nesting of any of these raptor species in the proposed project area would be rare. Raptors likely would only occur during migration and/or foraging. In addition, coastal California gnatcatcher, least Bell's vireo, loggerhead shrike, and yellow warbler have been observed within the proposed project area and are therefore assumed to be present.

D2-78 SCE suggests that the areas of potential impact on coastal California gnatcatcher habitat in Table 4.3-4 of the Draft EIR should be separated into impacts on coastal sage scrub versus on "atypical habitat." (SCE's label for Table "3.4-4" appears to be a typographical error.) SCE also suggests revised acreage for these new categories. However, SCE does not define "atypical habitat" in the comment, and the Total Approximate Impact Area in the suggested revised table does not add up to be the sum of its column or row. Although the 2015 Biological Assessment included as Appendix G uses "atypical habitat," it does not define the vegetation or habitat types considered "atypical;" the Biological Assessment also acknowledges that gnatcatcher breeding has occurred in what it describes as "atypical habitat." Because of the lack of information and unclear acreage numbers, the CPUC cannot provide a specific response to the suggested revisions to the table.

Table 4.3-4 in the Draft EIR describes the impact areas as "approximate" and mitigation for actual impacts to gnatcatcher habitat would be finalized during the implementation of MM BR-3 and would be based on actual impacts. Thus, if the impacts are less than the amount approximated in Table 4.3-4, then only those impacts would require mitigation.

The Draft EIR uses the same considerations as the Biological Resources Technical Report (Appendix D of the Draft EIR) for determining suitable habitat for coastal California gnatcatcher. In the Draft EIR (page 4.3-40), suitable habitat is considered to be:

- Coastal sage scrub with greater than 50 percent cover, consisting of species such as California sagebrush and or California buckwheat, or
- Areas consisting of a matrix of sparse, scattered coastal sage scrub shrubs and annual/biennial vegetation with sufficient morphological structure and density to support coastal California gnatcatcher nesting and provide foraging opportunities.

As shown by comparing Figure 5 of Appendix D with Figure 4.3-1 of the Draft EIR, coastal California gnatcatcher has been observed numerous times over multiple years foraging and nesting in native and non-native vegetation in the project area. Figure 10 of Appendix D shows areas of expected temporary and permanent impacts on gnatcatcher habitat and considers native and non-native vegetation to be gnatcatcher habitat. Table 4.3-4 of the Draft EIR is consistent with the definition of gnatcatcher habitat described above and utilized in these figures. Much of the vegetation shown in these maps is considered non-native but is also considered suitable habitat based on the criteria in the second bullet point above, and the Biological Resources Technical Report (Appendix D) considers impacts on this non-native/ruderal vegetation to be impacts on coastal California gnatcatcher habitat. The 2015 protocol survey for gnatcatcher mentioned by SCE in the comment was considered in the Draft EIR and included as Attachment A of Appendix G. The 2015 survey found multiple gnatcatchers nesting and foraging in the project area and does not provide a new definition for gnatcatcher habitat, as claimed by SCE. It is unclear how this survey limits what is considered gnatcatcher habitat or reduces the area of impact on gnatcatcher habitat, as claimed by SCE.

Furthermore, USFWS commented that the remaining gnatcatcher habitat in the project area provides connectivity between gnatcatcher populations and is important for maintaining a viable population in the northern range of the species (Medak pers. comm. 2015). In addition, USFWS's comment on the Draft EIR acknowledges that the area adjacent to the Mesa Substation is gnatcatcher habitat, including the non-native vegetation that supports gnatcatcher foraging/sheltering, and the USFWS recommended an increase in mitigation ratio for all gnatcatcher habitat permanently impacted by the project. In these comments, USFWS does not discount non-native vegetation that supports gnatcatchers nor suggest less mitigation.

CEQA Guidelines section 15064(f) requires that "[t]he decision as to whether a project may have one or more significant effects shall be based on substantial evidence in the record of the lead agency." The analysis of impacts on gnatcatchers is supported by substantial evidence, including analysis of potential habitat presented in the Biological Resources Technical Report and the known occurrences from multiple sources, including the Biological Resources Technical Report and the 2015 gnatcatcher protocol surveys, as well as information from the USFWS. The commenter does not provide specific evidence as to why the analysis in the document is inadequate. The conclusions in the Draft EIR are supported by substantial evidence in the record, and no changes were made to the Draft EIR in response to this comment.

See also response to comment D1-20 for a discussion of gnatcatcher habitat.

D2-79 SCE asserts that ruderal vegetation and non-native vegetation is atypical habitat for coastal California gnatcatcher as described in the 2015 protocol surveys for gnatcatcher (included as Attachment A in Appendix G of the Draft EIR) and the EIR should not consider these areas "suitable habitat" for the gnatcatcher. SCE recommends changing the impact analysis to consider only coastal sage scrub as suitable habitat.

During preparation of the Draft EIR, USFWS commented that the remaining

gnatcatcher habitat in the project area, including the area within the substation footprint (which contains native and non-native vegetation), provides connectivity between gnatcatcher populations and is important for maintaining a viable population in the northern range of the species (Medak pers. comm. 2015). In addition, USFWS's comment on the Draft EIR (see comment A3-1) acknowledges that the area adjacent to the Mesa Substation is gnatcatcher habitat, including the non-native vegetation that supports gnatcatcher foraging/sheltering, and recommended an increase in the mitigation ratio for all gnatcatcher habitat permanently impacted by the project. In these comments, USFWS does not discount non-native vegetation that supports gnatcatchers nor suggest less mitigation for impacts on habitat with non-native vegetation.

The Draft EIR uses the same considerations as the Biological Resources Technical Report (Appendix D of the Draft EIR) for determining suitable habitat for coastal California gnatcatcher. In the Draft EIR (p. 4.3- 40), suitable habitat is considered to be:

- Coastal sage scrub with greater than 50 percent cover, consisting of species such as California sagebrush and or California buckwheat, or
- Areas consisting of a matrix of sparse, scattered coastal sage scrub shrubs and annual/biennial vegetation with sufficient morphological structure and density to support coastal California gnatcatcher nesting and provide foraging opportunities.

As shown by comparing Figure 5 of Appendix D with Figure 4.3-1 of the Draft EIR, coastal California gnatcatcher has been observed numerous times over multiple years foraging and nesting in native and non-native vegetation in the project area. Figure 10 of Appendix D shows areas of expected temporary and permanent impacts on gnatcatcher habitat and considers native and non-native vegetation to be gnatcatcher habitat. Table 4.3-4 of the Draft EIR is consistent with the definition of gnatcatcher habitat described above and utilized in these figures. Much of the vegetation shown in these maps is considered non-native but is also considered suitable habitat based on the criteria in the second bullet point above, and the Biological Resources Technical Report (Appendix D of the Draft EIR) considers impacts on this non-native/ruderal vegetation to be impacts on coastal California gnatcatcher habitat.

Multiple surveys conducted between 2011 and 2015 documented gnatcatchers using ruderal vegetation, non-native vegetation, and coastal sage scrub in this area. The 2015 protocol survey for gnatcatchers mentioned by SCE in the comment was considered in the Draft EIR; the survey is included as Attachment A of Appendix G of the Draft EIR. The 2015 survey found multiple gnatcatchers nesting and foraging in the project area and does not discount the previous years' occurrences in non-native vegetation. Nesting attempts and successful nesting have been documented within the non-native vegetation (Figure 5: Map 1 of 5 of the Draft EIR's Appendix D, Figure 3A of Attachment A of the Draft EIR's Appendix G, Figure 4.3-1 of the Draft EIR) and gnatcatchers appear to be utilizing non-native vegetation for foraging during nesting season as well. It is unclear how the 2015 survey redefines what is considered gnatcatcher habitat, why some of the gnatcatcher habitat in the area should be considered "atypical," or how it reduces the area of impact on gnatcatcher habitat, as claimed by SCE.

CEQA Guidelines section 15064(f) requires that "[t]he decision as to whether a project may have one or more significant effects shall be based on substantial evidence in the record of the lead agency." The analysis of impacts on gnatcatchers is supported by substantial evidence, including analysis of potential habitat presented in the Biological Resources Technical Report and the known occurrences from multiple sources, including the Biological Resources Technical Report and the 2015 gnatcatcher protocol surveys, as well as information from the USFWS. The commenter does not provide specific evidence as to why the analysis in the document is inadequate. The conclusions in the Draft EIR are supported by substantial evidence in the record, and no changes were made to the EIR in response to this comment.

D2-80 SCE states its disagreement that least Bell's vireo was observed foraging at the Mesa Substation site, asserts the potential for direct impact to the species would only occur within the Telecommunications Route 3, and recommends several changes to the Draft EIR.

The Biological Resources Technical Report prepared by Insignia Environmental in 2015 for SCE (Appendix D of the Draft EIR) cites surveys conducted, concludes that the species was observed foraging in the transmission corridor adjacent to the Mesa Substation, and considers it present. While SCE describes the mulefat scrub as of marginal quality, it does not provide sufficient information to support an alternate conclusion that the species would not have been observed foraging as a resident of the area. Therefore, SCE's requested revision to emphasize migration was not made. However, the following revision was made to clarify where in the proposed project area the species was found.

# Page 4.3-40:

Least Bell's vireo is a federally and state endangered species. It has been observed foraging within-the proposed Mesa Substation site area and adjacent the 500-kV transmission line corridor adjacent to the Mesa Substation as well as nesting along portions of Telecommunications Route 3. Construction activities, such as clearing vegetation and grading within the proposed Mesa Substation site in the transmission corridor and along Telecommunications Route 3, could result in direct impacts including injury or mortality to an individual least Bell's vireo or the loss of a nest as a result of human presence, dust, or noise. Construction activities could also result in indirect impacts such as the disruption of nesting or foraging behaviors or the loss of habitat. Impacts to least Bell's vireo would be significant.

D2-81 SCE commented that the protocol rare plant survey (Appendix F of the Draft EIR) should be included as evidence that no burrowing owls or signs were observed in the project area. However, the protocol plant survey report methodology and results do not provide any information on training of surveyors or search methodology by surveyors pertaining to burrowing owl or any wildlife. During the rare plant surveys, botanical specialists followed a specific protocol published by CDFW and CNPS as described in Appendix F; the protocol does not include searches for burrowing owl. SCE does not provide specific evidence that the rare plant survey may be used to show the absence of or signs of burrowing owls. Therefore, no changes were made to the EIR.

D2-82 SCE states that coordination of its O&M activities with Metropolitan Water District's O&M activities related to the relocated Middle Feeder pipe is needed and suggests including Metropolitan Water District's O&M activities in this section. The following clarification to the EIR has been made based on SCE's comment:

### Page 4.3-44:

Operation of the proposed project would be similar to ongoing maintenance activities of existing electrical infrastructure <u>and would include O&M activities</u> <u>related to MWD's relocated Middle Feeder</u>. There would be no increase in the number of employees or level of service required to maintain the proposed infrastructure.

D2-83 In this comment, the CPUC requested copies of SCE's applications for CWA permits and associated correspondence with the United States Army Corps of Engineers (USACE), Regional Water Quality Control Board (RWQCB), and CDFW to verify updated impact acreages. SCE provided copies of their 1602 Notification of Lake and Streambed Alteration Agreement to CDFW, Section 401 Water Quality Certification to the RWQCB, and Section 404 Nationwide Permit Application to USACE. Information in the Section 401 application corresponds to SCE's suggested edit to the Draft EIR for acres of waters of the U.S. This change has been made to the EIR. Estimated impact acreage to jurisdictional streambed and associated riparian habitat listed in the 1602 Notification of Lake and Streambed Alteration Agreement is slightly lower than SCE's estimate provided in the comment. SCE's slightly higher estimate was added to the EIR based on SCE's suggestion. The following revision has been made to the EIR to reflect impact estimates from documents provided by SCE.

# Page 4.3-51:

Construction activities within the proposed Mesa Substation site area, adjacent power line corridors, and work within staging yards would result in direct, permanent impacts on wetlands (including drainages) as defined by Section 404 of the CWA. Of the potentially jurisdictional aquatic features within the proposed project area, approximately <del>3.7</del> <u>0.37 acres of waters of the US (USACE/RWQCB) and 2.66 acres of jurisdictional streambed and associated riparian habitat (CDFW)</u> may be permanently impacted, and much of these impacts would occur within the footprint of the new Mesa Substation (Insignia 2015b SCE 2016). These impacts would result from grading associated with construction of the new 220-kV substation infrastructure on the western portion of the substation site, ground disturbance associated with site preparation and construction of the 500-kV substation infrastructure on the eastern portion of the substation site, installation of new fence around substation perimeter, constructing new access roads, and construction of a new retention basin in the southwest portion of the substation site.

D2-84 SCE asserts that there is no justification for pre-construction surveys to be completed within 14 days prior to construction outside of the nesting bird season and

recommends altering the text in MM BR-1 to allow surveys to be performed up to 30 days before construction outside of the nesting season.

MM BR-1 requires that pre-construction surveys are completed by a qualified biologist and conducted for all sensitive biological resources, including special-status plants and wildlife. Surveys are not limited to nesting birds alone. Further, the measure indicates surveys shall be species and resource appropriate. Special status wildlife including western spadefoot toad, Belding's orange-throated whiptail, western pond turtle, southern grasshopper mouse, and several species of birds may occur throughout the year. A survey within 14 days of the beginning of construction in an area is an appropriate amount of time to schedule and perform surveys and develop any siteand resource- specific actions needed to minimize impacts on sensitive resources from project-related activities, while also minimizing the opportunity for new species to move into the area before construction actually begins. Once a pre-construction survey has been performed, the measure does not require that they are repeated as long as construction is ongoing in the area. To clarify the frequency of these surveys, the following changes were made to MM BR-1.

# Pages ES-7, 4.3-57 through 4.3-58, and 8-11;

Prior to construction and activities <u>in a new work area</u> that may include vegetation clearing, staging, and stockpiling, or other activities with the potential to directly or indirectly affect wildlife, the applicant shall retain a qualified biologist approved by the CPUC to conduct pre-construction surveys for sensitive biological resources, including special-status plant species and special-status wildlife, and nesting birds in all areas of temporary and permanent disturbance. Pre-construction surveys shall be species and resource appropriate and typically conducted a maximum of 14 days prior to construction, as approved by the CPUC<del>;</del>. If there is no work in an area for 14 days or more, the area shall be considered a "new work area" if construction begins again. <del>n</del>Nesting bird and burrowing owl pre-construction surveys shall be consistent with the timing specified in the Nesting Bird Management Plan required by MM BR-11.

D2-85 SCE is correct that western-spadefoot toad is not listed under the federal Endangered Species Act or California Endangered Species Act. The comment also points out that exclusionary fencing is routinely utilized to mitigate impacts for listed reptiles and amphibians.

CEQA does not limit the consideration of biological impacts to listed species; rather a broader definition of endangered, rare, or threatened species is defined under section 15380 of the CEQA Guidelines. In compliance with CEQA's definitions of endangered, rare, or threatened species, the EIR considers impacts to "special-status species." Section 4.3.1.3 of the Draft EIR lists the criteria used to identify special-status species; special-status species include those listed by CDFW as Species of Special Concern (SSC). The western-spadefoot toad is a SSC and, therefore, it is considered a special-status species in the EIR. The implementation of exclusionary fencing to mitigate impacts to this species would also be appropriate given its status, as well as appropriate for other sensitive resources.

The intent of MM BR-2 is primarily to define the limits of construction and prevent project activities from encroaching into adjacent areas. As SCE points out, fencing could also be used to exclude reptiles and amphibians, including western spadefoot toad, from work areas that occur in their habitat. Fencing is a valid form of delineating a work area and may be the most appropriate way to do so in certain areas, such as areas used repeatedly (e.g., laydown, staging, and certain work areas). The appropriate use of fencing would reduce the level of monitoring required in those areas and, in many cases, the potential impact from installing the fence would be less than the potential impact on sensitive resources, such as the spadefoot toad, due to, for example, vehicle or equipment encroachment into habitat. In addition, fencing is more visible than signage or flagging in certain situations (e.g., by equipment drivers) and thus may help maintain compliance. As stated by SCE, the installation of fencing along roads for stringing telecommunications line may not be necessary and appropriate due to the absence of ground disturbing activities and absence of adjacent habitat at these locations.

The text has been modified to clarify that fencing is not required by MM BR-2, but remains an appropriate option.

### Pages ES-7, 4.3-57, and 8-12:

In all locations of the project, construction activities, vehicular traffic (including movement of all equipment), and storage of construction materials shall be restricted to approved access roads and established construction areas indicated by flagging, fencing, and/or signage. The applicant shall ensure that exclusionary fencing is installed prior to the start of construction activities around laydown and work and staging areas, where necessary <u>and appropriate</u>, to prevent inadvertent encroachment into the <u>project area by special status species and the inadvertent encroachment by project activities into habitat adjacent to areas of impact</u>.

D2-86 SCE asserts that MM BR-3 may contain contradictory language and disagrees with an interpretation of the measure that requires the restoration of ruderal areas to coastal sage scrub. SCE claims there is no evidence that ruderal areas were previously coastal sage scrub and states that the ruderal vegetation is part of the preexisting condition and mitigation should not be required.

During preparation of the Draft EIR, USFWS (Medak pers. comm. 2015) commented that the remaining gnatcatcher habitat in the project area, including the area within the substation footprint, provides connectivity between gnatcatcher populations, is important for maintaining a viable population in the northern range of the species, and is critical for resiliency in response to changing vegetation and climatic conditions. USFWS recommended that the substation be designed to avoid and minimize impacts on gnatcatcher habitat, and that remaining open space surrounding the substation and within temporary impact areas be restored with native scrub habitat and managed in a manner that would support gnatcatchers over the long term.

Comments on the Draft EIR from CDFW and USFWS state that impacts from the temporal loss of sensitive communities, including communities that support coastal California gnatcatcher, remain significant with the mitigation described in the Draft

EIR's MM BR-3 and that mitigation for these communities should strive to result in superior habitat quality and quantity than that which was impacted to account for temporal loss (see comment A1-3). MM BR-3 has been revised to include recommendations from the wildlife agencies as shown in response to comment A1-3. SCE's recommendation to eliminate the restoration requirement for non-coastal sage scrub used by gnatcatcher contradicts recommendations and comments from the wildlife agencies and would reduce the effectiveness of mitigation to compensate for impacts due to, e.g., temporal loss. As recommended by both USFWS and CDFW, mitigation for impacts to gnatcatcher habitat should increase the quantity and quality of habitat used by the gnatcatcher in order to be effective. As discussed in responses to comments D1-20, D2-78, D2-79, gnatcatchers utilize non-coastal sage scrub habitat for forage, resting, and dispersal, and have also been documented as nesting in such areas.

CEQA Guidelines section 15064(f) requires that "[t]he decision as to whether a project may have one or more significant effects shall be based on substantial evidence in the record of the lead agency." The analysis of impacts on sensitive communities, including communities that support coastal California gnatcatcher, is supported by substantial evidence, including analysis of sensitive communities and suitable gnatcatcher habitat, as well as specific information from the USFWS. SCE does not provide specific evidence that the analysis in the document is inadequate. The conclusions in the Draft EIR are supported by substantial evidence in the record and expert analysis, and no changes were made to the EIR in response to this comment.

D2-87 SCE states that the existing sensitive natural communities within proposed project area do not have 80percent cover and MM BR-3 should be revised to require 70 percent relative cover to match the anticipated SWPPP's requirements. SWPPP requirements focus on soil stability and erosion prevention and they do not necessarily mitigate impacts to sensitive biological resources.

SCE appears to interpret the percent cover requirement in MM BR-3 to describe the density of the canopy for every sensitive natural community. However, the mitigation measure requires that at least 80 percent of the native plants restored would be successfully established after a minimum of four years. In response to this comment, the revised MM BR-3 text includes an edit to clarify the description of the 80 percent cover success criterion. The full text of the revised MM BR-3 is included in response to comment A1-3.

# Pages ES-8, 4.3-58, and 8-12:

• All temporarily impacted areas shall be restored. All temporary disturbances to sensitive natural communities shall be restored with the pre-disturbance natural community (except for areas burned in the 2015 "Lincoln" fire, which shall be restored to the pre-fire natural community). All other temporarily impacted areas observed to be utilized by the coastal California gnatcatcher shall be restored with the appropriate coastal sage scrub community if feasible and appropriate. Temporary impacts on sensitive natural communities and habitat utilized by gnatcatchers shall be mitigated by restoration at a minimum ratio of 1.5:1; if restoration is not feasible within 1 mile of the project area, SCE shall purchase credits and/or mitigation lands at a minimum ratio of 2.5:1 from

an entity approved by CDFW and USFWS, as appropriate. Areas that do not provide habitat to coastal California gnatcatcher, other special-status species, or sensitive resources may be restored to the conditions agreed upon between the landowner and the applicant.

- The restoration plan shall specify how each type of vegetation community, including sensitive natural communities, shall be addressed in terms of the following restoration details: topsoil segregation and conservation; vegetation treatment and removal; revegetation methods, including seed mixes, rates, <u>appropriate habitat structure</u>, and transplants; criteria to monitor and evaluate revegetation success (minimum of four years of monitoring and 80% <u>successful native plant establishmentcover for sensitive natural communities</u>); and compensation and remedial measures to be implemented as needed.
- For sensitive natural communities, mitigation of permanent impacts shall occur after construction at a <u>minimum</u> level of 1.5:1. In addition, permanent disturbances to coastal California gnatcatcher habitat that is not coastal sage scrub or another sensitive natural community shall be mitigated at a <u>minimum</u> 1.5:1 ratio with appropriate coastal sage scrub. Mitigation for permanent impacts shall be completed through one of the following methods:
  - 1. Establishing the natural community within the proposed project areas (onsite);
  - 2. Establishing the natural community outside the proposed project areas (within one mile of the project area); or
  - 3. If Options 1 and 2 are not feasible, SCE shall purchase credits and/or mitigation lands at a <u>minimum</u> ratio of 2<u>.5</u>:1 from an entity approved by CDFW and USFWS, as appropriate.
- D2-88 SCE's comment asserts that ruderal habitat does not qualify as habitat for coastal California gnatcatcher except when it is adjacent to coastal sage scrub and that MM BR-3 requires mitigation for an existing condition. SCE suggests modifying MM BR-3 to reduce the mitigation ratio and modify restoration criteria. As stated in comment response D2-86, USFWS considers the open space surrounding the Mesa Substation to be gnatcatcher "habitat" and critical for the resiliency of the gnatcatcher. USFWS and CDFW both recommend mitigation ratios higher than those included in the Draft EIR and suggested by SCE in this comment. Revisions to the EIR to address the comments made by the wildlife agencies have been made as shown in response to comment A1-3.

While SCE correctly states that no regulatory framework specifically protects "atypical" or non-habitat for gnatcatcher, Appendix G of the CEQA Guidelines suggests biological impacts consider habitat modifications for special status species. In addition, the wildlife agencies, which have regulatory authority over this species (federal Endangered Species Act, California Fish and Game Code Section 3503), suggested that the remaining open space surrounding the substation and within temporary impact areas be restored with native scrub habitat to support gnatcatchers on the property in the future as mitigation for spatial and temporal temporary impacts on gnatcatcher habitat. MM BR-3, as revised, describes a level of restoration and mitigation deemed appropriate by the wildlife agencies and the CPUC.

CEQA Guidelines section 15064(f) requires that "[t]he decision as to whether a project may have one or more significant effects shall be based on substantial evidence in the record of the lead agency." The analysis of impacts on sensitive communities, including communities that support coastal California gnatcatcher, is supported by substantial evidence, including recommendations by the wildlife agencies and the extensive documentation of gnatcatcher in ruderal, non-native, and coastal sage scrub in the project area. SCE does not provide specific evidence that the analysis in the document is inadequate. The conclusions in the Draft EIR are supported by substantial evidence in the record, and no changes were made to the EIR in response to this comment.

D2-89 SCE makes the same assertions as those stated in comment D2-87. As written in the comment response to D2-87, SWPPP requirements focus on soil stability and erosion prevention and they do not necessarily correlate to restoration for impacts to biological resources. See response to comment D2-87.

Also, see the full text of revised MM BR-3 in response to comment A1-3.

D2-90 SCE requests modifying the requirements of MM BR-3 to allow trimming conducted outside of the nesting bird season to occur without monitoring. MM BR-3 is intended to mitigate impacts on sensitive natural communities, all coastal California gnatcatcher habitat, and riparian habitat. To ensure trimming of native vegetation, riparian vegetation, and vegetation that provide habitat for coastal California gnatcatcher is kept to the minimum necessary and does not disturb any sensitive resources, monitoring is required. Trimming of native trees and arborescent shrubs also requires monitoring for the same reasons. SCE does not justify their request to modify the mitigation measure. Therefore, no changes were made based on SCE's comment. However, the following change was made to clarify monitoring requirements.

### Pages ES-8, 4.3-59, and 8-13:

To minimize the removal of vegetation in habitat areas of the coastal California gnatcatcher, SCE shall ensure that trimming of all native vegetation, riparian vegetation, and vegetation that provides potential habitat for coastal California gnatcatcher is monitored by a qualified biologist approved by the CPUC. Trimming of native trees and native arborescent shrubs shall be completed outside of the nesting bird season and shall be monitored by a qualified arborist biologist.

D2-91 SCE suggests revising the Draft EIR to eliminate the CDFW consultation requirement for the development of the Noxious and Invasive Weed Control Plan. MM BR-4 has been revised consistent with this recommendation.

### Pages ES-8, 4.3-60, and 8-13:

This plan shall include measures designed to avoid the introduction and spread of noxious weeds and invasive plant species designated by the state, the counties, and local weed control boards. This plan shall be developed in consultation with <del>CDFW</del> and <u>the</u> CPUC and shall be provided to these agencies for review and comment. The plan must be submitted to the CPUC 60 days prior to the planned start of construction. CPUC approval is required before the plan is implemented.

D2-92 SCE states that the Mesa project is within the same weed zone. It is unclear what is meant by "weed zone;" however, SCE goes on to state that the project area consists entirely of invasive species. SCE claims that the addition of water to the site via wash stations, even when contained, would increase biological impacts because annual invasive plants would increase near the wash stations.

> While the proposed project lies within an urbanized area where non-native invasive plants are prevalent, a variety of vegetation types and native plant species were documented in biological surveys. As described in Table 4.3-1 of the Draft EIR, "Vegetation Communities in the Survey Area," plant communities with native species include California Annual Grassland, Diegan Coastal Sage Scrub, Mulefat Scrub, Riparian Woodland, Southern California Walnut Woodland, Southern Coast Live Oak Woodland, Southern Sycamore-Alder Riparian Woodland, Intermittent Drainages, and Ephemeral Drainages. Wash stations, when installed and used properly, will contain any water potentially containing plant parts or seeds. Wash station water is then disposed of at a waste management facility or incinerator. Prevention of invasive weed spread will reduce impacts to areas with native plants, native vegetation types, and would increase the likelihood that temporarily impacted areas are successfully restored. Therefore, no change to the EIR was made.

D2-93 To incorporate SCE's recommendations regarding invasive species monitoring, the following changes to MM BR-4 (Noxious and Invasive Weed Control Plan) have been made:

# Pages ES-9, 4.3-60, and 8-13:

- All seeds to be used in revegetation and reclamation activities shall come from weed-free sources.
- All temporary disturbance areas that will be restored post-construction shall be monitored for invasive species establishment on a monthly basis <u>during the growing season and on a quarterly basis outside of the growing season</u> for at least one year after project restoration is completed. If evidence of the expansion or increase in abundance of a known invasive species or introduction of a new invasive species is found, the applicant shall initiate appropriate control measures, which may include mowing or trimming of weeds prior to seed set, as outlined in the plan.

Several natural communities, including sensitive natural communities, were found onsite during surveys as described in Table 4.3-1 of the Draft EIR. Loss of habitat would be a significant impact to several species as described under Impact BIO-1 of the Draft EIR and significant for sensitive natural communities as described under Impact BIO-2. MM BR-3 requires temporarily disturbed areas be restored to pre-construction sensitive natural communities, if present prior to construction, or coastal sage scrub if feasible. Restoration success criterion is defined as 80 percent successful native plant establishment. SCE would be required to monitor for non-native invasive species such that they not exceed 20 percent of the plant establishment at restoration areas. Therefore, no further changes to the EIR were made based on this comment. D2-94 Impact BIO-1 of the Draft EIR discusses impacts on Nevin's barberry. Direct and indirect impacts on this species, a state and federally listed endangered species, could occur from activities associated with installation of a telecommunications line including trampling during stringing or pulling, driving over the plant, and the spread of fugitive dust or weeds. If these impacts occurred, impacts from these activities would be significant. MM BR-6 requires that the proposed project is designed to avoid direct and indirect impacts on Nevin's barberry by ensuring project activities avoid the plant. SCE states that surveys for the proposed project were conducted previously and sufficiently meet the survey requirements of this mitigation measure. Pre-construction surveys are required in this mitigation measure and, similar to the pre-construction surveys described in MM BR-1, the information gathered from the surveys shall be used to develop site and resource specific actions. In the case of Nevin's barberry, this would include establishing the initial buffer of 200 feet around individuals. The surveys completed previously do not meet the requirements of pre-construction surveys described in the Draft EIR. No changes to the survey requirements were made.

SCE states that a "biologist" is too general of a term and that a botanist should be used to identify species and determine impacts. Because protocol level surveys are not required by this mitigation measure, the CPUC would review and approve the surveying biologist to make sure that the biologist doing the surveys have expertise with rare plants in southern California, a more specific title of botanist is not necessary.

SCE states that the known Nevin's barberry is within 15 feet of the existing and maintained access road and claims that the buffer requirements listed in MM BR-6 would result in more impacts because with the smallest buffer—25 feet—a new road would need to be constructed to access the site and this road would be in nesting habitat for least Bell's vireo and coastal California gnatcatcher. The distance of 25 feet in the measure was intended to provide SCE the flexibility to continue to utilize the access road if SCE can do so without impacting Nevin's barberry and if the reduced buffer is approved by the CPUC after coordination with USFWS. The following changes to the mitigation measure were made based on SCE's comment to clarify survey requirements and correct the distance from the access road to the known Nevin's barberry.

# Pages ES-9, 4.3-61, and 8-13:

The project shall be designed to avoid impacts on occurrences of Nevin's barberry during construction and operation and maintenance. Prior to the start of construction, the applicant's CPUC-approved qualified biologist shall complete preconstruction surveys in suitable habitat during the appropriate blooming period to identify any occurrences. Where Nevin's barberry occurs, all construction and operation and maintenance activities shall occur outside a restrictive buffer, which shall be established by a CPUC-approved qualified biologist. Vehicles and crew members shall be prohibited from coming within 200 feet of identified Nevin's barberry unless a buffer reduction is approved by the CPUC after consultation\_coordination with USFWS. A reduced buffer shall be a minimum of approximately 1525 feet or greater from a Nevin's barberry plant. A qualified biologist approved by the CPUC shall monitor crew members and the Nevin's

barberry to ensure all project activities stay away from Nevin's barberry within the buffer.

D2-95 Southern California black walnut is considered a special-status plant in the Draft EIR. SCE asserts that the same mitigation measures should apply to all special-status plants (with the exception of Nevin's barberry) and that MM BR-7 and MM BR-8 are potentially conflicting. SCE states that MM BR-7 implies surveys only for known individuals would occur whereas MM BR-8 requires surveys to identify new individuals.

MM BR-7 requires an "evaluation survey" by a qualified arborist for all black walnut trees within 25 feet of construction activities; in order to meet this requirement, SCE must evaluate previously known trees and trees discovered during pre-construction surveys. As stated in the measure, the arborist would record a brief description of each tree (e.g., location, height, diameter at breast height, condition). These "evaluation surveys" do not conflict with the requirement of a pre-construction survey described in MM BR-8.

SCE also claims that the mitigation measures are conflicting because MM BR-8 includes the purchase of credits and MM BR-7 does not. SCE would prefer that MM BR-7 includes the option of mitigating through the purchase of offsite credits in order to have the flexibility to avoid planting trees under powerlines. MM BR-7 was modified to incorporate SCE's request as shown below.

SCE identifies an inconsistency in the ratio for Southern California black walnut mitigation in the Draft EIR. The mitigation ratio described in MM BR-7 contained a typographical error and has been corrected.

Because Southern California black walnut occur in habitat that is used for foraging by loggerhead shrike, a CDFW species of special concern, and nesting and foraging by coastal California gnatcatcher, a federally endangered species, USFWS and CDFW should be included in mitigation decisions regarding replacement of trees.

Changes to MM BR-7 were made as follows:

### Pages ES-9, 4.3-61, 8-14:

<u>MM BR-7</u>: Restoration of Southern California Black Walnut. SCE shall take measures to avoid and minimize impacts on Southern California black walnut resulting from project construction activities, and shall plant replacement trees for any impacted or removed specimens. Prior to construction (after completion of final engineering design of project features), black walnut tree evaluation surveys shall be completed by a qualified arborist (an arborist with extensive local or regional expertise in the planting, care, and maintenance of black walnut trees). The arborist must be approved by the CPUC. The arborist shall record a brief description (e.g., location, height, diameter at breast height, condition) of each black walnut tree with a dripline within 25 feet of construction activities. All construction activities that take place within the driplines of black walnut trees (i.e., the outermost extent of the canopy) that are not being intentionally removed shall be monitored by a qualified arborist to reduce, to the extent feasible, impacts on the tree, including roots.

California black walnut trees that are impacted within the drip line or intentionally removed shall be replaced at a 23:1 ratio. If the diameter at breast height of the tree to be removed is 24 inches or less, it shall be replaced with a 24-inch box tree. If the diameter at breast height of the tree to be removed is greater than 24 inches, it shall be replaced with a 36-inch box tree. Replacement trees shall be planted on site as near to the original location as feasible and biologically appropriate, and shall be monitored by a qualified arborist who will ensure the replacement trees are placed in a suitable area. Replacement trees shall be monitored for seven years after the initial planting or until the arborist determines that 80 percent of trees are successfully established. If onsite replacement is not feasible, SCE shall plant replacement trees offsite as near to the proposed project as is appropriate and feasible. The same monitoring requirements and success criteria would apply as for those trees planted onsite. If neither of the two options above are feasible, SCE shall purchase credits and/or mitigation lands from an entity approved by CDFW such that a restoration ratio of 4:1 is achieved.

Tree removal shall not be permitted until a detailed plan for restoration, including identification of planting location, <u>or offsite mitigation lands</u>, is approved by the CPUC, and in consultation with USFWS and CDFW. Replacement trees shall be planted before tree removal, or if not feasible or if potentially harmful to the replacement trees, as soon as possible after removal.

Changes to MM BR-8 to clarify requirements related to Southern California black walnut were made as follows:

# Pages ES-9, 4.3-62, and 8-14:

Special-status plants shall be identified by a qualified biologist and flagged or surrounded with fencing in such a way that disturbance of the populations or individuals shall be avoided. In the event that populations or individuals <u>of specialstatus plants (other than Southern California black walnut—see MM BR-7</u>) cannot be avoided, the applicant shall develop and implement a restoration plan for each plant which will be submitted to CPUC and CDFW for review and comment no less than 60 days prior to construction activities within the work area where impacts would occur. <u>The CPUC will coordinate with<del>and CDFW, and</del> CPUC approval is required before the plan is implemented. <u>In the case of Southern California black walnut trees, a</u> restoration plan will be completed and approved as described in MM BR-7.</u>

- D2-96 As requested by SCE, changes have been made to allow mitigation of impacts to Southern California black walnut trees through the purchase of offsite mitigation lands. Refer to the response to comment D2-95 for specific changes.
- D2-97 As presented in SCE's comment, changes have been made to correct the inconsistency between the impact analysis and MM BR-7. Refer to the response to comment D2-95 for specific changes.

- D2-98 As stated by SCE, CDFW and USFWS do not have jurisdiction over Southern California black walnut trees, unless associated with a jurisdictional drainage. However, as discussed in the Draft EIR, because Southern California black walnut trees occur in habitat that is used for foraging by loggerhead shrike, a CDFW species of special concern, and nesting and foraging for coastal California gnatcatcher, a federally endangered species, USFWS and CDFW should be consulted regarding mitigation of walnut trees. The changes recommended in this comment were not incorporated into the EIR.
- D2-99 The Nesting Bird Management Plan (NBMP) described in MM BR-11 is intended to contain information regarding how SCE plans to reduce impacts to less than significant on nesting birds, including those listed under the federal or state endangered species acts as well as those covered under Migratory Bird Treaty Act or the California Fish and Game Code (described under Impact BIO-1 of the Draft EIR). The applicant is independently required to comply with the federal and state endangered species acts. Specific biological resource mitigation measure requirements in this EIR may be satisfied through compliance with permit conditions, or other authorizations obtained by the applicant, if these requirements are equally or more effective than the mitigation identified in this EIR. Permit conditions and other measures required to comply with the endangered species acts could be referenced or included in the NBMP as appropriate. Similar to the recently approved NBMP for the Santa Barbara County Reliability Project, the CPUC would like the Mesa NBMP to contain all birds that have the potential to occur on site in order to have a comprehensive document for biologists and monitors to utilize. One comprehensive document would decrease confusion that could occur due to the different requirements for the various bird species.

The revisions recommended in this comment were not incorporated into the EIR.

D2-100 SCE asserts that restating established protocol in their NBMP is not necessary when species-specific protocol is available. The following revision was made to clarify that SCE would be required to describe how it will comply with existing protocol instead of simply restating the protocol requirements.

# Pages ES-10, 4.3-63, and 8-15:

Appropriate survey timing, extents, methods, and surveyor qualifications; approved nest deterrent methods, including areas where vegetation will be cleared for the purpose of deterring nesting; monitoring and reporting protocols during construction; protocol for determining whether a nest is active; protocol for documenting, reporting, and protecting active nests within construction areas. If pre-construction survey protocols exist for a certain species, the plan shall <u>identify</u> the species-specific protocol that will be followed and outline how SCE will comply with the protocoloutline the implementation of these protocols.

D2-101 In response to SCE's comment D2-77, the term "raptor" was removed from the buffer reduction discussion in MM BR-11. During coordination for the preparation of the NBMP, the CPUC will discuss the buffer reduction process for raptors with the USFWS and CDFW.

# Pages ES-10, 4.3-63, and 8-15:

Guidelines for determining appropriate and effective buffer distances that will account for specific project settings, bird species, stage of nesting cycle, and construction work type. Language for buffer reduction process will be included in the plan, which shall include coordination with the appropriate wildlife agencies and the CPUC if reducing the buffer of a raptor or special-status species.

- D2-102 SCE refers to a technical working group convened for the West of Devers Project, which resulted in a template NBMP that SCE would like to use for this project. The template plan included requirements for previous experience but not education of the monitors and biologists. MM BR-11 does not specify what the minimum level of education or experience would need to be; only that the NBMP would describe the specific requirements for education and experience. The mitigation measure requires SCE to develop this plan with input from USFWS and CDFW, and obtain approval from the CPUC. SCE would be able to suggest the experience requirement agreed upon in the template. Therefore, no revision to the mitigation measure is necessary.
- D2-103 As stated by SCE, the USFWS is the authority providing approval for "take" permits. However, the CPUC, as the lead agency, will also provide approval for construction activities and the CPUC will coordinate with the USFWS to make decisions that may impact the coastal California gnatcatcher. Consistent with the recommendations in this comment, the following changes were made to clarify agency consultation requirements in MM BR-12.

# Pages ES-11, 4.3-64, and 8-16:

In the event that coastal California gnatcatchers are observed during preconstruction surveys, a qualified biologist must identify the boundaries of the pair's territory and SCE must not conduct construction activities within 500 feet of the territory, or as otherwise approved by the CPUC, in consultation with USFWS and CDFW. SCE shall notify USFWS and CDFWthe CPUC in the event gnatcatcher territory or nest sites are confirmed by surveys, immediately upon return from the field. If infeasible to maintain a buffer of 500 feet (or a distance otherwise approved by USFWS-and CDFW), by installing temporary flagging or fencing, from an active gnatcatcher territory, construction activities within or near these areas will be performed outside the breeding and nesting season (coastal California gnatcatcher breeding/nesting season is approximately February 1 through August 30).

D2-104 Additional information was added to clarify that the timing of pre-construction, protocol level surveys for least Bell's vireo would occur within the survey window specified in USFWS protocol for the species. SCE also suggests providing specific location information where surveys would be conducted and claims the current description is subjective. SCE recommends changing "areas of suitable or potentially suitable habitat" to "native riparian." USFWS's Least Bell's Vireo Survey Guidelines do not restrict surveys to "native riparian habitat;" guidelines state that "all riparian areas and any other potential vireo habitats" should be surveyed (USFWS 1997). Therefore, SCE's suggested change was not made; however, the term "riparian" was added to provide more specificity regarding survey requirements.

### Pages ES-11, 4.3-65, and 8-16:

<u>MM BR-13</u>: **Pre-Construction Surveys for Least Bell's Vireo.** Prior to construction <u>and within their breeding season (generally April 10-August 31)</u>, SCE shall complete protocol-level surveys for least Bell's vireo in areas of suitable or potentially suitable <u>riparian and other</u> habitat within the proposed component areas. Surveys will be conducted by a qualified biologist approved by the CPUC according to the survey protocol for least Bell's vireo (USFWS 2001).

D2-105 SCE suggested adding a defined timeframe for notifying agencies in the event least Bell's vireo territory or nest sites are confirmed. SCE recommends including a 48-hour window for notification. Given that pre-construction surveys may be completed shortly before the start of construction, agencies should be notified as soon as possible to avoid impacts. SCE does not provide information about why it suggests a 48-hour window or state that a shorter window is not feasible. To allow more time for notification, a 24-hour window after biologists return from the field was added.

### Pages ES-11 4.3-65, and 8-16:

In the event that least Bell's vireo territory or nest sites are confirmed, SCE shall notify the USFWS and CDFW *immediately upon within 24 hours of* returning from the field. If individuals or their nests are observed, biologists will establish and maintain a minimum 500-foot (or a distance otherwise approved buffer from USFWS and CDFW) exclusionary buffer by installing temporary flagging or fencing between the nest territory and construction activities.

D2-106 SCE claims that MM BR-14 may conflict with the project description, which requires removal of riparian vegetation.

The mitigation measure does not prevent the removal of riparian vegetation where it is needed. The mitigation measure provides a mechanism to minimize the removal of riparian vegetation in areas that require vegetation removal; thus, there is no conflict with the project description. SCE's statement that it would "minimize impacts to areas where riparian vegetation does not need to be removed" is noted. Because SCE does not identify an issue with the environmental analysis, no further response can be provided.

D2-107 MM BR-15 is intended to reduce impacts from avian collision with power lines during operations of the proposed project. SCE provided a company-wide Avian Protection Plan (APP) that describes a general approach to bird management during construction and operations of projects. The plan briefly describes that Avian Power Line Interaction Committee (APLIC) standards will be incorporated, but does not specify what measures would be utilized or how. The APP in the mitigation measure is required to describe the provisions SCE will incorporate from APLIC's standards into the operation of the Mesa Substation and a system for adaptive management of project-related issues to ensure impacts would be less than significant. This is information is not provided in detail in SCE's company-wide APP. Therefore, it would

not necessarily meet the requirements of mitigation measures or reduce impacts from collision to less than significant. Therefore, no changes to the EIR have been made.

D2-108 The following revision has been made to correct the noted typographical error.

### Page 4.4-1:

Cultural resources discussed in this section include historical resources, archeological resources (which may be historic or prehistoric and are a subset of historical resources), Native American resources, and paleontological resources:

D2-109 The following revision has been made to correct the noted typographical error.

### Page 4.4-1:

- **Historical Resources:** The California Environmental Quality Act (CEQA) defines historical resources as resources that are listed on, or determined to be eligible for listing on, the California Register of Historical Resources (CRHR) or a local register, or are otherwise determined to be historical pursuant to CEQA or the CEQA Guidelines (Public Resources Code [PRC] § 21084.1 or Code of Regulations, Title 14, § 15064.5, respectively). According to the CEQA Guidelines, a historical resource may be an object, building, structure, site, area, place, record, or manuscript that a <u>Lead aAgency determines to be historically significant or significant in terms of California's architectural, engineering, scientific, economic, agricultural, educational, social, political, military, or cultural records. Typically, in order to be considered historical for purposes of listing, a resource must be at least 50 years old.</u>
- D2-110 The following revision has been made to correct the noted typographical error.

### Page 4.4-1:

• Archaeological Resources: Archaeological resources may be considered historical resources pursuant to the CEQA Guidelines. Archaeological resources may also be determined to be "unique" as defined by CEQA (PRC § 21083.2). Unique archaeological resources are artifacts, objects, or sites that can be demonstrated to (1) contain information needed to answer important scientific research questions and that there is a demonstrable public interest in that information; (2) have a special and particular quality such as being the oldest of its type or the best available example of its type; or (3) be directly associated with a scientifically recognized important prehistoric or historic event or person. Archaeological resources that are neither a unique archaeological nor an historical resource are not required to be addressed in an Environmental Impact Report (EIR).

D2-111 The following revision has been made to correct the noted typographical error.

### Page 4.4-6:

To determine the potential for built environment historic<u>al</u> resources, ASM reviewed current and historic aerial photographs of the substation site. Subsequently, ASM conducted a historical resource field survey of the Mesa Substation area on August 19, 2014. ASM took photographs to document the three buildings located at 440 Potrero Grande Avenue. ASM also conducted archival research at the Monterey Park Public Library, including the Special Collections Room, and the City of Los Angeles Public Library to evaluate the buildings located in aerial imagery on the Mesa Substation site (Williams et al. 2014).

D2-112 The following revision has been made to correct the noted typographical error.

### Page 4.4-7:

The majority of the Goodrich Substation site (Figure 2-3e), which includes the project construction area and Staging Yard 4, was surveyed for archaeological resources for the TRTP project in 10-meter-wide transects. A small portion of the north central part of the Goodrich Substation site had not been surveyed. ASM surveyed this area to an intensive level for archaeological resources using 10-meter transects on June 19, 2014. No architectural historical resources were identified in examination of aerial photographs of the Goodrich Substation area (Williams et al. 2014).

D2-113 The following revision has been made to correct the noted typographical error.

### Page 4.4-10:

Three additional historic era resources were newly identified during field surveys of the Mesa Substation site area for the proposed project. These historic era resources include three buildings located at 440 Potrero Grande Drive that were constructed more than 45 years ago. The buildings' plans, architectural features, conditions, and historical integrity were noted, and California Department of Parks and Recreation (DPR) 523 site records were prepared to document the survey. None of the buildings were recommended as eligible for listing on CRHR or the NRHP (Williams et al. 2014) and the CPUC has no evidence to conclude that they are otherwise considered historical resources under CEQA.

### Page 4.4-13:

The proposed project would require equipment replacements and upgrades within the perimeters of several existing substations<sup>3</sup> in addition to the Mesa and Goodrich Substations. The applicant conducted a review of each of these substations and assessed whether they had been evaluated for NRHP/CRHR eligibility (Williams 2014). Additionally, Historical Resource Analysis Reports/Historic Property Survey Reports were prepared to evaluate NRHP/CRHR eligibility for the Laguna Bell and Lighthipe Substation Properties (Chiang and Tinsley Becker 2014a); the Repetto and San Gabriel Substation Properties (DeBiase and Tinsley Becker 2015); and the Anita, Fairfax, Garfield, and Newmark Substation Properties (Tinsley Becker et al. 2015). The Amador, Hillgen, Industry, and Jose Substations have not been evaluated. Table 4.4-4 lists each substation property where equipment replacements and/or upgrades would occur and its NRHP/CRHR eligibility status. The Mira Loma Substation is not of sufficient age to be eligible for the NRHP or CRHR.

D2-118 The following revision has been made to correct the noted typographical error:

# Page 4.4-14:

- D2-119 CPUC reviewed supplemental information requested from SCE, which included an email from Walter Davis from the USACE stating that the action would not require a permit under Section 408.

The following revision has been made to the EIR:

### Page 4.4-19

Section 106 of the NHPA is the basis for determining significance of impacts to cultural resources for projects with a federal nexus. Sections of the proposed project <u>likely</u> would <u>not</u> require a permit from the United States Army Corps of Engineers under Section 408 of the Rivers and Harbors Act and Section 404 of the

Clean Water Act (see also section 4.3, "Biological Resources") for potential impacts to Waters of the United States.

D2-120 The following revision has been made to correct the noted typographical error:

### Page 4.4-20:

The CRHR is an authoritative listing and guide to be used by State and local agencies, private groups, and citizens in identifying the existing historical resources of the State and to indicate which resources deserve to be protected, to the extent prudent and feasible, from substantial adverse change (California PRC  $\S$  5024.1(a)).

D2-121 The following revision has been made to correct the noted typographical error and reflect that the absence of resources in this area supports the conclusion that there would be no impact to known historical resources.

### Page 4.4-26:

No historic or archeological sites were identified during a record search or pedestrian surveys at the proposed project area for proposed transmission structure replacement in the City of Commerce or at the proposed conversion of the street light conductors from overhead to underground within the City of Bell Gardens. Therefore, there would be no impacts related from construction of the transmission structure or <u>conversion conversation</u> of the street light conductors <del>would be less than significant under this criterion</del>.

D2-122 The following revision has been made to correct the noted typographical error.

# Page 4.4-26:

Routine operations and maintenance activities would not require ground disturbing activities. However, maintenance of access roads may include occasional removal of vegetation or other activities to address washouts or eroded areas, as needed. In addition, wood pole testing and treating is a necessary maintenance activity conducted to evaluate the condition of wood structures both above and below ground level. Intrusive inspections require the temporary removal of soil around the base of the pole, usually to a depth of approximately 12 to 18 inches, to check for signs of deterioration. These would require ground disturbing activities in previously disturbed areas of the proposed project and would not result in material or physical changes to the known eligible and listed resources or to undiscovered resources. Therefore, there would be no potential to directly or indirectly impact a historic<u>al</u> resource. Therefore, operations and maintenance-related activities would have no impact under this criterion.

D2-123 The following revision was made to clarify that damage to a resource that is historical would be a significant impact.

### Page 4.4-27:

The remainder of activities would not result in ground disturbance and would not have the potential of damaging an undiscovered resource unless it was on the ground surface. Damage to a previously undiscovered <u>historical</u> surface resource would be a significant impact. MM CR-3 would be implemented to protect previously undiscovered resources. Impacts would be less than significant with mitigation.

D2-124 The following revision was made to clarify that damage to a resource that is historical would be a significant impact.

### Page 4.4-28:

These would require ground disturbing activities in previously disturbed areas of the proposed project. Therefore, there would be no potential to directly or indirectly impact an undiscovered historical or archaeological resource.

- D2-134 The following edit was made to complete the Section 402 General Construction Activity NPDES Permit description.

#### Page 4.5-19:

As authorized by Section 402 of the Clean Water Act, the California State Water Resources Control Board administers the NPDES General Permit for Discharges of Storm Water Associated with Construction Activity (General Construction Activity NPDES Storm Water Permit, 2009-0009-DWQ, 2010-0014-DWQ, and 2012-0006-DWQ) that covers a variety of construction activities that could result in wastewater discharges. Under this General Permit, the state issues a construction permit for projects that disturb more than 1 acre or more of land.

D2-135 The following revision was made to clarify that EPA is responsible for the Final GHG Tailoring Rule.

# Page 4.6-6:

The <u>EPA's</u> Final GHG Tailoring Rule, established in May 2010, sets thresholds for GHG emissions that define when permits under the New Source Review, Prevention of Significant Deterioration (PSD) and Title V Operating Permit programs are required for new and existing industrial facilities. This final rule tailors the requirements of these Clean Air Act permitting programs to limit which facilities are required to obtain PSD and Title V permits. Thresholds to trigger PSD and Title V are currently set at 100,000 tons per year of CO<sub>2</sub>e. A June 23, 2014 U.S. Supreme Court decision held that EPA may not treat GHGs as an air pollutant for purposes of determining whether a source is a major source required to obtain a PSD or Title V permit.

- D2-136 The commenter's requested revision is noted and included in the record for consideration of decision makers. SCE correctly notes that low carbon fuel standard (LCFS) was identified by CARB under the AB 32 Scoping Plan. The LCFS regulation was originally approved by CARB in 2009 and re-adopted in 2015. Executive Order S-1-07, issued on January 18, 2007, and which also addressed LCFS, calls for a reduction of at least 10 percent in the carbon intensity of California's transportation fuels by 2020. No changes were made to the text as a result of the comment.
- D2-137 The following language was added to the description of Resource Conservation and Recovery Act-regulated hazardous waste.

# Page 4.7-16:

A RCRA-regulated hazardous waste <u>is either found on a predetermined list or is not</u> <u>on a list, but</u> exhibits at least one of four characteristics: ignitability, corrosivity, reactivity, or toxicity. To keep track of hazardous waste activities, facility owners and operators who generate, transport, treat, store, or dispose of hazardous wastes must maintain records and submit reports to the EPA at regular intervals.

D2-138 The following change has been made to the description of wood pole disposal site based on updated information provided by SCE.

### Page 4.7-25:

These poles would need to be reused, returned to the manufacturer, or disposed of in a Class I hazardous waste landfill, disposed of in the lined portion of a Regional Water Quality Control Board (RWQCB) certified municipal landfill, or returned to the manufacturer. It is anticipated that these poles would either be reused or disposed of <u>through SCE's Treated Wood Waste contractor</u>, <u>Waste Management</u>, <u>Inc. at El Sobrante Landfill at Savage Canyon Landfill</u>, the only landfill identified by

the applicant for the proposed project that can accept treated wood waste (CalRecycle 2016, SCE 2015b) as discussed further in Section 4.12, "Public Services and Utilities."

D2-139 The following change has been made regarding the citation of California's Health and Safety Code.

### Page 4.7-33:

Because additional oil would be brought to and stored at the proposed Mesa Substation as part of the proposed project, the applicant would be required to update this plan to accommodate the additional oil-filled equipment in accordance with the CWA and APSA. An HMMP would also be required pursuant to California HSC Section <u>25505</u><del>25503.5</del>. The HMMP would include safety information regarding the transport, use, and disposal of hazardous materials.

- D2-140 The applicant is required to comply with applicable laws, including California laws regulating hazardous materials. However, CEQA does not prohibit including compliance with a law as a mitigation measure. Furthermore, MM HZ-1 requires that SCE submit a copy of the Hazardous Materials Business Plan to the CPUC so that the CPUC can ensure mitigation of impacts. Therefore, MM HZ-1 has been retained.
- D2-141 The applicant is required to comply with applicable laws, including California laws regulating hazardous materials. However, compliance with an applicable law or obtaining a permit does not necessarily mitigate all impacts or eliminate the need for mitigation measures. As described in Section 4.7.2.1, Spill Prevention, Control, and Countermeasure plans are required to address oil spills, and the statutory requirement is applied to reduce impacts during project operation. However, under Impact HZ-1, MM HZ-3 is applied to also address construction activities that could result in a spill and requires SCE to submit the plan to the CPUC for review and approval at least 30 days prior to construction.
- D2-142 The applicant is required to comply with the federal CWA. However, CEQA does not prohibit including compliance with a law as a mitigation measure. Furthermore, MM HY-1 requires that SCE implement specific Best Management Practices (BMPs) to reduce specific impacts. SCE must also submit a copy of the SWPPP to the CPUC so that CPUC can ensure mitigation of impacts. Therefore, MM HY-1 has been retained.
- D2-143 The suggested revision was not made because MM HZ-1, MM HZ-3, and MM HY-1 were retained in the Final EIR. Refer to responses to comments D2-140, D2-141, and D2-142.
- D2-144 The suggested revision was not made because MM HZ-3 was retained in the Final EIR. Refer to response to comment D2-141.
- D2-145 SCE states that the EIR analysis should state that SCE would prepare a Contaminated Soil Contingency Plan (CSCP) in compliance with regulatory requirements described in the state regulatory setting in Section 4.7.2.2. There are no regulations listed in Section 4.7.2.2 that require preparation of a CSCP; rather, MM HZ-4 requires that the CSCP be

prepared consistent with practices implemented under California Title 8 and Cal-OSHA regulations. Furthermore, MM HZ-4 requires that SCE prepare a CSCP that outlines steps that would need to be taken to identify and deal with contaminated soil in order to ensure implementation of the mitigation. SCE must also submit a copy of the CSCP to the CPUC so that CPUC can ensure mitigation of impacts. Therefore, MM HZ-4 has been retained.

- D2-146 The applicant is required to comply with applicable laws including California laws regulating Waste Discharge Requirements (WDRs) and discharge of extracted groundwater. However, CEQA does not prohibit including compliance with a law as a mitigation measure. Furthermore, MM HY-2 outlines options for disposal of groundwater allowed in the case that there is no WDR for the activity. Therefore, MM HY-2 has been retained.
- D2-147 The suggested revision was not made because MM HZ-4 was retained in the Final EIR. Refer to the response to comment D2-145.
- D2-148 The suggested revision was not made because MM HZ-4 was retained in the Final EIR. Refer to the response to comment D2-145. However, the following correction to the title of the plan described in this section was made.

### Page 4.7-37:

This could create a hazard to the public or environment, which would be a significant environmental effect. The applicant would prepare and implement a <u>Contaminated Soil Contingency Management</u> Plan in accordance with MM HZ-4, which would include precautionary measures and methods for handling potentially contaminated soils at all site areas that involve excavation activities.

D2-149 MM HZ-1 was not removed per SCE's request; refer to the response to comment D2-140. SCE provided an alternative request in the event the mitigation measure was not removed. The following change was made as requested by SCE; however, a 15-day time-frame was added to the CPUC submittal requirement to allow adequate time for verification.

### Page 4.7-39:

A Hazardous Materials Business Plan (HMBP) shall be submitted to the CPUC and electronically through the California Environmental Reporting System <u>(CERS)</u> for any hazardous materials stored on-site over threshold quantities (55 gallons, 200 cubic feet, or 500 pounds). The plan shall include information on:

- Hazardous materials stored at the Mesa Substation over threshold quantities.
- A site map with key emergency information, including internal access roads, adjacent public streets, sewer drains, emergency response equipment, and access/egress points.
- Emergency response plans for release and threatened release of the covered materials.

The HMBP and its approval by the Los Angeles Certified Unified Program Agency must be submitted to the CPUC at least 30 days prior to storage of covered hazardous materials. The HMBP must be submitted at least 30 days prior to storage of covered hazardous materials via the CERS. A receipt, showing that the agency received the plan, must be submitted to the CPUC no less than 15 days prior to storage of covered hazardous materials.

- D2-150 As explained in the response to comment D2-141, MM HZ-2 was not removed from the EIR and no revisions were made to MM HZ-2.
- D2-151 MM HZ-3 was not removed per SCE's request; refer to the response to comment D2-141. SCE provided an alternative revision in the event the mitigation measure was not removed, but the CPUC will not make the requested revisions because the revisions would take away the CPUC's ability to review and approve the Spill Prevention, Control, and Countermeasure plan. SCE's suggested revision to the time frame required to submit the plan makes it less effective because the plan can be submitted after construction has already begun. Thus, no revisions were made to the mitigation measure.
- D2-152 The following typographical error was corrected.

### Page 4.8-5:

SCE has performed wetland delineations on the Mesa Substation site per United States Army Corps of Engineers' (USACE's) *Wetlands Delineation Manual* and the *Interim Regional Supplement to the Corps of Engineers Wetland Delineation Manual: Arid West Region.* Figure 4.8-<u>2</u><sup>3</sup> shows the result of delineations. SCE submitted a request for an Approved Jurisdictional Determination on April 23, 2015 for waters on the Mesa Substation site. SCE has not yet received approval from USACE (SCE 2015).

- D2-153 Refer to response to comment D1-45.
- D2-154 The following changes have been made regarding the distance of Legg Lake relative to proposed project components.

# Page 4.8-6:

Under section 303(d) of the Clean Water Act, states identify water bodies as impaired for certain pollutants. The only listed water body in the vicinity of the project area is Legg Lake, which is located 0.2 mile <u>southwestnortheast</u> of Staging Area 7 and about <u>0.1-02</u> mile north of Telecommunications Route 3. The proposed Mesa Substation site area is located approximately 2.5 miles northeast of the lake.

D2-155 The typographical error identified in this comment has been corrected. See response to comment D1-45 for revisions.

D2-156 The following change has been made to the description of Section 402 permitting based on input by SCE.

# Page 4.8-12:

As authorized by Section 402 of the CWA, the SWRCB administers the statewide National Pollution Discharge Elimination System (NPDES) General Permit for Discharges of Storm Water Associated with Construction Activity (Construction General Permit) (NPDES Permit, 2009-0009-DWQ <u>as amended by<del>and</del></u> 2010-0014-DWQ <u>and 2012-0006-DWQ</u>) <del>that</del>which covers a variety of construction activities that could result in wastewater discharges. Under this system, the state grants coverage under the Construction General Permit for projects that disturb <del>more than</del> one acre <u>or more of</u> land. The SWRCB Construction General Permit process involves the notification of the construction activity by providing a Notice of Intent to the SWRCB, the development of a Storm<del>w</del> Water Pollution Prevention Plan (SWPPP), and the implementation of water quality monitoring activities if needed.

D2-157 The following changes have been made to clarify the purpose of SWPPPs.

# Page 4.8-12:

- Develop a maintenance schedule for BMPs installed during construction that are designed to reduce or eliminate pollutants after construction is completed; <u>and</u>
- Identify a sampling and analysis strategy and sampling schedule for discharges from construction activity in compliance with the requirements of the <u>Construction General Permit</u>. that discharge directly to a water body listed for impairment due to sedimentation, in accordance with CWA Section 303(d); and
- Identify a sampling and analysis strategy and sampling schedule for discharges that have been discovered through visual monitoring to be potentially contaminated by pollutants not visually detectable in the runoff.
- D2-158 Note that Section 404 is discussed in the EIR in Section 4.3.2.1. The following text related to Section 404 of the CWA has been added to the Final EIR in Section 4.8.2.1.

# Page 4.8-12:

### Section 404 (Waters of the United States)

Under Section 404 of the CWA, the United States Army Corps of Engineers (USACE) and EPA regulate the discharge of dredged or filled material in "waters of the United States." Waters of the United States typically includes wetlands and permanent and intermittent drainages, creeks, and streams and all aquatic or riverine habitats between the "ordinary high water mark" of those hydrological features. Any dredge or fill in these waters typically requires a permit from the USACE pursuant to Section 404. D2-159 The original text has been retained to explain Waste Discharge Requirements. The following changes have been made to the description of the Porter-Cologne Act to include basin plans.

# Page 4.8-13:

### Porter-Cologne Water Quality Control Act (Porter-Cologne Act)

Article 4 of the Porter-Cologne Water Quality Control Act (California Water Code 13260 et seq.) states that discharge of waste in an area that could affect Waters of the State requires filing a report of discharge with the Regional Water Quality Control Board. Waters of the State include surface water and groundwater in the state. Dischargers must obtain Waste Discharge Requirements (WDRs). If waters are also Waters of the U.S., then the WDR is covered by the section 401 Water Quality Certification, previously discussed. The Porter-Cologne Act (California Water Code, Division 7) regulates surface and groundwater quality in the State and requires the SWRCB and the nine RWQCBs to adopt water quality criteria to protect waters of the State. The SWRCB and local RWQCB have the responsibility of issuing permits for certain point source discharges, regulating construction and stormwater runoff, and developing regional basin plans.

Basin plans are prepared by a RWQCB to regulate all pollutants or nuisance discharges that may affect surface or groundwater within their jurisdiction. These plans designate beneficial uses for surface and groundwater, set narrative and numerical objectives that must be attained or maintained to protect designated beneficial uses, and describe implementation programs to protect all waters in the region. The Los Angeles RWQCB's Water Quality Control Plan represents the basin plan for the coastal watersheds of Ventura and Los Angeles Counties.

D2-160 A brief description of the Municipal Separate Storm Water Sewer System Permit was added to the regulatory setting in Section 4.8, "Hydrology and Water Quality," based on SCE's suggestion.

### Page 4.8-14:

### Municipal Separate Storm Water Sewer System Permit

The Los Angeles RWQCB's MS4 Permit, Water Quality Order No. R4-2012-0175, as amended by State Water Board Order WQ 2015-0075 (NPDES No. CAS004001) on November 8, 2012 regulates discharges within the Coastal Watersheds of Los Angeles County and 84 cities within the Los Angeles Flood Control District. Cities, including Monterey Park, Montebello, and Pasadena, are required by the permit to implement its own storm water program that prevents pollutant laden discharges from entering downstream storm water conveyance systems and draining into local receiving and coastal waters. These Cities are required to meet certain criteria thresholds, to develop and implement post-construction Low Impact Development (LID) Best Management Practices (BMPs) to address pollutant discharges. D2-161 SCE states that it revised the water usage calculations in April 2016. SCE describes that the Central Basin Metropolitan Water District (CBMWD) is a source for recycled water and mentions that Monterey Park has taken the initiative to provide water to SCE for the proposed project. A data request was sent to SCE regarding the City of Monterey Park and CBMWD's supply of water for the project in July 2016. In response, SCE provided a copy of the letter of intent SCE sent to CBMWD, in which SCE requested a "will serve letter" from CBMWD. In its data response, SCE also submitted notes from a meeting it attended with Monterey Park and CBMWD. The information did not support SCE's assertion that Monterey Park or CBMWD would supply recycled water, only that SCE *requested* this supply of water and therefore *may* utilize this source of water. Because there was not confirmation from Monterey Park or CBMWD of adequate availability of water sources for the EIR analysis to rely upon, the analysis in the EIR was revised to account for the potential use and make an impact determination.

SCE also stated in the letter to CBMWD, dated March 25, 2016, that water usage estimates have increased with an average annual requirement of 202.8 acre-feet. This water usage estimate contrasts with the estimate provided in the Draft EIR comment by SCE, dated June 27, 2016, of 404 acre-feet total during construction. The more recent, higher estimate from SCE's comment letter on the Draft EIR was used to revise the EIR.

Revisions have been made to the analysis to reflect SCE's intent to utilize recycled water and new water usage estimates provided in this comment. SCE estimates that water use will consist of a maximum of 140 acre-feet per year for three years. The maximum water use in any single year remains the same as previously estimated in the Draft EIR; however, given that the maximum use may occur over an additional year, the total water use estimate has increased. As described in the EIR, 140 acre-feet is approximately 0.3 percent of the 2014–2015 overdraft, which would not cause a notable decrease in the water table. Impacts would remain less than significant.

# Page 4.8-19:

### Groundwater Use

The Monterey Park Department of Public Works Water Utility Division <u>maywould</u> supply water for construction of the proposed project. <u>Monterey Park obtains</u> <u>water through contract with the Main San Gabriel Basin—a source that is entirely</u> <u>drawn from groundwater. The applicant intends to utilize recycled water from</u> <u>Central Basin Municipal Water District, thereby reducing, or eliminating, the need</u> <u>for groundwater; however, as of July 2016, the applicant has not secured water</u> <u>from the district (SCE 2016).</u> An estimated <u>404279</u> acre-feet of water would be used throughout the 55-month duration of construction. This analysis conservatively assumes that <del>up to half of the estimated construction water, or</del> up to 140 acre-feet per year (AFY), may be used in the first <u>two years and last year</u> of construction when the majority of grading activities would occur.

The Main San Gabriel Basin is in overdraft conditions and has experienced historic lowering of the groundwater table. The preliminary Operating Safe Yield recommendation for the Main San Gabriel Basin for fiscal year 2015–2016 is

150,000 AFY and for subsequent years through 2020 is approximately 130,000 AFY. About 195,000 acre-feet were pumped in 2014–2015. Producers pumping from the groundwater basin can pump more than their annual right, but they are required to fund water for recharging the basin; in 2014–2015, the required recharge amount would have been 45,000 acre-feet. Groundwater levels at one well have also decreased from 294 feet in 1983 to 175 feet in 2015. There is a requirement to recharge the basin to maintain the water level at this well at over 200 feet (Main San Gabriel Basin Watermaster 2015).

Even though the basin is in overdraft and groundwater levels are below the 200foot goal, the proposed project's water use would not be a substantial use of groundwater that would result in a net deficit in aquifer volume or a lowering of the local groundwater table level. One hundred-forty AFY equates to about 0.3 percent of the 2014–2015 overdraft. Spread across the basin, this would not cause a noticeable decrease in groundwater volume or groundwater level. This pumping level would <u>occur for a maximum of three yearsalso last only one year, with consecutive construction years using less and less water</u>. The use would therefore not be permanent. Impacts would be less than significant.

To maintain consistency throughout the EIR, the following change was also made to Section 4.12, "Public Services and Utilities:"

# Page 4.12-15:

During construction, The Monterey Park Department of Public Works Water Utility Division would supply water for the proposed project. An estimated 404279 AF of water would be used throughout the 55-month duration of construction.

D2-162 The following typographical errors in the Draft EIR were corrected.

# Page 4.8-21:

This would increase stormwater runoff and the potential for erosion and sedimentation because it would involve altered drainages and grade on the site. It would also increase the area of disturbed land, reducing infiltration at the site. The applicant would construct a <u>detention</u> basin in the southwest corner of the proposed Mesa Substation site and would implement site and source control BMPs into the design to help mitigate surface runoff. Drainage systems would be constructed along the perimeter of the substation to direct interior runoff to the <u>detention</u> basin. Impacts would be significant if the detention basin could not accommodate the amount of runoff generated, resulting in an overflow and flooding of downstream drainages.

To maintain consistency throughout the EIR, the following additional corrections were made:

### Page 4.8-24:

Runoff from the substation site would be directed toward a detention basin, which would be constructed during Phase  $\underline{12}$  (see Section 2.3.2.2, "Construction Phases").

Increases in runoff water could be significant during Phase 1, prior to construction of the detention basin.

- D2-163 While SCE plans to construct the detention basin during Phase I, SCE does not indicate that the detention basin would be constructed prior to other project components that would be constructed during Phase I. Increases in runoff water could cause significant erosion during Phase I prior to detention basin construction. No revisions to the EIR were made.
- D2-164 The following change to the timing of construction for the detention basin has been made based on updated information provided by SCE.

#### Page 4.8-20:

The applicant intends to prepare and implement a drainage plan in compliance with the jurisdictional agency requirements to minimize potential surface water and erosion impacts during the proposed site preparation and construction. Runoff from the substation site would be directed toward a detention basin, which would be constructed during Phase  $\underline{12}$  (see Section 2.3.2.2, "Construction Phases").

D2-165 The following change to the timing of the construction for the detention basin has been made based on updated information provided by SCE.

#### Page 4.8-22:

Runoff from the substation site would be directed toward a detention basin, which would be constructed during Phase <u>1</u><sup>2</sup> (see Section 2.3.2.2, "Construction Phases"). Increases in runoff water could be significant during Phase 1, prior to construction of the detention basin.

- D2-166 While SCE plans to construct the detention basin during Phase 1, SCE does not indicate that the detention basin would be constructed prior to other project components that would be constructed during Phase 1. Increases in runoff water could cause significant erosion during Phase 1 prior to detention basin construction. No revisions to the EIR have been made.
- D2-167 The following typographical errors in the Draft EIR have been corrected.

### Page 4.8-23:

It would also increase the area of disturbed land, reducing infiltration at the site and further increasing the potential for flooding. The applicant would construct a <u>detentionretention</u> basin in the southwest corner of the proposed Mesa Substation site and would implement site and source control BMPs into the design to help mitigate surface runoff. Drainage systems would be constructed along the perimeter of the substation to direct interior runoff to the <u>detentionretention</u> basin. Impacts would be significant if the detention basin could not accommodate the amount of runoff generated, resulting in an overflow and flooding of downstream drainages. The following additional change was made to ensure consistency throughout the section:

### Page 4.8-22:

Impacts would be significant if the detention basin could not accommodate the amount of runoff generated, resulting in an overflow and flooding of downstream drainages. MM HY-4 would require designing the basin to be of adequate capacity. These impacts would be less than significant with mitigation.

- D2-168 While SCE plans to construct the detention basin during Phase 1, SCE does not indicate that the detention basin would be constructed prior to other project components that would be constructed during Phase 1. Increases in runoff water could cause significant erosion during Phase 1 prior to detention basin construction. No revisions to the EIR have been made.
- D2-169 The following corrections have been made based on information provided by SCE.

### Page 4.8-24:

After construction, there would be about 72.2 acres of permanent new disturbance at the Mesa Substation. This would increase storm water runoff because it would involve alterations in drainages and grade on the site. It would also increase the area of disturbed land, reducing infiltration at the site. The applicant would construct a <u>detention</u> basin in the southwest corner of the proposed Mesa Substation site and would implement site and source control BMPs into the design to help mitigate surface runoff. Drainage systems would be constructed along the perimeter of the substation to direct interior runoff to the <u>detention</u> the perimeter basin. Impacts would be significant if the detention basin could not accommodate the amount of runoff generated. MM HY-4 would require designing the basin to be of adequate capacity. These impacts would be less than significant with mitigation.

D2-170 Several changes to the analysis of Impact HY-8 have been made per SCE's comment in D1-29, which pertained to the error in determining that the Main Project Area is in the inundation area for the failure of the Garvey Reservoir south dam. Refer to response to comment D1-29 for details regarding changes made in this section of the EIR.

Despite the removal of MM HY-6, the impact analysis conclusion remains "less than significant with mitigation." Staging Yard 6 is in the inundation area for the Garvey Reservoir north dam. Inundation waters would be about 5 feet deep. A dam failure when workers are present in this area could result in significant impacts due to the close proximity to the dam and depth of the water. Therefore, MM HY-5, which requires training on an evacuation route in the event of dam failure, is still necessary. With implementation of MM HY-5, Impact HY-8 is considered less than significant with mitigation. Therefore, the overall determination that Impact HY-8 would be less than significant with mitigation has not been revised.

D2-171 See response to comment D1-29 for changes made to the EIR.

- D2-172 See response to comment D2-142.
- D2-173 The applicant has requested several modifications to the existing language in MM HY-1 if MM HY-1 is retained. The CPUC is retaining MM HY-1, as described in response to comment D2-142.

SCE suggested removing specific examples of BMPs that could be implemented as well as the goals of implementing the BMPs. The goals of the BMPs—to "minimize ponding, eliminate flood hazards, and avoid erosion and siltation into creeks, streams, rivers, or bodies of water"—serve as a performance standard to reduce impacts to less than significant and therefore require the BMPs serve to reduce those impacts. SCE's revisions remove those goals, which could result in BMPs that do not address all of those performance standards. No changes based on this suggestion have been made to the mitigation measure.

SCE also requests that the SWPPP be "site-specific" and "prepared in compliance with the Construction General Permit." However, MM HY-1 already states that the "applicant will obtain coverage for the project under the Construction General Permit." SCE's suggestion that the SWPPP be "site-specific" is not clear because it could refer to the Mesa Substation site only or it could refer to the entire project site. Because of this, the CPUC has made none of the requested revisions.

SCE has suggested changing the requirement that vehicle maintenance activities take place at least 150 feet from aquatic resources to at least 50 feet, if feasible. The CPUC has no evidence that a minimum of 50 feet would be adequate to, for example, ensure that maintenance activities do not result in impacts to waters. The CPUC has found that 150 feet is a sufficient distance to ensure spills from maintenance activities would not impact aquatic resources. The addition of "if feasible" is unacceptable because it leaves open the possibility that impacts would be significant and unavoidable. The addition of "if feasible" without a definition of what would make implementation infeasible also makes enforcement of the mitigation measure problematic. Therefore, revisions regarding the minimum distance for vehicle maintenance have not been made based on SCE's suggestion.

SCE suggested modifying the mitigation measure to eliminate the requirement for the applicant to provide the CPUC with approved SWPPPs at least 30 days prior to construction. However, the CPUC will need proof of coverage to ensure mitigation as part of its responsibility as the Lead Agency. Therefore, this requirement has been retained. The CPUC agrees to the change about keeping SWPPPs on site and providing to the CPUC upon request once construction has begun. The following revisions were made to MM HY-1:

# Page 4.8-29:

Verification of Construction General Permit <u>obtained from the State Water</u> <u>Resources Control Board</u> <del>coverage approval and the approved SWPPP(s)</del> will be provided to the California Public Utilities Commission (CPUC) at least 30 days prior to start of construction. Updated SWPPPs will be <u>kept onsite during construction</u> and provided to the CPUC on request during construction.

D2-174 The applicant states that it would be required to submit an "Erosion Control Plan" to the City of Monterey Park as part of the grading plan process and that construction drainage issues are managed through the SWPPP process. The City of Monterey Park has stated that because the proposed project would be getting a General Construction Permit from the State Water Resources Control Board and would develop and implement a SWPPP, no additional plan describing erosion control would be required by the City (Alfonso pers. comm. 2016). The following change has been made to enable the requirements of MM HY-3 be satisfied with the SWPPP.

### Page 4.8-30:

SCE shall prepare and implement a Drainage Plan<u>, or incorporate the requirements</u> of this mitigation measure into the SWPPP, which that ensures runoff during construction activities at the Mesa Substation site will not exceed drainage capacity of the storm water system and other drainage facilities. Measures that can be employed can include:

- Constructing the detention basin earlier in construction.
- Constructing temporary detention basins on site.
- Creating infiltration areas to limit runoff that enters the storm water system.

<u>If the SWPPP is not used to satisfy the conditions of this mitigation measure, SCE</u> shall submit the plan to Monterey Park and CPUC for review and approval prior to beginning construction activities at the substation site.

D2-175 The City of Monterey Park has stated that design of the detention basins within its jurisdiction is required to follow the standards described in the Los Angeles County Department of Public Works Hydrology Manual (Alfonso pers. comm. 2016). Therefore, SCE's suggested revisions have not been made. Additional text has been added to clarify that the City of Monterey Park uses the same standards as Los Angeles County.

### Page 4.8-30:

SCE shall design the detention basin on the proposed Mesa Substation site in accordance with the Los Angeles County Department of Public Works Hydrology Manual <u>and in compliance with the City of Monterey Park's requirements</u> (LACDPW 2006). The Hydrology Manual contains techniques to calculate runoff flow rates and volumes based on Los Angeles County's historic precipitation and runoff.

D2-176 See response to comment D1-29 for changes made to the EIR.

D2-177 The following revisions have been made to Section 4.10.3 of the EIR to reflect that helicopters would not be used for conductor stringing at Goodrich Substation.

### Page 4.10-21:

### City of Pasadena

Most construction noise limitations in Pasadena apply within a 500-foot radius from a residential district; the closest residences to the substation are 100 feet away. There are residences within 500 feet of the construction area for structure replacement and telecommunications routing. Staging Yard 4 is also located within 500 feet of a residential area. <u>And may be used for helicopter landing and takeoff</u>. In this area, construction is allowed from 7:00 am to 7:00 pm Monday through Friday and from 8:00am to 5:00 pm on Saturday. Construction of the proposed project would generally take place within these hours. Some construction may be required outside of the allowed time, e.g., a planned line outage that must occur at night for safety reasons.

### Page 4.10-21:

Helicopter use at Staging Yard 4 would produce noise levels of up to 97 dBA at 100 feet. Construction-related noise associated with the proposed project would exceed the noise limits set forth in the City of Pasadena's noise ordinance as a result of construction occurring outside of the allowed construction hours and as a result of helicopter landing activities at Staging Yard 4. This would be a significant impact. Noise reduction mitigation measures would not be effective at reducing helicopter noise within 100 feet, since the helicopters would produce noise when airborne and landing, where noise barriers would be ineffective. Impacts would be significant and unavoidable.

D2-178 SCE's comment is noted and the following edits have been made to the EIR.

### Page 4.10-28:

Helicopters would <u>potentially</u> take off and land at Staging Yards 1 through <u>34</u>. Helicopter use would at most produce 97 dBA at 100 feet. Estimated noise impacts to sensitive receptors near each staging yard due to helicopter landing and takeoff are provided in Table 4.10-19.

D2-179 SCE's comment is noted and the following edits have been made to page 4.10-28, Table 4.10-19, of the EIR to reflect that helicopter use would not take place at Staging Yard 4.

D2-180 The commenter suggests various changes to MM NV-1, which requires a noise plan and describes performance standards to be met and noise control measures to be implemented. Suggested changes include deleting the first two bullet points which describe the mitigation's construction standards regarding noise, modifying the list of noise control measures, and replacing monitoring requirements with modeling criteria.

SCE is incorrect when it states that the standard in the first bullet—to reduce noise by 10 A-weighted decibels (dBA)—applies to operations and is not applicable to construction noise. As described under Impact NV-4, under "Significance Threshold," "a substantial increase in noise is defined as a 10-dBA increase of existing ambient noise levels. An increase of 10 dBA is perceived as a doubling of noise." The Draft EIR does not assign the 10-dBA threshold only to operational noise. Therefore, the first bullet in MM NV-1 has been retained.

SCE recommends removing the second bullet—which requires implementing measures so that construction noise does not exceed the noise level specified in the jurisdiction's noise ordinance—because it is not achievable. The CPUC agrees it is not achievable, as evidenced by the CPUC's conclusion that impacts under Impact NV-1 (noise levels in excess of standards established in the local general plan or noise ordinance) would be significant even with mitigation. Under CEQA, CPUC is still

required to mitigate significant impacts to either less than significant or as much as feasible if the impact remains significant. MM NV-1 has been revised as reflected below.

It should be noted that the CPUC must retain a performance standard in MM NV-1. CEQA requires mitigation measures that specify the creation of a plan with specific mitigation measures that must include, among other things, a performance standard. The first two bullet points in MM NV-1 contain the standards construction noise is meant to achieve. SCE suggests including "noise reduction" as a performance standard; however, "noise reduction" in general does not indicate a goal for how much noise must be reduced. Therefore, the two bullets have been retained as a performance standard. Furthermore, these types of measures must also contain examples of specific mitigation that would be used in order to achieve the performance standard. SCE has revised MM NV-1 to state the Noise Control Plan would "consider" certain measures. The CPUC understands these measures may not be used and that they are just examples of measures that could be used. The CPUC has modified language to show that these are examples of measures that may be used rather than measures that must be used.

SCE requests the remainder of its revisions for "greater flexibility," but does not provide specific reasons for its suggested changes. Some revisions appear to be only editorial (e.g., changing "shall" to "will). However, many suggested revisions (e.g., "efforts will be made") would result in an ineffective mitigation measure. SCE also deleted certain measures; the measures should be included in MM NV-1 to show the suite of measures that would be considered to reduce impacts. The following edits have been made and they provide flexibility but do not reduce the effectiveness of the mitigation measure.

# Page 4.10-32:

**MM NV-1: Noise Control Plan.** Prior to the start of construction, the applicant shall prepare a Noise Control Plan to ensure that project construction noise does not:

- Increase ambient noise levels by more than 10 dBA (8-hour L<sub>eq</sub>), or
- Exceed the noise level specified in the applicable jurisdiction's noise ordinance.

The Noise Control Plan measures shall be selected based on <u>the specific</u> equipment used, <del>and</del> activity conducted in specific locations, <u>and proximity to sensitive noise</u> <u>receptorsonce known</u>. The applicant shall submit the Noise Control Plan to the CPUC at least 30 days prior to the start of construction for review <u>and approval</u>. <u>Measures that may be included in </u><u>T</u>the Noise Control Plan <u>to reduce noise levels by</u> <u>10 dBA or to the noise level specified in the applicable jurisdiction's noise</u> <u>ordinance are: shall include, but not be limited to, the following noise reduction</u> <del>and control measures:</del>

• Temporarily <u>and safely</u> install and maintain <del>an</del> absorptive noise control barriers in the perimeter of construction sites <u>and/or between stationary</u> <u>construction equipment and sensitive noise receptors when</u> located within 200

feet of noise-intensive equipment operating more than 4 hours a day. The applicant shall notify all residents located within 50 feet of the absorptive barriers and ensure such barriers are installed in a safely manner.

- Limit heavy\_equipment activity adjacent to residences or other sensitive receptors to the shortest possible period required to complete the work activity.
- Ensure that proper mufflers, intake silencers, and other noise reduction equipment are in place and in good working condition.
- Maintain construction equipment according to manufacturer recommendations.
- Minimize <u>unnecessary</u> construction equipment idling.
- Reduce noise from back-up alarms (alarms that signal vehicle travel in reverse) in construction vehicles and equipment by providing a layout of construction sites that minimizes the need for back-up alarms and use flagmen to minimize the time needed to back up vehicles.
- When possible, use construction equipment specifically designed for low noise emissions (<u>e.g., i.e.</u>, equipment that is powered by electric or natural gas engines instead of diesel or gasoline reciprocating engines). Electric engines have been reported to have lower noise levels than internal combustion engines.
- Where practical, locate stationary equipment such as compressors, generators, and welding machines away from sensitive receptors or behind barriers.

The Noise Control Plan shall detail the frequency, location, and methodology for noise <u>modeling and</u> monitoring prior to and during various construction and restoration activities to ensure that generated noise levels do not exceed 10 dBA above existing ambient noise levels, or the applicable jurisdiction noise standards. <u>These methods shall include monitoring noise levels at the boundary of</u> <u>construction areas and using industry-standard noise modeling techniques to</u> <u>predict noise levels at adjacent sensitive receptors. If modeled levels exceed the</u> <u>greater than 10 dBA above existing ambient noise or applicable ordinance</u> <u>threshold noise, monitoring will be conducted to verify model results.</u> The Noise Control Plan shall detail the actions and procedures that the applicant shall implement to mitigate impacts in the event that monitoring detects noise levels that have exceeded the criteria specified in this EIR. Noise level measurements shall be conducted in compliance with the City of Monterey Park, City of Montebello, City of Commerce, City of Bell Gardens, City of Pasadena, and Los Angeles County requirements, as applicable.

The Noise Control Plan shall designate a Construction Relations Officer who is readily available to answer questions or respond to complaints during <u>periods of any hours or days that</u> construction or restoration is occurring. The applicant shall send pre-construction notifications to sensitive receptors located within 100 feet of construction activities at least 30 days prior construction. The notification shall include a phone number for the public to contact the Construction Relations Officer. Additionally, each construction site shall include clearly visible signs with

the Construction Relations Officer's public phone number. The applicant shall submit monthly reports to the CPUC summarizing the complaints submitted to the Construction Relations Officer. The summary reports shall describe how each complaint was addressed, if and when it was resolved, and <u>available</u> contact information for the member of the public who submitted the complaint.

D2-181 MM NV-2 was created to address a deficiency in SCE's proposed APM-NOI-01. Under Impact NV-1, it is noted that it is possible that the transformer noise at the 1990 Holly Oak Drive sensitive receptor may experience nighttime noise levels over Monterey Park's 50-dBA nighttime noise standard. SCE proposed APM-NOI-01, which requires that SCE to decrease operational noise levels of substation transformers to 50 dBA as measured at residential receptors in areas of the City of Monterey Park. The CPUC superseded APM-NOI-01 with MM NV-2 because APM-NOI-01 contained no method to verify the noise reduction. The CPUC retained in MM NV-2 the 50-dBA standard proposed by SCE in its APM.

> SCE comments that MM NV-2 should be removed because it is infeasible due to the ambient noise already exceeding the City of Monterey Park's noise ordinance standard. The average 8-hour noise equivalent is 52 dBA at 1990 Holly Oak Drive, as shown in Table 4.10-3, but the 8-hour ambient Leg is not representative of nighttime noise. Table 4.10-3 shows that the lowest nighttime noise level at this location is 47 dBA (1hour Leq). As indicated in Appendix J of the Draft EIR, the applicable ambient noise level for the Monterey Park noise standard is 50 dBA, as median nighttime noise level is approximately 50 dBA when taking into account the ambient noise measurements in Figure 3-6 from 10:00 p.m. to 7:00 a.m. The applicable noise standard—Monterey Park Municipal Code Title 9, Chapter 9.53—states that the noise standards are "the actual measured median ambient noise level or the ... presumed noise level, whichever is greater." The presumed noise levels are contained in Table 4.10-7 of the EIR and includes the 50-dBA daytime residential noise level. SCE has not presented evidence that the *nighttime* median ambient noise level is 52 dBA. The Monterey Park municipal code allows the noise standard to be the actual median ambient noise level if it is greater than the presumed ambient noise level and because the existing nighttime median noise level is at the threshold of the municipal code standard MM NV-2 and Impact NV-1 has been revised to better reflect the nighttime noise standards in the Monterey Park municipal code.

# Page 4.10-23:

As shown in Table 4.10-15, noise levels would exceed the City of Monterey Park's 50 dBA nighttime noise standard for residential land uses by 3 dBA at the property line of residences along Holly Oak Drive<del>, which would be a significant impact</del>. <u>The lowest nighttime ambient noise levels were measured at 47 dBA at this location</u>, and it appears that the nighttime median noise level is approximately 50 dBA. <u>Operation of the Mesa Substation would increase the ambient noise by 3 dBA. This would violate the Monterey Park municipal code and would be a significant impact</u>. <u>Existing ambient noise over a 24-hour period was determined to be 73.1 dBA at the Encanto Walk development (Monterey Park 2011). Nighttime noise would likely be less than the 24-hour average but may still exceed the 50 dBA nighttime noise standard. This impact would be significant before mitigation.</u>

The receptors on Holly Oak Drive are the closest to the 500/220-kV transformers, with the closest receptors being approximately 1,000 feet from the transformers (about 100 feet closer than 1990 Holly Oak Drive). To reduce transformer noise to meet the applicable standard of 50 dBA or lower in the residential areas and 55 dBA or lower in commercial areas of the City of Monterey Park and to prevent further increases in an existing exceedance of the threshold at either Holly Oak Drive or Encanto Walk, SCE would implement APM-NOI-01. Impacts would still be significant after implementation of APM-NOI-1 because there is no mechanism in the APM to require verification that the engineering solution abated noise to below the 50-dBA threshold. Furthermore, it is possible that conditions may change such that ambient noise levels may increase to above 50 dBA by the time the proposed project is operational, given the small difference between 47 and 50 dBA. Such an increase would result in APM NOI-01 requiring SCE to mitigate the 53-dBA transformer noise level to less than ambient noise levels, which would not be feasible. MM NV-2 supersedes APM-NOI-1 and would require verification of ambient noise levels and adequate noise reduction and implementation of additional measures until the threshold is met. Impacts would be less than significant after mitigation.

### Page 4.10-33:

#### MM NV-2: Operational Substation Noise Monitoring Compliance with

**Monterey Park Ordinance**. As soon as Mesa Substation is fully operational, the applicant shall conduct noise measurements to ensure that the operational noise levels from the substation transformers do not exceed the City of Monterey Park's 50-dBA nighttime noise standard (50 dBA or actual measured median ambient noise level, whichever is greater) at the closest receptor. If the <u>nighttime noise standard</u> threshold is exceeded, the applicant shall implement engineering solutions, including, but not limited to, barrier walls around the transformer, sound absorbing panels, and/or noise cancellation methods until the project does not exceed the threshold <u>nighttime noise standard</u>. SCE must submit the noise measurements in the form of a memorandum to the CPUC within two weeks of measurement. Reports shall be submitted until the CPUC verifies that operation noise does not exceed the City of Monterey Park's 50-dBA nighttime <u>noise standard</u>. Threshold.

A typographical error has also been corrected on page 4.10-10, with additional revisions made for clarity.

#### Page 4.10-10:

# Pages ES-21, 4.10-34, and 8-21:

<u>MM NV-4</u>: Positioning of Helicopter Landing and Takeoff Areas. SCE shall position helicopter landing and takeoff areas in Staging Yards 1, 2, <u>and 3, and 4</u> as far away as feasible from sensitive receptors, while not sacrificing the safety of helicopter operations due to hazards (e.g., transmission lines) in and around the staging yards. SCE must submit helicopter locations to the CPUC for review and approval at least 30 days prior to use of the helicopter location.

D2-183 The following edits were made to the EIR.

# Page 4.12-5:

### Solid Waste

The proposed project would generate solid waste during construction (e.g., concrete, non-recyclable metals, green waste, refuse, spoils, trash, and wood poles). SCE would use three-four approved, licensed landfills in the vicinity of the proposed project for the solid waste materials: Savage Canyon Landfill in Whittier, <u>Azuza Azusa</u> Land Reclamation Landfill in <u>Azuza Azusa</u>, and Scholl Canyon Landfill in Los Angeles, and El Sobrante Landfill in Corona. These landfills are rated as Class III landfills, which accept clean dirt, concrete, and asphalt (CalRecycle 2015a, b, c). Additionally, Asuza landfill can accept asbestos and nonhazardous petroleum contaminated soil (CalRecycle 2015a). Savage Canyon <u>El Sobrante</u> Landfill can also accept treated wood waste (CalRecycle 2015b). Disposal of hazardous materials is discussed in Section 4.7, "Hazards and Hazardous Materials." Characteristics of the three four landfills that would serve the proposed project are shown in Table 4.12-3.

D2-185 The applicant is required to comply with existing laws and regulations. However, CEQA does not prohibit including compliance with a law as a mitigation measure. MM HY-1 shall remain in place to ensure measures used to mitigate significant impacts on the environment are disclosed.

The following edits have been made to correct a typographical error.

# Page 4.12-14:

Impacts to these drainage features, grading, vegetation removal and the introduction of new impervious surfaces would increase water runoff to the storm water drainage system during construction. The use of water for dust control purposes would also contribute to runoff. Onflow from upstream areas (i.e., west east of the proposed substation site area) would also be interrupted by construction of the proposed substation.

D2-186 Based on updated water use numbers provided by SCE, the following change to the EIR has been made to ensure consistency with the Hydrology and Water Quality section.

# Page 4.12-15:

Given the likely OSY and predicted demand, it is reasonable to assume that the City will produce more than its entitlement during the years of project construction and will be required to pay the Watermaster a fee to recharge the ground basin. To conservatively assess impacts, it is assumed that up to half of the estimated construction water, or 140 AF, may be used in the first two years and last year of construction, when the majority of grading activities would occur, and less in <u>othersubsequent</u> years. This water requirement would add to the City's expected overproduction beyond their entitlement.

D2-187 Based on SCE's comment, the following edits have been made.

# Page 4.12-17:

During construction of the proposed project, solid waste, e.g., waste from building construction, waste associated removal of existing buildings, excess soils, green waste, refuse, spoils, and treated wood poles would be generated. Treated wood poles would be reused by SCE, returned to the manufacturers, disposed of in a Class I hazardous waste landfill, or disposed of in the lined portion of an RWQCB-certified municipal landfill, as discussed further in Section 4.7, "Hazards and Hazardous Materials." The remaining solid waste that cannot be recycled would be classified and transported to Savage Canyon Landfill, <u>Azuza Azusa</u> Land Reclamation Landfill, <del>or</del> Scholl Canyon Landfill, <u>or El Sobrante Landfill</u> in accordance with all applicable federal, state, and local regulations for solid and hazardous waste disposal. These three four landfills have a combined remaining capacity of approximately <del>53.5</del> <u>199</u> million cubic yards (CY) (CalRecycle 2015a, b, c) as shown in Table 4.12-3. The estimated quantity of solid waste that would be generated for the proposed project to be deposited at approved landfills is

approximately 41,800 CY. Impacts under this criterion would be less than significant.

The revisions do not affect the significance conclusion, which found the proposed project's impacts less than significant for Impact PSU-7.

#### D2-188 The following edit has been made.

### Pages ES-23, 4.12-18, and 8-25:

<u>MM PS-1</u>: Relocation Agreement with <u>Municipal Metropolitan</u> Water District. Prior to construction that would take the MWD's 72-inch Middle Feeder Pipeline out of service, the applicant shall reach an agreement with the MWD that will identify an alternate alignment that crosses the project site. This relocation agreement will enable the MWD to maintain reliable deliveries of treated water to its member agencies during relocation of the pipeline. SCE shall submit to the CPUC information from the MWD confirming that relocation of the pipeline will not result in inability to adequately serve customers. SCE shall submit this documentation at least 30 days prior to the pipeline being taken out of service.

### D2-189 The following edit was made.

### Page 4.13-5:

During peak construction periods, the applicant estimates that up to approximately 435 employees could be working simultaneously on various components throughout the proposed project area. This number conservatively assumes that peak construction of the proposed Mesa Substation; transmission, subtransmission, and distribution relocations; and telecommunications work may all occur simultaneously. The average number of workers is estimated to be approximately 126. The applicant anticipates that construction would be performed by either the applicant's local construction crews or contractors commuting from the Los Angeles area and would not require workers to relocate (SCE 2015a). However, in the event that local construction crews or contractors are not available, and the applicant were to hire up to 435 non-local employees for the entire duration of construction during peak periods of construction, or an average of approximately 126 workers for the duration of the project, the temporary relocation of workers to the project area for approximately 55 months could result in a minor increase in the use of existing neighborhood and regional parks or other recreational facilities.

#### D2-190 The following edits have been made.

# Page 4-14-1:

Comments related to the Metro Eastside Transit Corridor Project were taken into consideration in preparation of Section 6.0, "Cumulative Impacts and Other CEQA Considerations." There would be no impact to SR 164; therefore, <u>SR 164 the Metro Eastside Transit Corridor Project</u> is not discussed further in this analysis. All other

comments are addressed in this section.

D2-191 The following edits have been made.

### Page 4.14-2:

Local roadways in the vicinity of the proposed project area are listed in Table 4.14-1. Table 4.14-1 also lists the intersections that would be <u>impacted utilized</u> by project-related traffic. Key intersections and roadway segments were included in the analysis based on the proposed travel routes for construction trips, existing traffic volumes, and comments received from Caltrans regarding state operated roadways.

Phase I would generate trips due to worker vehicles, equipment delivery, soil import and export, and other similar activities. Trips would vary throughout the 18-monthlong Phase I. At peak activity levels, Phase I of the proposed Mesa Substation would generate up to <del>2,1441,072 (onetwo</del>-way) daily passenger car equivalent (PCE) trips, as shown in Table 4.14-12.

Note that MM TT-1 has been revised in the Final EIR to include the requirements of Draft EIR MM TTs 2, 3, 6, 7, 8, 9, and 10 referenced in the comment, as shown in response to comment A2-2.

D2-206 Compliance with permit requirements alone does not sufficiently demonstrate how significant impacts would be reduced to less than significant levels; therefore, detail

regarding how existing regulatory processes and mitigation measures reduce significant impacts has been included in the EIR. In addition, language has been added to the EIR indicating how specific transportation and traffic mitigation measure requirements may be satisfied through compliance with permit conditions, or other authorizations obtained by the applicant, if these requirements are equally or more effective than the mitigation identified in the EIR.

Note that MM TT-1 has been revised in the Final EIR to include the requirements of Draft EIR MM TT-7 referenced in the comment, as shown in response to comment A2-2.

- D2-215 MM TT-1 has been revised in the Final EIR to include the requirements of Draft EIR MM TT-7 referenced in the comment, as shown in response to comment A2-2. Compliance with permit requirements alone does not sufficiently demonstrate how significant impacts would be reduced to less than significant levels; therefore, MM TT-1 would be required to reduce impacts to a less than significant level.
- D2-216 MM TT-1 has been revised in the Final EIR to include the requirements of Draft EIR MM TT-8 referenced in the comment, as shown in response to comment A2-2. Compliance with permit requirements alone is not enough to show impacts would be reduced to less than significant; therefore MM TT-1 would be required to reduce impacts to a less than significant level.
- D2-217 MM TT-1 has been revised in the Final EIR to include the requirements of Draft EIR MM TT-9 referenced in the comment, as shown in response to comment A2-2. Compliance with permit requirements alone does not sufficiently demonstrate how significant impacts would be reduced to less than significant levels; therefore, MM TT-1 would be required to reduce impacts to a less than significant level.
- D2-218 MM TT-1 has been revised in the Final EIR to include the requirements of Draft EIR MM TT-10 referenced in the comment, as shown in response to comment A2-2. Compliance with permit requirements alone does not sufficiently demonstrate how significant impacts would be reduced to less than significant levels; therefore, MM

TT-1 would be required to reduce impacts to a less than significant level.

D2-219 Traffic and transportation mitigation measures have been renumbered based on consolidation of mitigation measures. The name of the education center has been updated in the Final EIR. MM TT-11 in the Draft EIR has been re-numbered as MM TT-4 in the Final EIR and has been updated with SCE's proposed edits; however, the CPUC has left a reference to the education center concurring that sufficient parking would be available during project construction.

The following edits have been made.

### Pages 4.14-47, ES-27, and 8-31:

<u>MM TT-114</u>: <u>Pasadena City College</u> Community Education Center Parking. If proposed project work at the Goodrich Substation would result in parking spot closures at the <u>Pasadena City College</u> Community Education Center parking lot, SCE shall coordinate scheduled closures with the <u>Pasadena City College</u> Community Education Center <u>on the following and shall obtain a letter from the Community</u> <u>Education Center that states</u>:

- The dates of parking spot closures; and
- The number of parking spots that would be closed.; and
- That the Community Education Center concurs that there will be sufficient parking spots to accommodate SCE's work and the Community Education Center's parking needs.

SCE shall submit the letter documentation to the CPUC 30 days prior to Community Education Center parking spot closure demonstrating coordination with the Pasadena City College Community Center and concurrence from the Pasadena City College Community Education Center that there will be sufficient parking spots to accommodate SCE's work and the Pasadena City College Community Education Center's parking needs.

D2-220 Refer to response to comment D2-57 regarding the project-level analysis that concludes that impacts of the project to views of the substation site from Potrero Grande Avenue (KOP 3) would be significant under Landscape Option 1 until trees reach maturity and less than significant with mitigation and would be significant under Landscape Option 2. Part of the rationale for the conclusion that impacts would be significant is that the new structures at the substation site would be more dominant than the existing structures and would add new geometric forms and lines to the view. The changes would produce strong contrast and reduce intactness and unity of views from Potrero Grande Drive. It follows that the reduced number of new structures associated with the One-Transformer-Bank Substation Alternative, when compared to the proposed project, would produce less contrast and would not reduce intactness and unity of views as much as the proposed project, even though the new structures would still be visually dominant. The Final EIR recognizes that the reduction in visual impacts would be "slight" compared to the proposed project. The text has been revised to clarify the analysis.

### Page 5-4:

Construction of the One-Transformer-Bank Substation Alternative would result in <u>slightly</u> reduced aesthetic impacts. The 500-kV switchrack would be about half the size of the switchrack for the proposed projects, which would result in fewer structures at the substation visible from viewpoints on Potrero Grande Drive. <u>Fewer structures associated with the One-Transformer-Bank Substation</u> Alternative, when compared to the proposed project, would result in slightly less of an increase in contrast and slightly less of a decrease of intactness and unity of views when compared to the proposed project. However, the transformer bank and 500-kV switchrack would be located adjacent to Potrero Grande Drive, closer to viewers, meaning that the new substation structures would still be visually dominant. The reduction in visual impacts (Impact AE-1) would be slight compared to the proposed projects.

As described on page 5-2 of the Draft EIR, CEQA Guidelines Section 15126.6(d) states that "The EIR shall include sufficient information about each alternative to allow meaningful evaluation, analysis, and comparison with the proposed project. A matrix displaying the major characteristics and significant environmental effects of each alternative may be used to summarize the comparison. If an alternative would cause one or more significant effect in addition to those that would be caused by the project as proposed, the significant effects of the alternative shall be discussed, but in less detail than the significant effects of the project as proposed." CEQA recognizes that the alternatives discussion can be less detailed than that of the proposed project. The absence of visual simulations of the One-Transformer-Bank Substation does not equate to a lack of support for a conclusion that visual impacts of the One-Transformer-Bank Substation would be less than those of the proposed project. As included in the EIR and above, CPUC's conclusion that the alternative would slightly reduce visual impacts is backed by evidence—that the switchrack would be smaller than the proposed project, with fewer visible structures. Therefore, no changes have been made to the conclusion that this alternative would have a slight reduction in visual impacts (Impact AE-1) when compared to the proposed project.

D2-221 Noise impacts would be reduced under the One-Transformer-Bank Substation Alternative, the Two-Transformer-Bank Transformer Alternative, and the Gas-Insulated Substation Alternative. (See analysis on EIR pages 5-12, 5-16, and 5-21, respectively.) From the perspective of a numerical measure of noise, however, noise would only be negligibly reduced (by about 2 dBA) under each alternative when compared to the proposed project. Because a change of less than 3 dBA would not be perceptible, the analysis has been revised to clarify that the noise from each alternative would be similar to the noise from the proposed project. The following revisions have been made to the EIR to reflect this clarification:

#### Page 5-13:

Noise from the proposed project may be reduced under the One-Transformer-Bank Substation Alternative because less construction would take place close to sensitive receptors on Holly Oak Drive. The One-Transformer-Bank Substation Alternative would increase the distance of the substation construction activities to the nearest sensitive receptors on Holly Oak Drive by approximately 170 feet. Thus, noise impacts at these receptors would be reduced by about 2 A-weighted decibels (dBA). Reduction in noise by 2 dBA would not result in a perceptible difference in noise levels. Construction of the One-Transformer-Bank Substation Alternative would <del>negligibly reduce noise impacts</del> <u>be similar</u> (Impact NV-4) <del>compared</del> to the impacts of the proposed project.

#### Page 5-18:

Noise from the proposed projects may be reduced under the Two-Transformer-Bank Substation Alternative because less construction would take place close to sensitive receptors on Holly Oak Drive. The Two-Transformer-Bank Substation Alternative would increase the distance of the substation construction activities to the nearest sensitive receptors on Holly Oak Drive by approximately 170 feet. Thus, noise impacts at these receptors would be reduced by about 2 dBA. Reduction in noise by 2 dBA would not result in a perceptible difference in noise levels. Construction of the Two-Transformer-Bank Substation Alternative would negligibly reduce noise impacts <u>be similar</u>(Impact NV-4) compared to the impacts of the proposed project.

#### Page 5-24:

Noise from the proposed project may be reduced under the Gas-Insulated Substation Alternative because less construction would take place close to sensitive receptors on Holly Oak Drive. The Gas-Insulated Substation Alternative would increase the distance of the substation construction activities to the nearest sensitive receptors on Holly Oak Drive by approximately 190 feet. Thus, noise impacts at these receptors would be reduced by about 2 dBA. Reduction in noise by 2 dBA would not result in a perceptible difference in noise levels. Construction of the Gas Insulated Substation Alternative would <del>negligibly reduce noise impacts</del> <u>be similar (Impact NV-4) <del>compared</del> to the impacts of the proposed project. All</u> other impacts related to noise under this alternative would be the same as those associated with the proposed project.

Regarding SCE's suggestion to delete "To minimize the removal of vegetation in habitat areas of the coastal California gnatcatcher," see response to comment D2-78 for a discussion of the EIR's criteria for gnatcatcher habitat.
