On Wednesday, 6 August 2008 Erika Wilder and myself drove Tribal Chair Ken Woodrow of the Eshow Valley Band Of Michahai and Wuksachi Indians and his Vice Chair, Delbert Davis over the accessible portions of the routes of the Proposed Project and Alternatives 2 - 4. Also invited to this meeting was Lalo Franco, Cultural Specialist/NAGPRA Coordinator for the Santa Rosa Rancheria Tachi Tribe. In several telephone conversations, Mr. Franco insisted that we work with him separate and apart from Mr. Woodrow or his organization and indicated that he would be willing to meet with SCE or the CPUC and their consultants sometime in the future. He was not, however, willing to attend the 6 August meeting.

Mr. Woodrow agreed to give us his take on the project routes in writing, and I expect to hear back from him soon. My take on their reaction to the routes is that they agree the foothill area is very sensitive with regard to prehistoric archaeological resources, although burials and other resources may also be hidden in the valley floor. Messers Woodrow and Davis were particularly concerned about the proximity of Alternative Route 4 to Rocky Hill, a place of particular local Native American significance. The main advantage the Propose Route has over the Alternatives is that it passes through substantially less of the foothill region. Mr. Woodrow also indicated some Native American burials may be present in an marked or unmarked cemetery in the vicinity of the Proposed Route near Cameron Creek Colony, perhaps Deep Creek Cemetery. Mr. Woodrow is going to check on this burial place with his elders and get back to us. If it is Deep Creek Cemetery, the Proposed Project will pass just to the north of the burials with no direct effect.

5/15 Lalo Franco called late in the day regarding the SCE written correspondence of 30 April 2008 seeking Native American input to the SJXV Project environmental assessment. Lalo's focus was on his concern that SCE had included Ken Woodrow on the correspondence list. Lalo felt that Ken and his organization should not be consulted or should not have the same standing in consultation as Santa Rosa Rancheria, which is a federally recognized tribe with trust land. I explained to Lalo that Ken Woodrow is on the California Native American Heritage contact list and we are obliged to contact and discuss the project with everyone on that list that chooses to talk to us.

7/25 Lalo Franco called in response to the email I sent today asking if he and Ken Woodrow were available for a project route tour and meeting on either August 4 or 11. Lalo again reiterated all of his earlier concerns about Ken Woodrow's participation and stated that his organization would not meet with us at a meeting where Ken is present. I attempted to re-direct the conversation to concerns Lalo might have about resource sensitivity of the proposed or alternative routes, stating my take that the foothill areas were the most sensitive with regard to prehistoric archaeology. Lalo indicated that there may be some issues on some of the routes, but he could not be specific.

8/5 Lalo returned several calls I had left for him asking if he would be able to attend a project route tour and meeting on August 6. Lalo stated that he would be willing to meet with SCE and the PUC at a later date, but he would not attend the meeting on 6 August because Ken Woodrow would be there and he would not attend future meetings that included Ken. I expressed my regrets and indicated we would be in touch.

Ken Woodrow/Tom Taylor

May-August 2008 Ken Woodrow called me multiple times during the May through August timeframe asking about the status of the project, PUC CPCN process, and the timing for a field meeting regarding the project. The calls were always friendly. Ken expressed his concern for archaeological resources in the project area, particularly Rocky Hill. Ken explained to me that his group had approached California State Parks about acquiring Rocky Hill and preventing any future development of this very important place to his people. He asked if SCE could support this acquisition as a purchasing partner. I told Ken I would bring his request to the attention of SCE management.
