Viewpoint 1: Existing view looking east from the residential neighborhood at Sea Lavender Way and Black Coral Way (western terminus of the Proposed Project).

Viewpoint 6: View looking southeast from the parking lot of the Sleep Train Amphitheatre.





Viewpoint 8: Existing view looking northeast from the end of Vista Santa Rosalia in a residential neighborhood near Dennery Canyon.



Viewpoint 9: Existing view looking north from the east side of Heritage Road.



Viewpoint 10: Existing view looking south from Heritage Road. (A simulation of Viewpoint 10 is included in Attachment 4.1-B: Visual Simulations.)



Viewpoint 11: Existing view to the east-southeast from an open space area within the Otay River Valley. (A simulation of Viewpoint 11 is included in Attachment 4.1-B: Visual Simulations.)



Viewpoint 12: Existing view looking northeast from an undeveloped mesa.



Viewpoint 13: Existing view looking north-northwest from an undeveloped mesa.



Viewpoint 14: Existing view looking south from Main Street at Heritage Road. Proposed Project poles would be located approximately 0.5 mile away in the middleground of the photograph. (A simulation of Viewpoint 14 is included in Attachment 4.1-B: Visual Simulations.)



Viewpoint 15: Existing passenger view looking east-northeast from State Route (SR-) 125.



Viewpoint 16: Existing view looking east from SR-125, approximately 0.5 mile north of Otay Mesa Road.



Viewpoint 17: Existing view looking south from Harvest Road at Lonestar Road. (A simulation of Viewpoint 17 is included in Attachment 4.1-B: Visual Simulations.)



Viewpoint 18: Existing view looking north from Otay Mesa Road along Harvest Road. The fifth pole from the foreground represents the eastern terminus of the Proposed Project.
