

NOTICE OF AN APPLICATION- FOR A PERMIT TO CONSTRUCT

PROJECT NAME: SANTA CRUZ 115 KV REINFORCEMENT PROJECT
APPLICATION NUMBER: A.12-01-012

Proposed Project: In order to improve transmission system reliability and ensure safe and reliable electric service to Santa Cruz County area residents, PG&E is proposing to add a new, approximately 8.8-mile, 115 kV power line between Green Valley Substation and Rob Roy Substation. To support the new power line, new equipment will be installed in an expanded substation yard at Rob Roy Substation located on Freedom Boulevard, 0.6 miles northeast of State Highway 1 in Santa Cruz County. The new power line includes two segments: (1) the Northern Alignment would rebuild approximately 7.1 miles of the existing single-circuit Green Valley-Camp Evers 115kV Power Line into a double-circuit power line; and (2) the Cox-Freedom Segment would rebuild approximately 1.7 miles of existing distribution line into a combined single-circuit 115kV line and a distribution line. The Northern Alignment portion of the power line will begin at Green Valley Substation located north of the City of Watsonville on Minto Road, approximately 0.3 miles east of Green Valley Road. The new line will extend approximately 0.9 miles north and then approximately 0.8 miles west along Dalton Road, crossing Green Valley Road and Pinto Lake County Park. The proposed new power line will leave Pinto Lake County Park heading northwest for approximately 1.9 miles, crossing Kliever Road, Pioneer Road, and Pioneer View Road to Amesti Road, then west approximately 0.4 miles, crossing Corralitos Creek and Corralitos Road. Approximately 0.2 miles west of Corralitos Road, the line will extend northwest approximately 1.2 miles, crossing Hames Hollow Road and Hames Road, then west for approximately 1.7 miles, crossing Quail Run, Jingle Lane, Potter Road, Meadow Road and Pine Forest Drive to the end of the Northern Alignment segment on the west side of Cox Road. From there, the Cox-Freedom Segment will turn south approximately 0.4 miles along Cox Road to Day Valley Road and to McDonald Road, then southwest approximately 0.6 miles along McDonald Road to Freedom Boulevard, where it will turn southwest for approximately 0.7 miles to Rob Roy substation. To support the new power line, approximately 79 tubular steel poles with concrete foundations will replace existing wood power poles, and approximately 21 wood power poles will replace existing distribution poles. The existing Rob Roy Substation fence line will be expanded approximately 50 feet along the north and east sides on PG&E property to accommodate new equipment. Existing poles will be replaced to reconnect the existing Rob Roy-Paul Sweet 115 kV Power Line and the existing Green Valley-Rob Roy 115 kV Power Line to the modified substation.

To complete this project, PG&E has applied to the California Public Utilities Commission (CPUC) for a Permit To Construct (PTC). Construction is planned to start in the spring of 2013, or as soon as possible after permitting is completed, and is planned to be completed by December of 2013, or as soon thereafter as possible.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 06-01-042 and Pacific Gas and Electric Company's "EMF Design Guidelines for Electrical Facilities." The following measures are proposed for this project:

- The phases of the new Green Valley-Rob Roy 115 kV line and the existing Green Valley-Camp Evers 115 kV line will be arranged for minimum magnetic field level at the edge of the right of way.
- The height of the 62 poles in school and residential land use areas will be raised so that they are five feet taller than otherwise required.
- At Rob Roy Substation, high current devices, transformers, and reactors will be kept away from the substation property lines.
- For underground duct banks, the minimum distance will be 12 feet from the adjacent property lines or as close to 12 feet as practical.

Application for CPUC Authorization: Pursuant to CPUC General Order 131-D, Section III.B, no electric utility shall begin construction of certain facilities without first receiving authorization (Permit to Construct) from the CPUC.

Public Review Process: Persons or groups may protest the granting in whole or in part of the authority sought in the proposed Project and request that the CPUC hold hearings on the application.

An original and seven (7) exact copies of each protest, response or request for hearing on this project must be filed with the CPUC by no later than March 5, 2012, at the following address:

Protests, responses and/or requests for hearing must comply with Articles 2 and 2.5 of the CPUC's Rules of Practice and Procedure, and should include the following:

1. Your name, mailing address and daytime telephone number;
2. Reference to the CPUC Application Number and Project Name;
3. The facts constituting the grounds for the protest, the effect of the application on you as a protestant, the reasons you believe part or all of the application is not justified, and, if requesting an evidentiary hearing, the facts you would present at an evidentiary hearing to support a request for whole or partial denial of the application. (See Rule 2.6 of the CPUC's Rules of Practice and Procedure, which can be accessed electronically at www.cpuc.ca.gov under the link to the Public Advisor's Office.)

If the CPUC, as a result of its preliminary investigation after such requests, determines that public hearings should be held, the CPUC will notify you of the time and place of the requested hearing. The CPUC is authorized to act on the permit application without hearings if there are no protests or requests for hearings or if the CPUC determines that no protest or request for a hearing has been filed that raises issues requiring a hearing.





To support the new power line, new equipment will be installed in an expanded substation yard at Rob Roy Substation located on Freedom Boulevard, 0.6 miles northeast of State Highway 1 in Santa Cruz County. The new power line includes two segments: (1) the Northern Alignment would rebuild approximately 7.1 miles of the existing single-circuit Green Valley–Camp Evers 115kV Power Line into a double-circuit power line; and (2) the Cox–Freedom Segment would rebuild approximately 1.7 miles of existing distribution line into a combined single-circuit 115kV line and a distribution line. The Northern Alignment portion of the power line will begin at Green Valley Substation located north of the City of Watsonville on Minto Road, approximately 0.3 miles east of Green Valley Road. The new line will extend approximately 0.9 miles north and then approximately 0.8 miles west along Dalton Road, crossing Green Valley Road and Pinto Lake County Park. The proposed new power line will leave Pinto Lake County Park heading northwest for approximately 1.9 miles, crossing Kliever Road, Pioneer Road, and Pioneer View Road to Amesti Road, then west approximately 0.4 miles, crossing Corralitos Creek and Corralitos Road. 

Approximately 0.2 miles west of Corralitos Road, the line will extend northwest approximately 1.2 miles, crossing Hames Hollow Road and Hames Road, then west for approximately 1.7 miles, crossing Quail Run, Jingle Lane, Potter Road, Meadow Road and Pine Forest Drive to the end of the Northern Alignment segment on the west side of Cox Road. From there, the Cox-Freedom Segment will turn south approximately 0.4 miles along Cox Road to Day Valley Road and to McDonald Road, then southwest approximately 0.6 miles along McDonald Road to Freedom Boulevard, where it will turn southwest for approximately 0.7 miles to Rob Roy substation. To support the new power line, approximately 79 tubular steel poles with concrete foundations will replace existing wood power poles, and approximately 21 wood power poles will replace existing distribution poles. The existing Rob Roy Substation fence line will be expanded approximately 50 feet along the north and east sides on PG&E property to accommodate new equipment. Existing poles will be replaced to reconnect the existing Rob Roy-Paul Sweet 115 kV Power Line and the existing Green Valley-Rob Roy 115 kV Power Line to the modified substation.

To complete this project, PG&E has applied to the California Public Utilities Commission (CPUC) for a Permit To Construct (PTC). Construction is planned to start in the spring of 2013, or as soon as possible after permitting is completed, and is planned to be completed by December of 2013, or as soon thereafter as possible.

Electric and Magnetic Fields (EMF): Pacific Gas and Electric Company will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 06-01-042 and Pacific Gas and Electric Company's "EMF Design Guidelines for Electrical Facilities." The following measures are proposed for this project:

- The phases of the new Green Valley-Rob Roy 115 kV line and the existing Green Valley-Camp Evers 115 kV line will be arranged for minimum magnetic field level at the edge of the right of way.
- The height of the 62 poles in school and residential land use areas will be raised so that they are five feet taller than otherwise required.
- At Rob Roy Substation, high current devices, transformers, and reactors will be kept away from the substation property lines.
- For underground duct banks, the minimum distance will be 12 feet from the adjacent property lines or as close to 12 feet as practical.

Application for CPUC Authorization: Pursuant to CPUC General Order 131-D, Section III.B, no electric utility shall begin construction of certain facilities without first receiving authorization (Permit to Construct) from the CPUC.

Public Review Process: Persons or groups may protest the granting in whole or in part of the authority sought in the proposed Project and request that the CPUC hold hearings on the application.

1. Your name, mailing address and daytime telephone number;
2. Reference to the CPUC Application Number and Project Name;
3. The facts constituting the grounds for the protest, the effect of the application on you as a protestant, the reasons you believe part or all of the application is not justified, and, if requesting an evidentiary hearing, the facts you would present at an evidentiary hearing to support a request for whole or partial denial of the application. (See Rule 2.6 of the CPUC's Rules of Practice and Procedure, which can be accessed electronically at www.cpuc.ca.gov under the link to the Public Advisor's Office.)

If the CPUC, as a result of its preliminary investigation after such requests, determines that public hearings should be held, the CPUC will notify you of the time and place of the requested hearing. The CPUC is authorized to act on the permit application without hearings if there are no protests or requests for hearings or if the CPUC determines that no protest or request for a hearing has been filed that raises issues requiring a hearing.
