® The Universal LifeLine Telephone Service subsidy makes affordable telephone service available to qualified low-income customers. Reliable telephone service is crucial to the most vulnerable residents in California, allowing residents to reach police, fire and medical responders, by dialing 911 when fire, natural disasters, medical emergencies, or other crises occur. The Resolution ensures adequate funding, at an appropriate level, to support the California LifeLine program's goal of providing universal service.

**ESTIMATED COST:**

® No estimated cost to the Commission. However, the resolution will cause end-users of intrastate telecommunications services to pay an additional \$1.70 per \$100 of intrastate billings.

® Authorizes TWC to file a Tier 2 AL within 30 days from the effective date of the authorized rates to collect the under-collected revenues from May 10, 2015, the interim rate date, to the effective date of the new rates established by the Resolution. This AL should become effective upon approval by the Division of Water and Audits.

® Approves TWC's proposed water main capital improvement project at the Highway 89 crossing and intersection of Timberland Road with a cost cap of \$35,000.

® Authorizes TWC to file a Tier 2 AL filing to add to its rate base and in rates the utility plant associated with its water main capital improvement project, once the project is completed.

**SAFETY CONSIDERATIONS:**

® The resolution provides adequate revenues to the utility so that it can provide safe and reliable water service to its customers. The water served by the utility meets all applicable water quality standards set forth by the State Water Resources Control Board.

**ESTIMATED COST:**

® \$14,575 + Water Main Capital Improvement Project Cost Cap of \$35,000.
