- B.10-2 Please see General Response GR-1 regarding effects on property values. Your comments are consistent with the findings of the Draft EIR/EIS.
- B.10-3 Thank you for submitting your opinion and comments. These will be shared with the decision-makers who are reviewing the Project and alternatives at the USDA Forest Service and the CPUC.
- B.10-4 The impacts of Alternative 5 compared to the proposed Project and other alternatives are discussed in Section D of the Draft EIR/EIS. Alternative 5 would have the potential to expose the greatest number of residences to noise associated with construction, operation, and maintenance activities and is therefore, the least preferable alternative with respect to Noise. Alternative 5 would also be the least preferable for Public Services. For Hydrology and Water Quality, Alternative 5 was determined to be preferable to both Alternative 1 and Alternative 2. For Air Quality, Land Use and Public Recreation, Traffic and Transportation, and Utilities and Service Systems, Alternative 5 was determined to be the second least preferable alternative from a biological perspective as it may result in beneficial impacts to the California condor and Management Indicator Species on National Forest System (NFS) lands, and would be located in habitats characterized by greater disturbance than the proposed Project or other alternatives.
- B.10-5 The Draft EIR/EIS addresses Alternative 5 impacts on Socioeconomics in Section C.12.10, Cultural Resources in Section C.4.10, and Visual Resources in Section C.15.10.
- B.10-6 Thank you for submitting your opinion and comments regarding Alternative 5. These will be shared with the decision-makers who are reviewing the Project and alternatives at the USDA Forest Service and the CPUC.
