We had not received any notice prior to this even though other parties outside of our community of Leona Valley had been notified since 2004. It appears that these same other parties were involved in the scoping phase and took care to protect their interests. Alternative 5 appears to have been added at a later date in the process and consequently notification to the community of Leona Valley did not occur. The CEQA notification guidelines may have been violated as well. We have a viable and active Leona Valley Town Council that should have been contacted when such an impact would occur to so many homeowners and families. The comment period ends on September 18, 2006. This short notice does not provide adequate time to fully prepare a response to the 1000 plus page DEIR. I support the request that you have already received to give us an extension of 90 days for further study and comments.
