As part of our case against Alternative 2, we adopt all applicable harmful issues to us as outlined in JACKSON, DEMARCO, TIDUS & PECKENPAUGH letter to you on October 2, 2006. While their letter primarily addresses Alternate 5, the same failures, shortcomings and damages impact our 36917 Bouquet Canyon property should Alternative 2 be adopted. And for additional those reasons, we are opposed to Alternative 2

However, Item 2. Background, line 13 on page 4 is erroneous in that Alternative 2 does require establishing new rights of way to accomplish construction of new transmission lines. Alternative 2 travels through existing residences, agricultural lands, and proposed 50 to 100 homes as well as previously undisturbed lands. The property and existing homes it negatively would impact is estimated to be valued at a minimum of 15 million dollars. It also creates a potential hazard for fire-fighting aircraft. Additionally, Alternative 2's new, not-currently-existing, midslope route appears to damage beautiful, scenic, winding, creek-side Bouquet Canyon Road with its trees, fishing, and campgrounds.

In summary, we adopt JDT&P's notification (attached) of failures, shortcomings and negative impact on our property where applicable; but reject all their references to Alternate 2 throughout their document (attached) as incorrect.
