

1. Comments and Responses to Comments

1.1 Purpose of Response to Comments Document

This document, in conjunction with the Sunrise Powerlink Project Draft EIR/EIS (January 2008) and the Sunrise Powerlink Project Recirculated Draft EIR/Supplemental Draft EIS (July 2008), constitutes the Final EIR/EIS on the Proposed Project. The Final EIR/EIS has been prepared pursuant to CEQA Section 21000 et seq., California Public Resources Code, and in accordance with the Guidelines for the Implementation of CEQA Section 15000 et seq., California Code of Regulations, Tit. 14. The Notice of Preparation (NOP) describing the Proposed Project was published on September 15, 2006. The Final EIR/EIS will be used by the CPUC as part of its CPCN approval process, which includes selecting project alternatives, adopting mitigation measures, and reviewing project costs. The BLM, as Lead Federal Agency, shall be responsible for ensuring compliance with all requirements of NEPA and the Council on Environmental Quality (CEQ) regulations for implementing NEPA (40 Code of Federal Regulations [CFR] 1500-1508). This Final EIR/EIS contains all comments on the Draft EIR/EIS and Recirculated Draft EIR/Supplemental Draft EIS and responses thereto. The focus of the responses to comments is on the disposition of significant environmental issues as raised in the comments, as specified by Section 15088(b) of the State CEQA Guidelines and 40 CFR 1503.4 under NEPA.

1.2 List of Commenters and Responses – Draft EIR/EIS

This section provides responses to comments received during the Draft EIR/EIS public review period, which commenced on January 3, 2008 and ended on April 11, 2008. Responses to issues and concerns raised by several commenters are addressed in a set of General Responses (GR-1 through GR-18).
