Replacing a segment of a singlecircuit 138-kV transmission line between the Talega and Capistrano substations with a new double-circuit 230-kV transmission line (7.5 miles), and relocating several transmission and distribution line segments (2 miles, combined) located near the two substations; and 3. Relocating a 12-kV distribution line into new and existing underground conduit and overhead on new structures from the proposed San Juan Capistrano Substation to Prima Deschecha Landfill.
