QAL: Davey Tree DATE: Fall 2017 through Spring 2018, prior to last rains METHOD: Ground

COMMENTS: \* 1 gallon per acre of this pre-blend will provide the above listed rates per acre of each individual product. Clear site of vegetation prior to treatment, if possible. Fill tank half full of water. Add 2.0 gallons of pre-mixed blend to a 50-gallon mix tank, thoroughly mix, and continuously agitate the suspension. Transfer to field tank, if used. Re-agitate between pole sites. Nurse backpack sprayers out of this tank. Apply as a uniform spray to both target weeds and the soil in a 10-foot radius around the subject pole. At 25 gpa spray volume, each pole will require approximately 1.5 pints of spray mixture.

I hereby certify that alternatives and mitigation measures that would substantially lessen any significant adverse impact on the environment have been considered and, if feasible, adopted. Criteria for determining need for treatment: Pest is present.
