

## Chapter 3

# INDIVIDUAL RESPONSES TO COMMENTS

This chapter contains copies of the comment letters<sup>1</sup> received on the Draft Environmental Impact Report (DEIR) and recirculated DEIR for the Estrella Substation and Paso Robles Area Reinforcement Project (Proposed Project), and provides individual written responses to the comments contained in the comment letters. Each letter within this chapter has been assigned a letter code (e.g., A or AA for comment letters received on the original DEIR; R.A for comment letters received on the recirculated DEIR) and individual comments within each letter have been numbered consecutively in the left margin. Brackets are placed adjacent to individual comments to indicate the extent of the comment. Each comment letter is followed by the California Public Utilities Commission’s (CPUC) responses to that letter, which are numbered to correspond with the comments marked on the letter. Where appropriate, responses to individual comments in this chapter refer the reader to the applicable master response(s), which are provided in Chapter 2.

### 3.1 List of Comment Letters

**Table 3-1** presents the list of comment letters received on the original DEIR. The comment letters are organized by type: (1) state agencies or elected representatives; (2) local agencies; (3) additional stakeholder groups; and (4) individuals. No federal agencies submitted comments on the DEIR. **Table 3-2** presents the list of comment letters received during public review of the recirculated DEIR.
