Dear Mr. Jordan:

The California Public Utilities Commission's (CPUC's) Infrastructure Permitting and CEQA section completed its review of TDS Telecom's Proponent's Environmental Assessment (PEA). The CPUC received the PEA on April 30, 2015 and submitted a deficiency letter to TDS on May 28, 2015. TDS responded to the deficiency letter on June 17, 2015.

The CPUC has determined that the PEA is now complete. The CPUC's Information and Criteria List and PEA Checklist and United States Bureau of Indian Affairs (BIA) NEPA Guidebook were used as basic guides for determining PEA adequacy. The CPUC will prepare an Initial Study and Negative Declaration. If mitigation is required, a Mitigated Negative Declaration will be prepared. At this time, the CPUC does not anticipate that preparation of an Environmental Impact Report will be required. Based on discussions with BIA, preparation of an Environmental Assessment is anticipated to be the appropriate level of review for National Environmental Policy Act compliance. Therefore, the CPUC will coordinate with BIA to prepare a joint Initial Study/Environmental Assessment. Scheduling details for a public meeting early in the environmental planning process will follow.
