Chapter 4. Comments and Responses to Comments

This chapter documents the responses to each of the comments received on the draft EIR. Agencies and individuals who submitted comments on the draft EIR are identified in Table 4-1.

The CPUC also received oral public comments on the draft EIR at the City of Lodi public meeting on October 13, 1999, and the Public Participation Hearing before the California Public Utilities Commission afternoon and evening sessions on October 19, 1999. Comments received at those meetings are addressed at the end of the written comments. The CPUC received no formal oral comments on the draft EIR at the public meeting in Isleton on October 14, 1999.
