The California Public Utilities Commission (CPUC) as the Lead Agency under the California Environmental Quality Act (CEQA) has prepared a Draft Subsequent Environmental Impact Report (EIR) for consideration of the Southern California Edison (SCE) application for a Certificate of Public Convenience and Necessity (CPCN) to build and operate components of the Riverside Transmission Reliability Project (RTRP).

Draft Subsequent EIR Availability

The Draft Subsequent EIR will be released for public review on April 2, 2018. Comments on the Draft Subsequent EIR are due on or before May 17, 2018. The Draft Subsequent EIR is available for review at the locations identified in Table 1, and at the CPUC office at 505 Van Ness Avenue, San Francisco, CA 94102. Project Background

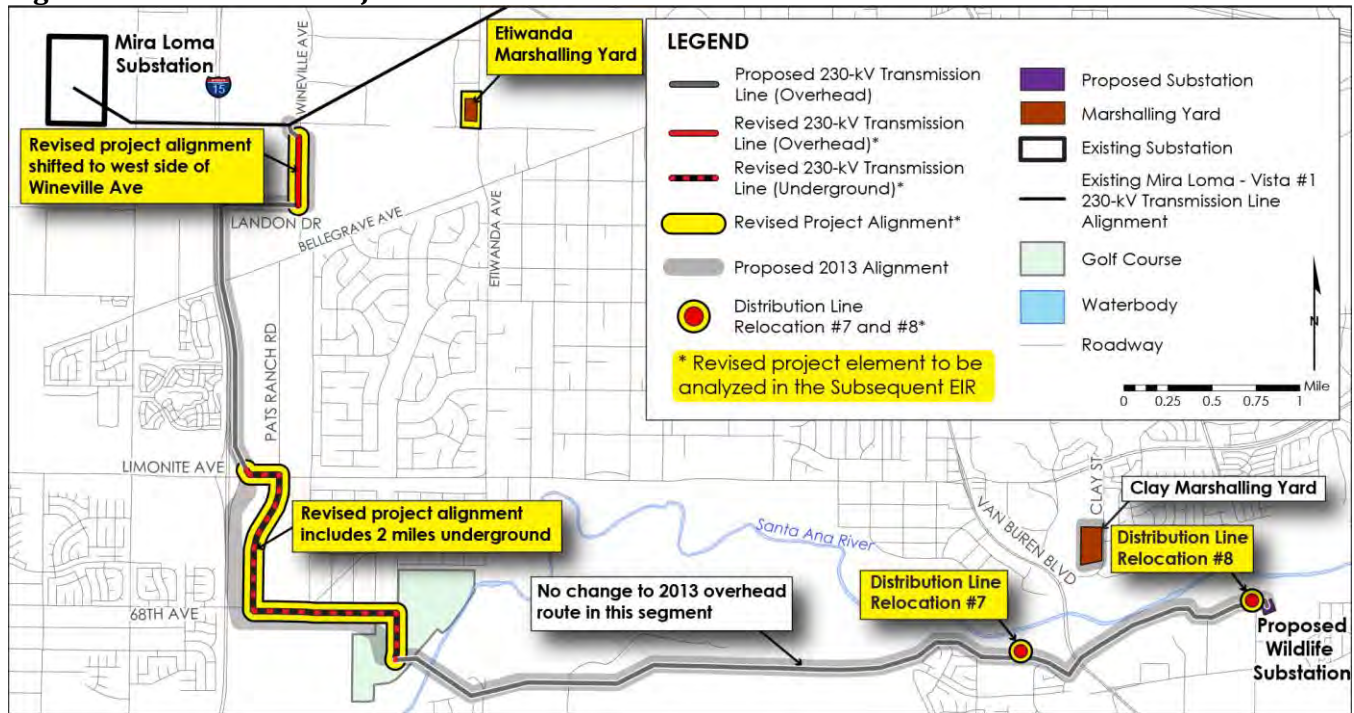
The RTRP was first proposed by Riverside Public Utilities and SCE in 2009. As the CEQA Lead Agency, the City of Riverside prepared an EIR to analyze the environmental impacts from construction, operation, and maintenance of the RTRP. The City of Riverside certified the EIR and approved the project on February 5, 2013. Following certification of the 2013 RTRP EIR, SCE modified segments of the RTRP to avoid conflicts with residential and commercial developments within SCE's proposed transmission line route in the City of Jurupa Valley. This Draft Subsequent EIR analyzes the transmission route revisions and existing distribution line modifications (together referred to as the Revised Project) that were not included in the 2013 RTRP EIR.

Revised Project Location and Description

The Revised Project is located in the cities of Jurupa Valley and Riverside, as well as unincorporated Riverside County, and includes the following major components. These components are shown in Figure 1 below.

- Approximately 0.4 mile of new overhead 230-kV double-circuit transmission line
- Approximately 2 miles of new underground 230-kV double-circuit transmission line
- Relocation of existing distribution line at two locations
- Etiwanda Marshalling Yard

Significant Impacts of the Revised Project

The Draft Subsequent EIR has identified significant and unavoidable impacts to Aesthetic, Agricultural, Noise, and Transportation and Traffic resources that would result from construction, operation, and maintenance of the Revised Project. All other potential impacts to environmental resources were determined to be less than significant or could be reduced to a less than significant level with the implementation of mitigation measures identified in the Draft Subsequent EIR.

Informational Workshops

The CPUC will hold informational workshops to help affected communities understand the Revised Project, its alternatives, the Draft Subsequent EIR, and how to participate in the CPUC decision-making process. The dates and times for these informational workshops are provided in Table 2 below.

Antecedentes del Proyecto

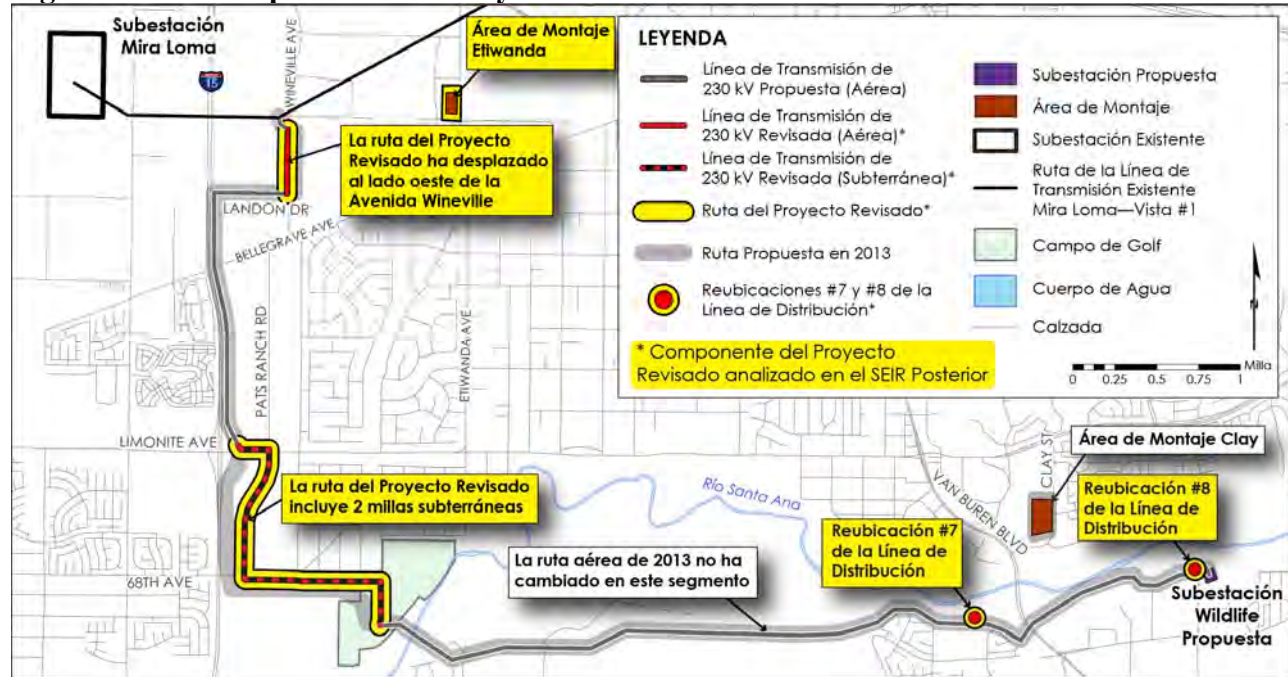
El RTRP fue propuesto por primera vez por los Servicios Públicos de Riverside (RPU) y SCE en 2009. La Ciudad de Riverside era la agencia líder, y preparó un EIR para analizar los impactos ambientales de la construcción, operación, y mantenimiento del RTRP. La Ciudad de Riverside certificó el EIR RTRP 2013 Final, y aprobó el proyecto el 5 de febrero de 2013. Después de la certificación del EIR RTRP 2013, SCE revisó unos segmentos del RTRP para evitar unos desarrollos residenciales y comerciales que entraban en conflicto con la línea de transmisión propuesta de SCE en la Ciudad de Jurupa Valley. Este SEIR Borrador analiza las revisiones de la línea de transmisión y las modificaciones a las líneas de distribución existentes (se denominan colectivamente como el Proyecto Revisado) que no estaban incluidas en el EIR RTRP 2013.

Ubicación y Descripción del Proyecto Revisado

El Proyecto Revisado está ubicado en las Ciudades de Jurupa Valley y Riverside, y también en un área no incorporado del Condado de Riverside. El Proyecto Revisado incluye los siguientes componentes principales. Se muestra estos componentes en la Figura 1.

- Aproximadamente 0.4 milla de línea aérea de transmisión de doble circuito de 230 kV nueva
- Aproximadamente 2 millas de línea subterránea de transmisión de doble circuito de 230 kV nueva
- Reubicación de unas líneas de distribución existentes en dos ubicaciones
- Área de Montaje Etiwanda

Impactos Significativos del Proyecto Revisado

El SEIR Borrador ha identificado unos impactos significativos e inevitables en los recursos de Estéticas, Agricultura, Ruido, y Tráfico y Transportación que resultarían de la construcción, operación, y mantenimiento del Proyecto Revisado. Se determinó que todos los otros impactos potenciales en los recursos ambientales serían en un nivel menos que significativo con la implementación de unas medidas de mitigación identificadas en el SEIR Borrador.

Project Summary. Riverside Public Utilities and SCE proposed to construct and operate the RTRP in 2009. The City of Riverside prepared and certified an EIR in 2013. SCE subsequently modified segments of the RTRP to avoid conflicts with residential and commercial developments in the City of Jurupa Valley. This Draft Subsequent EIR analyzes the revisions to the transmission route and existing distribution line modifications that were not included in the 2013 RTRP EIR. The revised segments include the following:

- Approximately 0.4 mile of new overhead 230-kV double-circuit transmission line
- Approximately 2 miles of new underground 230-kV double-circuit transmission line
- Relocation of existing distribution line at two locations
- Etiwanda Marshalling Yard

Project Location. The RTRP would be located in the western and northern sections of the City of Riverside and extend into the cities of Norco and Jurupa Valley, as well as parts of unincorporated Riverside County. The project area is bordered to the north by State Route 60, to the west by Interstate 15, and to the south and east by State Route 91. The modified segments analyzed in the Draft Subsequent EIR would be located in the cities of Jurupa Valley and Riverside, as well as parts of unincorporated Riverside County.

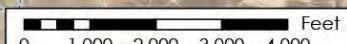

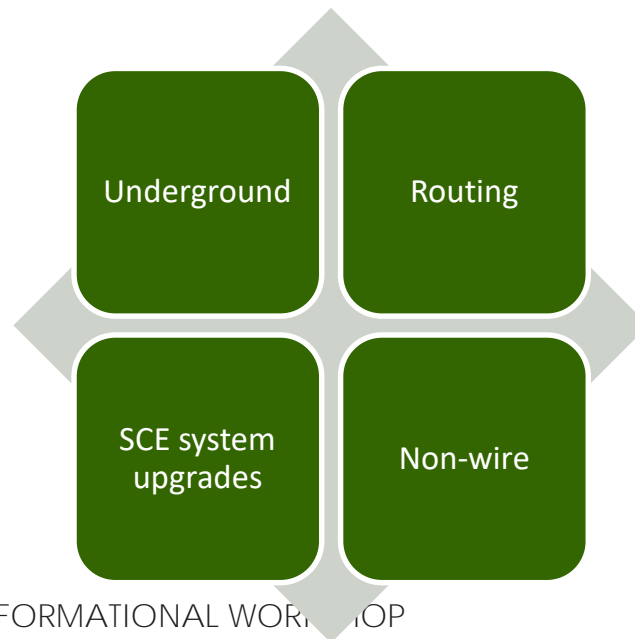
