2	DR#18, Q1h and Q1n	Please provide mapped locations and GIS data for rare plants documented during 2015 rare plant surveys
		The Busby Biological Services memo dated December 7, 2015 states that eight individual thread-leaved brodiaea were mapped during 2015. The CPUC requests the GIS data corresponding with the mapped locality of thread-leaved brodiaea.
		The Chambers Group memo dated September 21, 2015, indicates that five sensitive plant species were observed during the April survey; however, the memo does not include a map or GIS data showing the locations where these species were observed. The CPUC requires this data to define the locations of sensitive plant species.
3	DR#18, Q8	Please identify whether the City of San Diego or Caltrans maintains ownership of Pomerado bridge including the bridge cells over I-15. If City-owned, has SDG&E confirmed the feasibility of using the bridge cell with the City of San Diego?
