INTRODUCTION

This report provides a summary of the construction and compliance activities associated with the SDG&E Sycamore-Peñasquitos 230-kV Transmission Line Project for the week of May 7 to May 12, 2018.

A summary of the Notices to Proceed, Minor Project Refinement, and Temporary Extra Workspace Requests are provided in Tables 1, 2, and 3, respectively. A summary of Noncompliance, Project Memoranda and Incidents is provided in Table 4. Daily Inspection Reports are provided in Appendix A.

STAGING YARDS

Summary of Activity:

Stonebridge Staging Yard:

1. Delivering equipment; inspecting BMPs; and demobilizing equipment.

Driving Range Staging Yard:

1. Delivering equipment; and inspecting BMPs.

Vulcan Staging Yard:

1. Maintaining BMPs; delivering materials and equipment; and delivering, sorting, and removing spoil material from night excavations.

Crestmar Point Staging Area:

1. Delivering materials and equipment; and inspecting BMPs.

Underground Transmission Line:

- 1. Nighttime construction activities: No activity.
- 2. Daytime construction activities occurred west of I-15 in Segment 5 in Section 20 (approximately at Stations 322+00 to 401+00): Installing cable.
- 3. Daytime construction activities occurred east of I-15 in Segment 3 in Sections 12 through 17 (approximately at Stations 614+00 to P05): Installing and splicing cable; mandreling; and working in vaults.

I-15 Crossing

1. Construction activities in Segment 5 (approximately at Station 402+50): Boring and installing pipe in the sending bore pit located at the end of the Kearny Mesa Road cul-de-sac.

Overhead Transmission Line:

- 1. P03: No activity.
- 2. P04: No activity.
- 3. P05: Splicing conductor wire.
- 4. P06: No activity.
- 5. CC MM CP to E39: Installing grounding wire; and QA/QC inspecting.

Peñasquitos Substation:

1. No activity.

Sycamore Substation:

1. Installing racks and miscellaneous hardware.

Environmental Compliance:

- 1. All pavement was kept clean during this reporting period. No winds occurred that were higher than 20 mph. All off-road diesel-powered construction equipment met a minimum of EPA Tier 3 standards or had due diligence documentation provided to CPUC for it.
- 2. The contractor followed the recommendations from the Qualified Acoustician for work occurring in occupied habitat for the coastal California gnatcatcher and/or least Bell's vireo within or adjacent to the Multiple Habitat Planning Area (MHPA). Specifically, idling (including bucket trucks) was prohibited, the use of vehicle radios or any other kind of amplification was prohibited, loud conversation/yelling was discouraged, and work was limited to one active truck in a given work location. Nesting bird surveys were conducted on May 10, 2018, for proposed trenching activities on Pomerado Road, Segment 3, Section 1, between stations 415 and 421. During this reporting period, daily nest monitoring was conducted at two different locations. The two locations consist of a pair of common ravens nesting near the west side sending bore pit (Segment 4, West of I-15), and a kestrel pair nesting in a monopole inside the Sycamore Substation. The kestrel and raven nests were spot-checked throughout the day on a daily basis. Daily monitoring will continue at both nest locations until it is determined that the young have fledged, it

is not an active nest, or construction activities cease at these locations. No other specialstatus species were observed during the monitoring period. All project equipment arrived clean and free of mud and/or vegetation.

- 3. During this reporting period, paleontological monitors were on site for grounddisturbing activities in areas with a moderate to high potential of encountering resources. During both the day and night shifts, paleontological monitors observed boring activities west of the I-15. Cultural and Native American monitors were not on site during this reporting period, as recommended by the CPUC qualified archaeologist, due to grounddisturbing activities being located in areas with a low potential of encountering cultural resources. No cultural or paleontological resources were observed during the monitoring effort this reporting period.
- 4. No hazardous material releases were recorded during this reporting period.
- 5. All construction activities occurred in accordance with the approved Construction Fire Prevention Plan.
- 6. Daytime underground construction activities occurred Monday through Saturday, from 8:00 am to 4:00 pm. Daytime construction activities occurred in accordance with the City of San Diego approved Traffic Control Permits and Noise Permits.
- 7. Project personnel parked their personal vehicles within a designated personal vehicle parking area within the project limits within the Stonebridge Staging Yard. Workers parked within the work limits of the Driving Range Staging Yard or parked on the adjacent public street. Traffic Control Permits were obtained from the City of San Diego.
- 8. The QSP conducted required daily inspections during this reporting period. The QSP conducted a pre-rain inspection on May 11, 2018, for the anticipated rain event on May 11 and May 12, 2018. The rain event did not occur as anticipated. The Environmental Inspectors inspected equipment to ensure that drip pans were being placed under equipment by the contractor. All trash receptacles were covered daily, ingress/egress areas were hand-swept, a street sweeper was used in and around work areas, and regular BMP maintenance and installation was conducted throughout the week.
- 9. All construction and compliance personnel on site during this reporting period completed the Project Safety and Environmental Awareness Program (SEAP). To date, approximately 1,880 project personnel have received the required SEAP training, and 1,776 project personnel have received the UXO training.
- 10. No compliance level incidents were recorded during this reporting period.
- 11. No complaints were received during this reporting period.
- 12. Agency Representatives during Construction (other than CPUC EMs): None
