2.1 INTRODUCTION

This section includes a list of the public agencies, organizations, and private citizens who provided comments on the Draft Subsequent EIR, copies of written comments received on the Draft Subsequent EIR, and responses to those comments. As required by California Environmental Quality Act (CEQA), these responses to comments address significant environmental issues raised by commenters (California Public Resources Code [PRC] 21091[d]; CEQA Guidelines Sections 15088[a], 15132).

2.2 OPPORTUNITIES FOR PUBLIC COMMENT ON THE DRAFT SUBSEQUENT EIR

2.2.1 Public Notices

On April 2, 2018, the CPUC published and distributed the Notice of Availability (NOA) of the Draft Subsequent EIR to inform interested local, regional, and state agencies, and the public that a Draft Subsequent EIR had been prepared and published for the Revised Project. The CPUC mailed 728 copies of the NOA to residents and property owners within 300 feet of the Revised Project and each alternative alignment. The CPUC mailed 426 copies of the NOA to agencies, organizations, tribes, and interested parties. Fifteen copies of the NOA and Draft Subsequent EIR, as well as one copy of the Notice of Completion, were sent to the Sate Clearinghouse for distribution to state agencies. The NOA presented the background, purpose, description, and location of the Revised Project, as well as the contact name and contact methods to request additional information about the Revised Project. The NOA solicited written comments on the Draft Subsequent EIR during a 45-day comment period (April 2, 2018 through May 17, 2018) and provided information on public informational workshops.

In addition to the NOA, the CPUC provided additional notifications to the public about the April 24 and 25, 2018 public informational workshops in order to receive comments on the Draft Subsequent EIR.

The CPUC published a legal advertisement in English in the Press-Enterprise on April 22, 2018, and a legal advertisement in Spanish in the La Prensa on April 20, 2018. Additionally, electronic copies of the NOA and the Draft Subsequent EIR were posted on the CPUC's website at: http://www.cpuc.ca.gov/Environment/info/panoramaenv/RTRP/. English and Spanish copies of the NOA were mailed to local libraries to post on public message boards.

The NOA, newspaper legal advertisements, and the public informational workshop sign-in sheets are provided in Attachment 1. Notifications provided basic project information and the

date, time and location of the public information workshops. The public was encouraged in the NOA, newspaper legal advertisements, and at the public informational workshops to submit written comments and concerns regarding the Revised Project and the adequacy of the Draft Subsequent EIR at the public workshops, by mail, by fax, or email to the CPUC.

2.2.2 Public Informational Workshops

The CPUC held public informational workshops in Jurupa Valley on April 24 and 25, 2018 to accept comments on the Draft Subsequent EIR from agencies, organizations, and individuals. The informational workshop times and location are listed in Table 2.2-1.

Following the presentation, informational stations were available where attendees could ask clarifying questions about the Revised Project. All attendees were encouraged to submit written comments on the Draft Subsequent EIR.

2.3 COMMENTS ON THE DRAFT SUBSEQUENT EIR

The CPUC received 278 comment letters from various state and local agencies, organizations, individual members of the public, and SCE. Twenty-three comment letters were received after the close of the comment period; these comments were accepted and are included in the Final Subsequent EIR. The CPUC has considered all comments and provides responses to all comments in this document.

2.4 LIST OF COMMENTERS

Agency and organization comments included topics such as technical clarifications and corrections, concerns regarding project need, impacts on aesthetics, hazardous materials, project alternatives, and preference for the environmentally superior alternative. Individual comments included concerns about health and safety, impacts on property values, impacts on traffic and emergency access, impacts on aesthetics, support for undergrounding the transmission lines, and rejection of the Proposed Project. SCE comments included technical clarifications and corrections, provision of supplemental data, and minor changes to mitigation measures.
